10	Be it enacted by the General Assembly of Virginia:
11	1. That § 46.2-342 of the Code of Virginia is amended and reenacted as follows:
12	§ 46.2-342. What license to contain; Uniform Donor Document.
13	A. Every license issued under this chapter shall bear:
13	1. A license number which shall be the same as the licensee's social security number, or a control
15	
15 16	number which shall be assigned by the Department to the licensee if he <i>either</i> (i) has no social security
10	number or (ii) requests that his social security number not be used;
	2. A dated color photograph of the licensee;
18	3. The licensee's name, year, month, and date of birth;
19 20	4. The licensee's address;
20	5. A brief description of the licensee for the purpose of identification;
21	6. A space for the signature of the licensee; and
22	7. Any other information deemed necessary by the Commissioner for the administration of this title.
23	No abbreviated names or nicknames shall be shown on any license.
24	A1. At the option of the licensee, the address shown on the license may be either the post office
25	box, business, or residence address of the licensee. However, regardless of which address is shown on
26	the license, the licensee shall supply the Department with his residence address. This residence address
27	shall be maintained in the Department's records. Whenever the licensee's address shown either on his
28	license or in the Department's records changes, he shall notify the Department in writing of such change
29	as required by § 46.2-324.
30	B. The license shall be cardboard or other suitable material or combination thereof and in a form to
31	be determined by the Commissioner.
32	C. Photographs, for licensees under twenty-one years of age at the time of issuance of the license,
33	shall be profile photographs; but photographs for licensees twenty-one years of age or older at the time
34	of issuance of the license shall be front face view photographs. Notwithstanding the preceding provisions
35	of this subsection, the first and subsequent photographs for persons under twenty-one years of age shall
36	be profile photographs until the original issued license has expired.
37	D. The Department shall establish a method by which an applicant for a driver's license or an
38	identification card may designate his willingness to be an organ donor as provided in Article 2
39 40	(§ 32.1-289 et seq.) of Chapter 8 of Title 32.1 and shall cooperate with the Virginia Transplant Council
40	to ensure that such method is designed to encourage organ donation with a minimum of effort on the
41	part of the donor and the Department.
42	E. If an applicant designates his willingness to be a donor pursuant to subsection D, the Department
43	may make a notation of this designation on his license or card and shall make a notation of this
44 45	designation in his driver record.
45	F. The donor designation authorized in subsection E shall be sufficient legal authority for the
46 47	removal, following death, of the subject's organs or tissues without additional authority from the donor, or his family or acteta
4 7 48	or his family or estate. G. The donor designation provided pursuant to subsection D may only be rescinded by appearing in
40 49	person at a Department branch office. The Department shall notify the prospective donor of this
50	requirement at the time he authorizes donor designation.
51 52	H. With the written consent of his parent or legal guardian, a minor may make a donor designation.
	I. When requested by the applicant, and upon presentation of a signed statement by a licensed
53 54	physician confirming the applicant's condition, the Department shall indicate on the applicant's driver's license that the applicant is an insulin dependent diabatic

55 56	J. In the absence of gross negligence or willful misconduct, the Department and its employees shall be immune from any givil or ariminal liability in connection with the making of or failure to make a

58 59	K. Notwithstanding the foregoing provisions of this section, the Department shall continue to use the uniform department as formerly set forth in subsection D above for organ department designation
