2 An Act to amend and reenact §§ 6.1-63, 6.1-65.1 and 6.1-66 of the Code of Virginia, relating to bank loans secured by real estate.

Approved Be it enacted by the General Assembly of Virginia:

6 Be it enacted by the General Assembly of Virginia: 7 1. That §§ 6.1-63, 6.1-65.1 and 6.1-66 of the Code of Virginia are amended and reenacted as follows:

9 § 6.1-63. Limitation on amount of loans secured by real estate generally; loans providing for lesser10 payments during early periods of maturity.

A. No bank shall make any loan secured by real estate when such loan together with all prior liens 11 and encumbrances on such real estate exceeds fifty percent of the appraised value of the real estate 12 13 securing such loan, unless such loan is (a) (i) amortized by regular periodic payments of principal and interest, in equal or unequal amounts, due at least as regularly as annually in amounts which would pay 14 15 the loan in full over a period of forty years and two months or less, or (b) (ii) amortized by payments of principal due at least as regularly as annually, which are not less than three and one-half percent 16 annually of the original principal of the loan and in either of such events, the amount of the loan, 17 18 together with all prior liens or encumbrances on such real estate shall not exceed ninety percent of the 19 appraised value of the real estate securing such loan.

B. The Commissioner of Financial Institutions may authorize, upon such terms and conditions
 deemed appropriate by him, investment in loans secured by real estate, providing for lesser payments
 during the early periods of maturity of such loans.

C. No bank shall make such loans in an aggregate sum in excess of the amount of its capital and its
 surplus or in excess of seventy percent of its time and savings deposits, whichever is greater.

D.C. The appraisals necessitated by this section shall be required if the loan shall equal or exceed an amount established from time to time by the Commissioner of Financial Institutions who, in establishing such amount, shall take into consideration the requirements imposed on banks under applicable federal regulations. Such appraisals shall be in writing, signed by the appraisers, and shall be retained in the files of the bank, subject to examination of bank examiners. The appraisers so appointed shall be experienced persons competent to appraise real estate in the locality where the real estate is located.

E-D. Any bank may make loans secured by real estate that do not comply with the limitations and restrictions in this section if the total unpaid amount of the loan, exclusive of the loans which subsequently comply with such limitations and restrictions, does not exceed ten percent of the *total* amount that a bank may invest in of loans secured by real estate loans under subsection C of this section. The total unpaid amount so loaned shall be included in the aggregate sum that such bank may invest in real estate loans.

37 F.E. The provisions of this section relating to ratio of loan to appraised value, amortization, and appraisal shall not relate to the case where:

39 1. The real estate security is taken solely as an abundance of caution on terms which are not more favorable than they would be in absence of such a lien on real estate;

41 2. A real estate security conveyance is taken by or ancillary to the assignment of lease obligations42 upon which the bank is relying primarily and prudently;

3. A subsequent transaction results from an existing extension of credit providing (i) that the
borrower has performed satisfactorily, (ii) there is no advance of new money, except as formerly agreed,
(iii) the credit standing of the borrower is not deteriorating, and (iv) there is no obvious and noticeable
deterioration of marketing conditions or the physical assets which provide collateral security to the bank;
or

48 4. A lien upon real estate is taken to secure a prior advance which was not secured by such real estate.

50 G-F. In cases where an appraisal by a state-certified or state-licensed appraiser is not required, under 51 this or other sections of this chapter in a real estate-related financial transaction, the bank as a matter of 52 prudence may take and preserve a reasonable appraisal, valuation or analysis of real estate or real 53 property in connection with such transaction.

54 H.G. The State Corporation Commission may by order or regulation eliminate loans or specific categories of loans from the requirements of this section.

56 § 6.1-65.1. Investment in reverse annuity mortgages.

57 A bank may invest in reverse annuity mortgages to the extent and in the manner that may be

58 provided in regulations adopted by the Commission. Such loans shall be included in the aggregate 59 amount of loans secured by real estate permitted by § 6.1-63.

60 § 6.1-66. Certain loans for home improvement purposes not considered loans secured by real estate.

61 Loans made to home owners for maintenance, repair, landscaping, modernization, alteration,

62 improvement, furnishings and equipment to their homes, whether or not secured, shall not be considered63 as loans secured by real estate within the meaning of § 6.1-63, provided each such loan shall be payable

64 in approximately equal monthly installments, shall not be for a term longer than twelve years, and shall

65 not exceed an amount specified in accordance with subsection D C of § 6.1-63. Such home loans may

66 otherwise be made under the provisions of §§ 6.1-63, 6.1-64 or § 6.1-65. If such loan is in excess of the

67 amount specified under subsection D C of § 6.1-63, unless the taking of real estate security is solely in

the abundance of caution and the terms are not more favorable than in the absence of such a real estate

69 lien, an appraisal as required by §§ 6.1-63, 6.1-64 or § 6.1-65 shall be required by the bank.
