

# VIRGINIA ACTS OF ASSEMBLY -- 1995 SESSION

## CHAPTER 853

*An Act to amend and reenact Chapter 966 of the Acts of Assembly of 1994, which appropriated the public revenue for the two years ending, respectively, on the thirtieth day of June, 1995, and the thirtieth day of June, 1996, and to repeal Chapters 4, 8 and 9 of the Acts of Assembly of 1994, Special Session I, and Chapter 9 of the Acts of Assembly of 1994, Special Session II.*

Be it enacted by the General Assembly of Virginia:
