10 11	Be it enacted by the General Assembly of Virginia:
12	1. That § 10.1-2212 of the Code of Virginia is amended and reenacted as follows:
13	§ 10.1-2212. Listing of certain historical societies receiving appropriations.
14	A. At the direction of the Director, the Comptroller of the Commonwealth is instructed and
15	empowered to draw annual warrants upon the State Treasurer, as provided in the general appropriations
16	act, in favor of the treasurers of certain historical societies, museums, foundations, and associations for
17 18	use in caring for and maintaining collections, exhibits, sites, and facilities owned by such historical organizations, specified as follows:
10 19	1. Virginia Historical Society. For aid in maintaining Battle Abbey at Richmond.
20	2. Confederate Museum at Richmond. For the care of Confederate collections and maintenance of the
21	Virginia Room.
22	3. Valentine Museum at Richmond. For providing exhibits to the public schools of Virginia.
23	4. Woodrow Wilson Birthplace Foundation, Incorporated. To aid in restoring and maintaining the Woodrow Wilson home at Staunton.
24 25	5. Robert E. Lee Memorial Association, Incorporated. To aid in further development of "Stratford" in
2 6	Westmoreland County.
27	6. Poe Foundation, Incorporated. To aid in maintaining the Poe Shrine at Richmond.
28	7. Patrick Henry Memorial Foundation at Brookneal. To aid in maintaining home.
29	8. Hanover County Branch, Association for the Preservation of Virginia Antiquities. To aid in
30 31	maintaining the Patrick Henry home at "Scotchtown" in Hanover County.9. Historic Lexington Foundation. To aid in restoration and maintenance of the Stonewall Jackson
32	home at Lexington.
33	10. "Oatlands," Incorporated. To aid in maintaining "Oatlands" in Loudoun County.
34	11. Montgomery County Branch, Association for the Preservation of Virginia Antiquities. To aid in
35	maintaining Smithfield Plantation House.
36 37	12. The Last Capitol of the Confederacy. For the preservation of the Last Capitol of the Confederacy in Danville.
37 38	13. Association for the Preservation of Virginia Antiquities. For assistance in maintaining certain
39	historic landmarks throughout the Commonwealth.
40	14. The Corporation for Jefferson's "Poplar Forest." To aid in restoring, maintaining, and operating
41	"Poplar Forest," Thomas Jefferson's Bedford County home.
42	15. Belle Grove, Incorporated. To aid in providing educational programs for Virginia students.
43 44	16. George Washington Boyhood Home Foundation. To aid in the restoration and perpetuation of "Ferry Farm," George Washington's boyhood home.
45	17. Montpelier National Trust for Historic Preservation. To aid in restoring, maintaining, and
46	operating Montpelier, the lifelong home of President James Madison, in Orange County.
47	18. Eastern Shore of Virginia Historical Society. To aid in restoring, maintaining and operating Kerr
48	Place in Accomack County.
49 50	19. New Town Improvement and Civic Club, Inc. To aid in restoring, maintaining and operating
50 51	Little England Chapel, a landmark to Hampton's first generation of freedmen, in the City of Hampton. 20. Woodlawn Plantation. To aid in the preservation and maintenance of Woodlawn Plantation.
52	21. Friends of Historic Huntley. To support the research and preservation of Historic Huntley
53	Mansion.
54	B. Organizations receiving state funds as provided for in this section shall certify to the satisfaction
55	of the Department that matching funds from local or private sources are available in an amount at least
56 57	equal to the amount of the request in cash or in kind contributions which are deemed acceptable to the Department.
57 58	C. Requests for funding of historical societies or like organizations as set forth in subsection A, shall
59	be considered by the Governor and the General Assembly only in even-numbered years.
