HOUSE BILL NO. 1754

Offered January 18, 1995

A BILL to amend and reenact § 59.1-392 of the Code of Virginia, relating to the Virginia Racing *Commission; percentage retained on pari-mutuel wagering pools.*

Patron—Guest

Referred to Committee on General Laws

Be it enacted by the General Assembly of Virginia:

1. That § 59.1-392 of the Code of Virginia is amended and reenacted as follows: 11

§ 59.1-392. Percentage retained; tax.

A. Any person holding an operator's license pursuant to this chapter shall be authorized to conduct 13 14 pari-mutuel wagering on horse racing subject to the provisions of this chapter and the conditions and regulations of the Commission. 15

16 B. On pari-mutuel pools generated by wagering on live horse racing conducted within the Commonwealth, involving win, place and show wagering, the licensee shall retain an amount not to 17 exceed eighteen percent of the pool, and the legitimate breakage, out of which shall be paid: 18

1. a. If there are no satellite facilities, one and one-half percent of the pool to the Commonwealth as 19 20 a license tax which shall be paid within five days to the Commonwealth;

b. If there are satellite facilities, one percent of the pool to the Commonwealth as a license tax which 21 22 shall be paid within five days to the Commonwealth, and one-quarter percent of the pool shall be paid 23 to the locality in which the satellite facility is located and one-quarter percent to the locality in which the track is located which shall be paid within five days to the locality. If any satellite facility is located 24 25 in more than one locality, the license tax shall be prorated in equal shares among those localities; 26

2. Eight percent of the pool as purses or prizes to the participants in such race meeting;

3. Seven and one-half percent of the pool, the breakage and the proceeds of pari-mutuel tickets 27 28 unredeemed 180 days from the date on which the race was conducted, to the operator; and 29

4. One percent of the pool to the Virginia Breeders Fund which shall be paid to the Commission 30 within five days and shall be used in support of the policy of the Commonwealth to sustain and promote 31 the growth of a native industry.

32 C. On pari-mutuel pools generated by wagering on live horse racing conducted within the 33 Commonwealth involving wagering other than that set forth in subsection B of this section, the licensee 34 shall retain an amount not to exceed twenty-two percent of the pool and the legitimate breakage, out of 35 which shall be paid:

36 1. a. If there are no satellite facilities, three percent of the pool to the Commonwealth as a license 37 tax which shall be paid within five days to the Commonwealth;

38 b. If there are satellite facilities, two percent of the pool to the Commonwealth as a license tax which 39 shall be paid within five days to the Commonwealth, and one-half percent of the pool shall be paid to 40 the locality in which the satellite facility is located and one-half percent to the locality in which the track is located which shall be paid within five days to the locality. If any satellite facility is located in 41 42 more than one locality, the license tax shall be prorated in equal shares among those localities; 43

2. Nine percent of the pool as purses or prizes to the participants in such race meeting;

44 3. Nine percent of the pool, the breakage and the proceeds of the pari-mutuel tickets unredeemed 180 days from the date on which the race was conducted, to the operator; and 45

4. One percent of the pool to the Virginia Breeders Fund which shall be paid to the Commission 46 within five days and shall be used in support of the policy of the Commonwealth to sustain and promote 47 **48** the growth of a native industry.

49 D. On pari-mutuel wagering generated by simulcast horse racing transmitted from jurisdictions 50 outside the Commonwealth, with the approval of the Commission the licensee may commingle pools 51 with the racetrack where the transmission emanates or establish separate pools for wagering within the Commonwealth. All simulcast horse racing in this subsection must comply with the Interstate Horse 52 53 Racing Act of 1978 (15 U.S.C. § 3001 et seq.).

54 E. On pari-mutuel pools generated by wagering on simulcast horse racing transmitted from 55 jurisdictions outside the Commonwealth, involving win, place and show wagering, the licensee shall 56 retain:

57 1. a. If there are no satellite facilities, one and one-half percent of the pool to the Commonwealth as a license tax which shall be paid within five days to the Commonwealth; 58

b. If there are satellite facilities, one percent of the pool to the Commonwealth as a license tax which 59

shall be paid within five days to the Commonwealth, and one-quarter percent of the pool to the locality
in which the satellite facility is located and one-quarter percent to the *Virginia* locality in which the
track is located which shall be paid within five days to the locality. If the satellite facility is located in
more than one locality, the license tax shall be prorated in equal shares among those localities; and

64 2. One percent of the pool to the Virginia Breeders Fund which shall be paid to the Commission
65 within five days and shall be used in support of the policy of the Commonwealth to sustain and promote
66 the growth of a native industry.

67 Any contractual agreement between a licensee and other entities concerning the distribution of the remaining portion of the retainage is subject to the approval of the Commission.

F. On pari-mutuel pools generated by simulcast horse racing transmitted from jurisdictions outside
 the Commonwealth, involving wagering other than that set forth in subsection E, the licensee shall
 retain:

1. a. If there are no satellite facilities, three percent of the pool to the Commonwealth as a licensetax which shall be paid within five days to the Commonwealth;

b. If there are satellite facilities, two percent of the pool to the Commonwealth as a license tax which 74 75 shall be paid within five days to the Commonwealth, and one-half percent of the pool to the locality in which the satellite facility is located and one-half percent to the Virginia locality in which the track is 76 located which shall be paid within five days to the locality. If the satellite facility is located in more 77 78 than one locality, the license tax shall be prorated in equal shares among the localities; and 2. One 79 percent of the pool to the Virginia Breeders Fund which shall be paid to the Commission within five 80 days and shall be used in support of the policy of the Commonwealth to sustain and promote the growth 81 of a native industry.

Any contractual agreement between a licensee and other entities concerning the distribution of the remaining portion of the retainage is subject to the approval of the Commission.

G. Moneys payable to the Commonwealth shall be deposited in the general fund. Gross receipts for
license tax purposes under Chapter 37 of Title 58.1 shall not include pari-mutuel wagering pools and
license taxes authorized by this section.
