2 *An Act to amend and reenact § 4.1-227 of the Code of Virginia, relating to alcoholic beverage control;*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 4.1-227 of the Code of Virginia is amended and reenacted as follows:**

8 § 4.1-227. Suspension or revocation of licenses; notice and hearings; imposition of penalties.

9 A. Except for temporary licenses, before the Board may impose a civil penalty against a brewery  
10 licensee or suspend or revoke any license, reasonable notice of such proposed or contemplated action  
11 shall be given to the licensee in accordance with the provisions of § 9-6.14:12 of the Administrative  
12 Process Act.

13 The action of the Board in suspending or revoking any license or in imposing a civil penalty against  
14 the holder of a brewery license shall be subject to judicial review in accordance with the Administrative  
15 Process Act (§ 9-6.14:1 et seq.). Such review shall extend to the entire evidential record of the  
16 proceedings provided by the Board in accordance with the Administrative Process Act. An appeal shall  
17 lie to the Court of Appeals from any order of the court. Notwithstanding § 8.01-676.1, the final  
18 judgment or order of the circuit court shall not be suspended, stayed or modified by such circuit court  
19 pending appeal to the Court of Appeals. Neither mandamus nor injunction shall lie in any such case.

20 B. In suspending any license the Board may impose, as a condition precedent to the removal of such  
21 suspension or any portion thereof, a requirement that the licensee pay the cost incurred by the Board in  
22 investigating the licensee and in holding the proceeding resulting in such suspension, or it may impose a  
23 civil penalty not to exceed \$1,000 for the first violation, \$2,500 for the second violation and \$5,000 for  
24 the third violation in lieu of such suspension or any portion thereof, or both.

25 C. Following notice to the licensee of a hearing which may result in the suspension or revocation of  
26 his license, the Board may accept from the licensee an offer in compromise to pay a civil charge not  
27 exceeding \$5,000, either in lieu of suspension or in addition thereto, or in lieu of revocation.

28 D. In case of an offense by the holder of a brewery license, the Board may require that such holder  
29 pay the costs incurred by the Board in investigating the licensee, and it may impose a civil penalty not  
30 to exceed \$25,000 for the first violation, \$50,000 for the second violation, and for the third or any  
31 subsequent violation, suspend or revoke such license or, in lieu of any suspension or portion thereof,  
32 impose a civil penalty not to exceed \$100,000. Such suspension or revocation shall not prohibit the  
33 licensee from manufacturing or selling beer manufactured by it to the owners of boats registered under  
34 the laws of the United States sailing for ports of call of a foreign country or another state, and to  
35 persons outside the Commonwealth.

36 E. The Board shall, by regulation, designate the violations for which a waiver of a hearing and  
37 payment of a civil charge in lieu of suspension may be accepted for a first offense occurring within  
38 three years immediately preceding the date of the violation. The Board shall establish a schedule of  
39 penalties for such offenses, prescribing the appropriate suspension of a license and the civil charge  
40 acceptable in lieu of such suspension. A licensee receiving notice of a hearing on an alleged violation  
41 meeting the requirements of this subsection, shall be advised of the option of (i) accepting the  
42 suspension authorized by the Board's schedule, (ii) paying a civil charge authorized by the Board's  
43 schedule in lieu of suspension, or (iii) proceeding to a hearing.
