6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 2.1-124 of the Code of Virginia is amended and reenacted as follows:**

8 § 2.1-124. Criminal cases.

9 A. Unless specifically requested by the Governor to do so, the Attorney General shall have no
10 authority to institute or conduct criminal prosecutions in the circuit courts of the Commonwealth except
11 in cases involving violations of the Alcoholic Beverage Control Act (§ 4.1-100 et seq.), violation of laws
12 relating to elections and the electoral process as provided in § 24.1-21, laws relating to motor vehicles
13 and their operation, the handling of funds by a state bureau, institution, commission or department, the
14 theft of state property, and cases involving the practice of law without being duly authorized or licensed
15 or the illegal practice of law, in which cases the Attorney General may leave the prosecution to the local
16 attorney for the Commonwealth, or he may, in his discretion, institute proceedings by information,
17 presentment or indictment, as the one or the other may be appropriate, and conduct the same. In all
18 other criminal cases in the circuit courts, except where the law provides otherwise, the authority of the
19 Attorney General to appear or participate in the proceedings shall not attach unless and until a petition
20 for appeal has been granted by the Court of Appeals or a writ of error has been granted by the Supreme
21 Court. In all criminal cases before the Court of Appeals or the Supreme Court in which the
22 Commonwealth is a party or is directly interested, the Attorney General shall appear and represent the
23 Commonwealth. In any criminal case in which a petition for appeal has been granted by the Court of
24 Appeals, the Attorney General shall continue to represent the Commonwealth in any further appeal of a
25 case from the Court of Appeals to the Supreme Court.

26 B. The Attorney General shall, upon request of a person who was the victim of a crime and subject
27 to such reasonable procedures as the Attorney General may require, ensure that such person is given
28 notice of the filing and disposition of any appeal or habeas corpus proceeding involving the case or
29 cases in which such person was a victim. For the purposes of this section, a victim is an individual who
30 has suffered physical, psychological or economic harm as a direct result of the commission of a crime;
31 a spouse, child, parent or legal guardian of a minor, incapacitated or incompetent victim; or a spouse,
32 child, parent or legal guardian of a victim of a homicide. Nothing in this subsection shall confer upon
33 any person a right to appeal or modify any decision in a criminal, appellate or habeas corpus
34 proceeding; abridge any right guaranteed by law; or create any cause of action for damages against the
35 Commonwealth or any of its political subdivisions, the Attorney General or any of his employees or
36 agents, any other officer, employee or agent of the Commonwealth or any of its political subdivisions,
37 or any officer of the court.
