2 *An Act to amend and reenact § 18.2-371.2 of the Code of Virginia, relating to purchase or possession*  
3 *of tobacco products by minors; civil penalty.*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 18.2-371.2 of the Code of Virginia is amended and reenacted as follows:**8 § 18.2-371.2. Prohibiting purchase or possession of tobacco products by minors or sale of tobacco  
9 products to minors.

10 A. No person shall sell to, distribute to ~~or~~ , purchase for *or knowingly permit the purchase* by any  
11 person less than eighteen years of age, knowing or having reason to believe that such person is less than  
12 eighteen years of age, any tobacco product, including but not limited to cigarettes and cigars. ~~However,~~  
13 ~~the provisions of this subsection shall not apply to the sale of~~ *Where any tobacco product is sold from a*  
14 *vending machine provided notice is* ~~shall also be~~ posted on the machine in a conspicuous manner and  
15 place indicating that the purchase or possession of tobacco products by minors is unlawful.

16 B. No person less than eighteen years of age shall purchase or possess any tobacco product including  
17 but not limited to cigarettes and cigars. The provisions of this subsection shall not be applicable to the  
18 possession of tobacco products by a person less than eighteen years of age making a delivery of tobacco  
19 products in pursuance of his employment.

20 C. A violation of subsection A or B by an individual or by a separate retail establishment shall be  
21 punishable by a civil penalty not to exceed ~~\$50~~ *fifty dollars* for a first violation and a civil penalty ~~of~~  
22 *not to exceed* \$100 for a ~~second any subsequent~~ violation. *However, a third or subsequent violation of*  
23 *subsection A shall be punishable by a civil penalty not to exceed \$250. A third or subsequent violation*  
24 *of subsection B shall be punishable by a civil penalty not to exceed \$100.* Any attorney for the  
25 Commonwealth of the county or city in which an alleged violation occurred may bring an action to  
26 recover the civil penalty, which shall be paid into the state treasury. Any law-enforcement officer may  
27 issue a summons for a violation of subsection A or B.

28 D. *Cigarettes shall be sold only in sealed packages provided by the manufacturer, with the required*  
29 *health warning.* The proprietor of every retail establishment which offers for sale any tobacco product,  
30 including but not limited to cigarettes and cigars, shall post in a conspicuous manner and place a sign or  
31 signs indicating that the sale of tobacco products to any person under eighteen years of age is prohibited  
32 by law. Any attorney for the county, city or town in which an alleged violation of this subsection  
33 occurred may enforce this subsection by civil action to recover a civil penalty not to exceed ~~\$50~~ *fifty*  
34 *dollars.* The civil penalty shall be paid into the local treasury. No filing fee or other fee or cost shall be  
35 charged to the county, city or town which instituted the action.

36 E. Nothing in this section shall be construed to create a private cause of action.
