LD5863812 **SENATE BILL NO. 1074** 1 234567 FLOOR AMENDMENT IN THE NATURE OF A SUBSTITUTE (Proposed by Senator Stolle on January 31, 1995) (Patron Prior to Substitute—Senator Saslaw) A BILL to amend and reenact § 22.1-207.1 of the Code of Virginia, relating to family life education and guidance counseling. 8 Be it enacted by the General Assembly of Virginia: 9 1. That § 22.1-207.1 of the Code of Virginia is amended and reenacted as follows: 10 § 22.1-207.1. Family life education. A. The Board of Education shall develop by December 1, 1987, standards of learning and curriculum 11 12 guidelines for a comprehensive, sequential family life education curriculum in grades K through 12. Such curriculum guidelines shall include instruction as appropriate for the age of the student in family 13 living and community relationships, the value of postponing sexual activity, human sexuality, human 14 reproduction, and the etiology, prevention and effects of sexually transmitted diseases. All such 15 16 instruction shall be designed to promote parental involvement, foster positive self concepts and provide 17 mechanisms for coping with peer pressure and the stresses of modern living according to the students' 18 developmental stages and abilities. The Board shall also establish by December 1, 1987, requirements 19 for appropriate training for teachers of family life education. 20 By December 1, 1987, the Board of Education shall provide the House Committee on Appropriations 21 and the Senate Committee on Finance an analysis of the state and local fiscal impact of implementing a 22 mandatory statewide family life education program and a recommended apportionment of state and local 23 funding for such programs if not otherwise determined by law. 24 B. A local school board may, at its option, implement a family life education program and 25 procedures for participation in any family life education program and may adopt, in whole or in part, 26 the Board's standards of learning and curriculum guidelines or, upon obtaining public comment from 27 the community, adopt locally developed objectives and curricula. 28 C. Every school board shall inform the parents of the procedures for participation in guidance 29 counseling programs as follows: 30 1. All parents shall be informed that participation in academic guidance counseling programs and 31 career education guidance counseling is required of all students. 32 2. All parents shall be informed that, if they object to all or any part of group guidance counseling 33 instruction that is not academic or career education guidance counseling, they may return, within a 34 reasonable time designated by the school board, a written note, requiring that their child be excused 35 from all or part of the group guidance counseling program and that the child be given other instruction. 36 3. All parents shall be informed that, except for an initial contact on an issue, their permission will 37 be required for participation in individual or small-group structured counseling of a personal nature. 38 D. Other grade-level-appropriate instruction shall be provided to students not participating in the 39 programs in accordance with B or C above. Parents may reverse participation decisions by providing 40 written notification of the new decision to the principal. E. For the purposes of this section, "parent" means the biological parent or adoptive parent, 41 42 guardian or other person having control or charge of a child.
