3 *charter for the City of Franklin, relating to city boundaries.*

6 **Be it enacted by the General Assembly of Virginia:**

7 **1. That § 1.02 of Chapter 155 of the Acts of Assembly of 1962 is amended and reenacted as**
8 **follows:**

9 § 1.02. Boundaries.

10 The boundaries of the city shall be the boundaries of the Town of Franklin, its predecessor, as
11 described in Chapter 123 of the Acts of the General Assembly of 1875-1876, approved March 15, 1876,
12 as modified and enlarged by the decree of the Circuit Court of Southampton County entered on May 25,
13 1906, in the annexation proceedings styled Town of Franklin v. County of Southampton, Virginia, which
14 decree is recorded in the Clerk's Office of the Circuit Court of Southampton County, Virginia, in
15 Common Law Order Book 8 at pages 359, et seq., and as further modified and enlarged by the decree
16 of the Circuit Court of Southampton County entered on March 5, 1925, in the annexation proceedings
17 styled Town of Franklin v. County of Southampton which decree is recorded in the Clerk's Office of the
18 Circuit Court of Southampton County, Virginia, in Common Law Order Book 12 at pages 129, et seq.,
19 and as further modified and contracted by the decree of the Circuit Court of Southampton County
20 entered on May 27, 1932, in the proceedings styled Town of Franklin v. County of Southampton, which
21 decree is recorded in the Clerk's Office of the Circuit Court of Southampton County, Virginia, in
22 Common Law Order Book 13 at pages 443, et seq., and as further modified and enlarged by the decree
23 of the Circuit Court of Southampton County entered on May 26, 1949, in the annexation proceedings
24 styled Town of Franklin v. County of Southampton, which decree is recorded in the Clerk's Office of
25 the Circuit Court of Southampton County, Virginia, in Common Law Order Book 16 at pages 194, et
26 seq., and as further modified and enlarged by the decree of the Circuit Court of Southampton County
27 entered on November 13, 1959, in the annexation proceedings styled Town of Franklin v. County of
28 Southampton, which decree is recorded in the Clerk's Office of the Circuit Court of Southampton
29 County, Virginia, in Common Law Order Book 19 at pages 264, et seq., so as to coincide with the
30 outside boundaries of the City of Franklin existing immediately preceding the effective date of this
31 charter and as further modified and enlarged by the decree of the Circuit Court of Southampton County,
32 entered on December 20, 1985, in the Voluntary Settlement Proceeding styled in the matter of the
33 petition by the City of Franklin, Virginia, and the County of Southampton, Virginia, for an Order
34 affirming and validating a voluntary settlement and establishing the rights of the local governments,
35 pursuant to Chapter 26.1:1 of Title 15.1 of the Code of Virginia which decree is recorded in the clerk's
36 Office of the Circuit Court of Southampton County in Chancery Order Book 27 at page 14 et seq.

37 **2. That an emergency exists and this act is in force from its passage.**
