**1. That §§ 2.1-1.1, 2.1-1.6, 2.1-51.18, 9-6.25:2, 66-1, and 66-4 of the Code of Virginia are amended and reenacted as follows:**

336 § 66-1. Creation of Department of Juvenile Justice.

337 There is hereby created within the executive branch, responsible to the Governor, a Department of  
 338 ~~Youth and Family Services~~ *Juvenile Justice*. The Department shall be under the immediate supervision  
 339 of a Director who shall be appointed by the Governor, subject to confirmation by the General Assembly.  
 340 The Director shall serve at the pleasure of the Governor or until his successor shall be appointed and  
 341 qualified. Vacancies shall be filled in the same manner as original appointments. ~~Wherever the words~~  
 342 ~~"Department of Youth Services," "Director of the Department of Youth Services," and "State Board of~~  
 343 ~~Youth Services" appear in this title and in the Code of Virginia, the Acts of Assembly, or other laws of~~  
 344 ~~the Commonwealth, they shall mean "Department of Youth and Family Services," "Director of the~~  
 345 ~~Department of Youth and Family Services," and "State Board of Youth and Family Services,"~~  
 346 ~~respectively.~~

347 § 66-4. State Board of Juvenile Justice.

348 There shall be a State Board of ~~Youth and Family Services~~ *Juvenile Justice*, consisting of seven  
 349 members appointed by the Governor. In making appointments the Governor shall endeavor to select  
 350 appointees of such qualifications and experience that the membership of the Board shall include persons  
 351 suitably qualified to consider and act upon the various problems which may come before the Board. The  
 352 appointments shall be subject to confirmation by the General Assembly if in session and, if not, then at  
 353 its next succeeding session.

354 2. That wherever the words "Department of Youth and Family Services", "Director of the  
 355 Department of Youth and Family Services," and "State Board of Youth and Family Services"  
 356 appear in this title and in the Code of Virginia, the Acts of Assembly, or other laws of the  
 357 Commonwealth, they shall mean "Department of Juvenile Justice," "Director of the Department  
 358 of Juvenile Justice," and "State Board of Juvenile Justice," respectively.
