12	Be it enacted by the General Assembly of Virginia:
13	1. That the Code of Virginia by adding in Article 4 of Chapter 4 of Title 18.2 sections numbered
14	18.2-57.3 and 18.2-57.4 as follows:
15	§ 18.2-57.3. Assault and battery against school personnel.
16	Any person who commits assault or assault and battery against another, knowing or having reason
17	to know that such other person is a full- or part-time employee or volunteer of any public or private
18 19	elementary, secondary or post-secondary school engaged in the performance of his duties as such, shall be guilty of a Class 1 misdemeanor and, upon conviction, be sentenced to a minimum, mandatory term
20	of confinement of ten days, which shall not be suspended, in whole or in part. However, if the offense is
20 21	committed by use of any firearm, the minimum, mandatory term of confinement shall be six months.
22	Upon conviction, the court shall also order that the defendant make full restitution to the victim.
23	Nothing in this section shall be construed to affect the right of any person charged with a violation
24	of this section from asserting and presenting evidence in support of any defenses to the charge that may
25	be available under common law.
26	§ 18.2-57.4. Assaults and battery by juveniles in certain facilities and those on probation and parole.
27	Any person confined in accordance with § 16.1-249 or in any other facility operated by or under
28	contract with the Department of Youth and Family Services, or while in the custody of any employee of
29	such facility or any probationer, parolee or person under court supervision, who commits an assault or
30	assault and battery on (i) any person who is an employee of, volunteer at or otherwise lawfully admitted
31	to the facility, except another person confined in the facility, (ii) any person who is supervising or
32	working with the confined person or (iii) a probation officer or staff of a court services unit or other
33	employee of a law-enforcement agency or court, shall be guilty of a Class 1 misdemeanor and shall
