An Act to amend and reenact §§ 2.1-1.6, 2.1-429.4, and 9-6.25:1 of the Code of Virginia and to repeal §§ 2.1-427 and 2.1-428 of the Code of Virginia, relating to the Laboratory Services Advisory Board.

Be it enacted by the General Assembly of Virginia:

1. That §§ 2.1-1.6, 2.1-429.4, and 9-6.25:1 of the Code of Virginia are amended and reenacted as follows:

§ 2.1-1.6. State boards.

- 178 Department of General Services is authorized to take in and absorb within the Division of Consolidated

179 Laboratory Services any laboratory activity that is owned and operated by a political subdivision of the
 180 Commonwealth that will conform to the duties and responsibilities of the Division. Any costs that may
 181 accrue to the Commonwealth as a result of the consolidation must be paid out of funds specifically
 182 appropriated for this purpose by the general appropriations act.
