6 Be it enacted by the General Assembly of Virginia:

7 1. That § 32.1-102.3:2 of the Code of Virginia is amended and reenacted as follows: 8

§ 32.1-102.3:2. Certificates of public need; moratorium; exceptions.

9 The Commissioner of Health shall not approve, authorize or accept applications for the issuance of 10 any certificate of public need pursuant to this article for any project which would result in an increase in the number of beds in which nursing facility or extended care services are provided through June 30, 11 12 1996. However, the Commissioner may approve or authorize:

13 1. The issuance of a certificate of public need for a project for the (i) renovation or replacement on site of an existing facility or any part thereof or (ii) replacement off-site of an existing facility at a 14 15 location within the same city or county and within reasonable proximity to the current site when replacement on the current site is proven infeasible, in accordance with the law, when a capital 16 17 expenditure is required to comply with life safety codes, licensure, certification or accreditation standards. Under no circumstances shall the State Health Commissioner approve, authorize, or accept an 18 19 application for the issuance of a certificate for any project which would result in the continued use of 20 the facility replaced as a nursing facility.

21 2. The issuance of a certificate of public need for any project for the conversion on site of existing licensed beds to beds certified for skilled nursing services (SNF) when (i) the total number of beds to be 22 23 converted does not exceed the lesser of twenty beds or ten percent of the beds in the facility; (ii) the 24 facility has demonstrated that the SNF beds are needed specifically to serve a specialty heavy care 25 patient population, such as ventilator-dependent and AIDS patients and that such patients otherwise will 26 not have reasonable access to such services in existing or approved facilities; and (iii) the facility further 27 commits to admit such patients on a priority basis once the SNF unit is certified and operational.

3. The issuance of a certificate of public need for any project for the conversion on site of existing 28 29 beds in an adult care residence licensed pursuant to Chapter 9 (§ 63.1-172 et seq.) of Title 63.1 as of 30 March 1, 1990, to beds certified as nursing facility beds when (i) the total number of beds to be 31 converted does not exceed the lesser of thirty beds or twenty-five percent of the beds in the adult care 32 residence; (ii) the adult care residence has demonstrated that nursing facility beds are needed specifically 33 to serve a patient population of AIDS, or ventilator-dependent, or head and spinal cord injured patients, 34 or any combination of the three, and that such patients otherwise will not have reasonable access to such 35 services in existing or approved nursing facilities; (iii) the adult care residence further commits to admit such patients once the nursing facility beds are certified and operational; and (iv) the licensed adult care 36 37 residence otherwise meets the standards for nursing facility beds as set forth in the regulations of the 38 Board of Health. Notwithstanding the conditions required by this exception related to serving specific 39 patient populations, an adult care residence which has obtained by January 1, 1991, a certificate of 40 public need for a project for conversion on site of existing beds in its facility licensed pursuant to 41 Chapter 9 of Title 63.1 as of March 1, 1990, to beds certified as nursing facility beds may use the beds 42 converted to nursing facility beds pursuant to this exception for patient populations requiring specialized 43 care of at least the same intensity which meet the criteria for the establishment of a specialized care 44 nursing facility contract with the Department of Medical Assistance Services.

45 4. The issuance of a certificate of public need for a project in an existing nursing facility owned and operated by the governing body of a county when (i) the total number of new beds to be added by 46 construction does not exceed the lesser of thirty beds or twenty-five percent of the existing nursing 47 48 facility beds in the facility; (ii) the facility has demonstrated that the nursing facility beds are needed 49 specifically to serve a specialty heavy care patient population, such as dementia, ventilator-dependent, 50 and AIDS patients; and (iii) the facility has executed an agreement with a state-supported medical college to provide training in geriatric nursing. 51

52 5. The issuance of a certificate of public need for a nursing facility project located in the City of 53 Staunton when (i) the total number of new beds to be constructed does not exceed thirty beds; (ii) the 54 facility is owned by and will be operated as a nonprofit entity; and (iii) the project is proposed as part 55 of a retirement community that is a continuing care provider registered with the State Corporation 56 Commission pursuant to Chapter 49 (§ 38.2-4900 et seq.) of Title 38.2.

57 6. The issuance of a certificate of public need for any project for an increase in the number of beds 58 in which nursing home or extended care services are provided, or the creation of new beds in which 59 such services are to be provided, by any continuing care provider registered with the State Corporation 60 Commission pursuant to Chapter 49 of Title 38.2, if (i) the total number of new or additional nursing 61 home beds plus any existing nursing home beds operated by the provider does not exceed twenty 62 percent of the continuing care provider's total existing or planned independent living and adult care 63 residence population when the beds are to be added by new construction, or twenty-five beds when the 64 beds are to be added by conversion on site of existing beds in an adult care residence licensed pursuant 65 to Chapter 9 of Title 63.1; (ii) such beds are necessary to meet existing or reasonably anticipated 66 obligations to provide care to present or prospective residents of the continuing care facility pursuant to 67 continuing care contracts meeting the requirements of § 38.2-4905; (iii) the provider agrees in writing not to seek certification for the use of such new or additional beds by persons eligible to receive 68 medical assistance services pursuant to Title XIX of the United States Social Security Act; (iv) the 69 70 provider agrees in writing to obtain, prior to admission of every resident of the continuing care facility, 71 the resident's written acknowledgement acknowledgment that the provider does not serve recipients of medical assistance services and that, in the event such resident becomes a medical assistance services 72 73 recipient who is eligible for nursing facility placement, such resident shall not be eligible for placement 74 in the provider's nursing facility unit; and (v) the provider agrees in writing that only continuing care 75 contract holders will be admitted to the nursing home beds after the first three years of operation.

Further, if a certificate is approved pursuant to this subdivision, admissions to such new or additional beds shall be restricted for the first three years of operation to patients for whose care, pursuant to an agreement between the facility and the individual financially responsible for the patient, private payment will be made or persons who have entered into an agreement with the facility for continuing care contracts meeting the requirements of § 38.2-4905.

7. The issuance of a certificate of public need for a nursing facility project associated with a 81 continuing care provider which did not operate a nursing home on January 1, 1993, and was registered 82 83 as of January 1, 1993, with the State Corporation Commission pursuant to Chapter 49 of Title 38.2, if 84 (i) the total number of new beds to be constructed does not exceed sixty beds; (ii) the facility is owned 85 by and will be operated as a nonprofit entity; (iii) after the first three years of operation, the facility will admit only retired officers of the United States uniformed forces and their surviving spouses; (iv) the 86 87 provider agrees in writing not to seek certification for the use of such beds by persons eligible to 88 receive medical assistance services pursuant to Title XIX of the United States Social Security Act; and 89 (v) the provider agrees in writing to obtain, prior to admission of every resident of the continuing care 90 facility, the written acknowledgement acknowledgment that the provider does not serve recipients of 91 medical assistance services and that, in the event such resident becomes a medical assistance services 92 recipient who is eligible for nursing facility placement, such resident shall not be eligible for placement 93 in the provider's nursing facility unit. Further, if a certificate is approved, pursuant to this subdivision, 94 admissions to such beds shall be restricted to persons for whose care, pursuant to an agreement with the 95 facility, private payment will be made or persons who have entered into an agreement with the facility 96 for continuing care contracts meeting the requirements of § 38.2-4905.

8. The issuance of a certificate of public need for a nursing facility project located in the City of
Norfolk if (i) the total number of beds to be constructed does not exceed 120 beds; (ii) the facility will
replace an existing facility in the City of Chesapeake; (iii) the construction of the facility has been
delayed by environmental contamination caused by leaking underground storage tanks; and (iv) the total
capital costs of the facility will not exceed \$4,387,000.

102 9. The issuance of a certificate of public need for a project in an existing nonprofit nursing facility 103 located in the City of Lynchburg if (i) the current facility consists of four nursing units, with the two 104 nursing units constructed in 1969 to be retained; (ii) forty of the newly constructed beds will replace 105 existing eighteen two-bed and twenty two-bed units, built before 1915; (iii) the total number of beds to 106 be constructed does not exceed sixty beds, including forty existing and twenty new beds; (iv) the area around the construction site has been identified by the local governing body for major renovation and 107 108 revitalization; and (v) the project is the subject of a memorandum of agreement between the local governing body and the applicant, pursuant to which, the local governing body agrees to make certain 109 110 improvements to the area of the project's location.

111 10. The issuance of a certificate of public need for an increase in the number of beds in which 112 nursing facility or extended care services are provided or the creation of new beds in which such 113 services are to be provided in the City of Virginia Beach by an association described in § 55-458 114 created in connection with a real estate cooperative for which an application for registration was filed as 115 required by § 55-497 prior to January 1, 1994, which offers a level of nursing services to its residents 116 consistent with the definition of continuing care in § 38.2-4900 if (i) the total number of new or 117 additional nursing care beds plus any existing nursing care beds operated by the association does not

118 exceed twenty percent of the number of total existing or planned cooperative units when beds are to be 119 added by new construction or by conversion on site of existing beds in a licensed adult care residence; 120 (ii) such beds are necessary to meet existing or reasonably anticipated obligations to provide nursing 121 care to present or prospective residents of the cooperative units pursuant to a written agreement with the 122 association; (iii) the association agrees in writing not to seek certification for the use of any such beds 123 by persons eligible to receive medical assistance services pursuant to Title XIX of the United States 124 Social Security Act; (iv) the association agrees in writing to obtain, prior to each resident's occupancy of 125 a cooperative unit, the resident's written acknowledgment that the association does not serve recipients of 126 medical assistance services and that in the event such resident becomes a medical assistance services recipient who is eligible for nursing facility placement such resident shall not be eligible for placement 127 128 in the association's nursing facility unit; (v) the association agrees in writing that only residents of 129 cooperative units will be admitted to the nursing care beds after the first three years of operation as a 130 nursing care facility; and (vi) the association complies with the disclosure requirements for continuing 131 care providers pursuant to Chapter 49 of Title 38.2.

132 11. The issuance of a certificate of public need for a nursing facility project located in the City of
133 Charlottesville if (i) the total number of beds to be converted from hospital to nursing facility use does
134 not exceed thirty beds; (ii) the facility will provide nursing services to patients committed to, transferred
135 to, or discharged from facilities owned by the Department of Mental Health, Mental Retardation and
136 Substance Abuse Services and from any psychiatric hospital located in the City of Charlottesville or
137 Albemarle County; and (iii) the facility has executed an agreement with the Department of Mental
138 Health, Mental Retardation and Substance Abuse Services to provide such services.

139 12. The issuance of a certificate of public need for a nursing facility project located in Montgomery
140 County if (i) the total number of beds to be constructed does not exceed sixty beds; (ii) the facility has
141 entered into a partnership with several public institutions of higher education to establish a gerontology
142 center for the conduct of research and the education of professionals; and (iii) the nursing facility beds
143 will be an integral part of an existing health care institution which has a mission of providing a
144 continuum of care as recorded in its 100-year plan.

145 13. The issuance of a certificate of public need for a nursing facility project located in the Town of 146 Colonial Beach if (i) the total number of beds to be converted from adult care residence to nursing 147 facility use does not exceed seven; (ii) the facility is owned by a nonprofit health care center located in 148 Fredericksburg; and (iii) the total number of new or additional beds plus existing nursing facility beds 149 operated by the facility will not exceed sixty.

150 14. The issuance of a certificate of public need to a nursing facility in Ashland, Virginia, currently operating at ninety-nine percent occupancy to convert ten private rooms to semiprivate, thereby adding ten beds to an existing fifty-bed wing to promote efficiency of operations and improve access for area residents if the total capital expenditures will not exceed \$15,000.

15. The issuance of a certificate of public need for a nursing facility project located in an existing facility which currently contains 325 "independent living" units with home health services available, 154 155 156 seventy-five assisted living units, and thirty-one nursing facility beds, only five of which are certified for 157 use by persons eligible to receive medical assistance services pursuant to Title XIX of the United States 158 Social Security Act if (i) the total number of beds to be constructed does not exceed thirty beds, (ii) the 159 facility agrees in writing not to seek certification for the use of any such beds by persons eligible to receive medical assistance services pursuant to Title XIX of the United States Social Security Act, (iii) 160 161 such beds are necessary to meet existing or reasonably anticipated obligations to provide nursing care to 162 present or prospective residents of this retirement community, and (iv) the retirement community agrees in writing that only residents of the retirement community will be admitted to such nursing facility beds 163 164 after the first three years of operation.

165 16. The issuance of a certificate of public need for a project in an existing facility located in Scott County for the conversion on site of existing beds in an adult care residence licensed pursuant to 166 Chapter 9 (§ 63.1-172 et seq.) of Title 63.1 as of October 1, 1994, to beds certified as nursing facility 167 168 beds when (i) the total number of beds to be converted does not exceed the lesser of thirty beds or 169 twenty-five percent of the beds in the adult care residence; (ii) the adult care residence has demonstrated 170 that nursing facility beds are needed specifically to serve a population of patients having Alzheimer's 171 Disease or related disorders and that such patients will not otherwise have reasonable access to such 172 services in existing or approved nursing facilities; (iii) the adult care residence will restrict admissions to 173 such patients once the nursing facility beds are certified and operational; and (iv) the licensed adult care 174 residence otherwise meets the standards for nursing facility beds as set forth in the regulations of the 175 Board of Health.

176 17. The issuance of a certificate of public need in an existing nursing facility project if (i) the
177 facility's total number of beds will not exceed sixty beds, including existing beds and those proposed;
178 (ii) the space in the existing nursing facility in which the proposed additional beds will be located has

never been occupied by any licensed beds; and (iii) the total direct capital costs associated with theproposed project will not exceed \$10,000.

18. The issuance of a certificate of public need to a nonprofit nursing facility project located in 181 182 Henrico County that is designed to provide a continuum of care for patients with Alzheimer's Disease 183 and related disorders if (i) the project was under construction January 1, 1995, and will be ready for 184 occupancy no later than June 1, 1996; (ii) not less than thirty of the newly constructed beds will be designated and retained as private pay beds priority access to the new nursing facility beds will be given 185 to individuals living in the adult care residence located within the same facility in which the new 186 nursing facility beds are proposed; however, access to the new nursing facility beds will not be limited 187 188 to these adult care residence patients; and (iii) subject to a determination of, and until otherwise 189 specified by, the Commissioner, up to thirty of the new nursing facility beds may be required to be retained exclusively as private pay beds; and (iv) the total number of nursing facility beds to be 190 191 constructed does not exceed sixty beds.

192 Notwithstanding the foregoing and other provisions of Article 1.1 (§ 32.1-102.1 et seq.) of Chapter 4
193 of this title, the state home for aged and infirm veterans authorized by Chapter 668, 1989 Acts of
194 Assembly, shall be exempt from all the 1993 certificates of public need review requirements as a
195 medical care facility.

196 2. That an emergency exists and this act shall be in force from its passage.

197 3. That, except for this enactment clause, this act shall expire on July 1, 1996, unless the 198 moratorium provided in § 32.1-102.3:2 remains in effect on July 1, 1996; the Commissioner, 199 however, shall continue to review and may approve any applications accepted for review prior to 200 July 1, 1996, pursuant to the exceptions included in § 32.1-102.3:2, as it was in effect on the date 201 this act becomes effective. The Commissioner shall take final action on all such applications by

202 December 31, 1996.
