## HOUSE BILL NO. 1371

## AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the Senate Committee for Courts of Justice  
on February 28, 1996)

(Patron Prior to Substitute—Delegate Nixon)

*A BILL to amend and reenact §§ 20-108.2 and 63.1-264.2 of the Code of Virginia, relating to determination of child support; imputed income.***Be it enacted by the General Assembly of Virginia:****1. That §§ 20-108.2 and 63.1-264.2 of the Code of Virginia are amended and reenacted as follows:**

§ 20-108.2. Guideline for determination of child support.

A. There shall be a rebuttable presumption in any judicial or administrative proceeding for child support under this title or Title 16.1 or 63.1, including cases involving split custody or shared custody, that the amount of the award which would result from the application of the guidelines set forth in this section is the correct amount of child support to be awarded. In order to rebut the presumption, the court shall make written findings in the order as set out in § 20-108.1, which findings may be incorporated by reference, that the application of the guidelines would be unjust or inappropriate in a particular case as determined by relevant evidence pertaining to the factors set out in §§ 20-107.2 and 20-108.1. The Department of Social Services shall set child support at the amount resulting from computations using the guidelines set out in this section pursuant to the authority granted to it in Chapter 13 (§ 63.1-249 et seq.) of Title 63.1 and subject to the provisions of § 63.1-264.2.

B. For purposes of application of the guideline, a basic child support obligation shall be computed using the schedule set out below. *However, a minimum obligation of \$65 shall be established regardless of income.* For combined monthly gross income amounts falling between amounts shown in the schedule, basic child support obligation amounts shall be extrapolated. "Number of children" shall mean the number of children for whom the parents share joint legal responsibility and for whom support is being sought.

of child support for \$10,000 to the following percentages of gross income above \$10,000:

For gross monthly income between \$20,000 and \$50,000, add the amount of child support for \$20,000 to the following percentages of gross income above \$20,000:

For gross monthly income over \$50,000, add the amount of child support for \$50,000 to the following percentages of gross income above \$50,000:

C. For purposes of this section, "gross income" shall mean all income from all sources, and shall include, but not be limited to, income from salaries, wages, commissions, royalties, bonuses, dividends, severance pay, pensions, interest, trust income, annuities, capital gains, social security benefits except as listed below, workers' compensation benefits, unemployment insurance benefits, disability insurance benefits, veterans' benefits, spousal support, rental income, gifts, prizes or awards. Gross income shall be subject to deduction of reasonable business expenses for persons with income from self-employment, a partnership, or a closely held business. "Gross income" shall not include benefits from public assistance programs as defined in § 63.1-87, federal supplemental security income benefits, or child support received. For purposes of this subsection, spousal support included in gross income shall be limited to spousal support paid pursuant to a pre-existing order or written agreement and spousal support shall be deducted from the gross income of the payor when paid pursuant to a pre-existing order or written agreement between the parties to the present proceeding.

D. Any extraordinary medical and dental expenses for treatment of the child or children shall be added to the basic child support obligation. For purposes of this section, extraordinary medical and dental expenses are uninsured expenses in excess of \$100 for a single illness or condition and shall include but not be limited to eyeglasses, prescription medication, prostheses, and mental health services whether provided by a social worker, psychologist, psychiatrist, or counselor.

E. Any costs for health care coverage as defined in § 63.1-250, when actually being paid by a parent, to the extent such costs are directly allocable to the child or children, and which are the extra costs of covering the child or children beyond whatever coverage the parent providing the coverage would otherwise have, shall be added to the basic child support obligation.

F. Any child-care costs incurred on behalf of the child or children due to employment of the custodial parent shall be added to the basic child support obligation. Child-care costs shall not exceed the amount required to provide quality care from a licensed source. Where appropriate, the court shall consider the willingness and availability of the noncustodial parent to provide child care personally in determining whether child-care costs are necessary or excessive.

G. 1. Except in cases involving split custody or shared custody, a total monthly child support obligation shall be established by adding (i) the monthly basic child support obligation, as determined from the schedule contained in subsection B of this section, (ii) all extraordinary medical expenses, (iii) costs for health care coverage to the extent allowable by subsection E, and (iv) work-related child-care costs and taking into consideration all the factors set forth in subsection B of § 20-108.1. The total monthly child support obligation shall be divided between the parents in the same proportion as their monthly gross incomes bear to their monthly combined gross income. The monthly obligation of each parent shall be computed by multiplying each parent's percentage of the parents' monthly combined gross income by the total monthly child support obligation.

286 However, the monthly obligation of the noncustodial parent shall be reduced by the cost for health  
287 care coverage to the extent allowable by subsection E when paid directly by the noncustodial parent.

288 2. In cases involving split custody, the amount of child support to be paid shall be the difference  
289 between the amounts owed by each parent as a noncustodial parent, computed in accordance with  
290 subdivision 1 of this subsection, with the noncustodial parent owing the larger amount paying the  
291 difference to the other parent.

292 For the purpose of this section and § 20-108.1, split custody shall be limited to those situations  
293 where each parent has physical custody of a child or children born of the parents, born of either parent  
294 and adopted by the other parent or adopted by both parents. For the purposes of calculating a child  
295 support obligation where split custody exists, a separate family unit exists for each parent, and child  
296 support for that family unit shall be calculated upon the number of children in that family unit who are  
297 born of the parents, born of either parent and adopted by the other parent or adopted by both parents.  
298 Where split custody exists, a parent is a custodial parent to the children in that parent's family unit and  
299 is a noncustodial parent to the children in the other parent's family unit.

300 3. In cases involving shared custody, the amount of child support to be paid is the difference  
301 between the amounts owed by each parent to the other parent, with the parent owing the larger amount  
302 paying the difference to the other parent.

303 To compute the monthly amount to be paid by one parent to the other parent, the following  
304 calculations shall be made:

305 (a) The "basic child support obligation" of each parent shall be the "total shared support" multiplied  
306 by the other parent's "custody share." The "total shared support" of both parties equals statutory  
307 guideline amount determined pursuant to subsection B for the combined income of the parties and the  
308 number of shared children multiplied by 1.25. A parent's "custody share" equals the number of days that  
309 parent has physical custody of a shared child per year divided by the number of days in the year.

310 (b) To each parent's "basic child support obligation" shall be added the other parent's costs of health  
311 care coverage, to the extent allowable by subsection E, and the other parent's work-related child care  
312 costs to the extent allowable by subsection F.

313 (c) The obligation of each parent to the other shall be then computed by multiplying each parent's  
314 percentage of the parents' monthly combined gross income by the support obligation obtained in  
315 subdivision G 3 (b).

316 The shared custody rules set forth herein apply when each parent has physical custody of a child or  
317 children born of the parties, born of either parent and adopted by the other parent, or adopted by both  
318 parents, for more than 110 days of the year. Any calculation under this subdivision shall not create or  
319 reduce a support obligation to an amount which seriously impairs the custodial parent's ability to  
320 maintain minimal adequate housing and provide other basic necessities for the child.

321 H. The Secretary of Health and Human Resources shall ensure that the guideline set out in this  
322 section is reviewed by July 1, 1990, and every four years thereafter, by a panel which includes  
323 representatives of the courts, the executive branch, the General Assembly, the bar, custodial and  
324 noncustodial parents and child advocates. The panel shall determine the adequacy of the guideline for  
325 the determination of appropriate awards for the support of children by considering current research and  
326 data on the cost of and expenditures necessary for rearing children, and any other resources it deems  
327 relevant to such review. The panel shall report its findings to the General Assembly before it next  
328 convenes following such review.

329 § 63.1-264.2. Scale of suggested minimum contributions.

330 The Department shall set child support at the amount resulting from computations pursuant to the  
331 guideline set out in § 20-108.2 in determining the required monthly support obligation, the amount of  
332 support obligation arrearage, if any, and the amount to be paid periodically against such arrearage. There  
333 shall be a rebuttable presumption that the amount of the award which would result from the application  
334 of the guidelines is the correct amount of child support to be awarded. In order to rebut the presumption  
335 the Department shall make written findings in its order that the application of the guidelines would be  
336 unjust or inappropriate in a particular case as determined by relevant evidence pertaining to support for  
337 other children in the household or other children for whom any administrative or court order exists, *or*  
338 *relevant evidence pertaining to imputed income to a person who is voluntarily unemployed or who fails*  
339 *to provide verification of income upon request of the Department; provided that income may not be*  
340 *imputed to the custodial parent because (i) a child is not regularly attending school, (ii) child care*  
341 *services are not available, or (iii) the cost of such child care services are not added to the basic child*  
342 *support obligation.* Additional factors which may lead to rebuttal of the presumption shall be determined  
343 by Department regulation.
