11	Be it enacted by the General Assembly of Virginia:
12	1. That § 46.2-323 of the Code of Virginia is amended and reenacted as follows:
13	§ 46.2-323. Application for driver's license; proof of completion of driver education program; penalty.
14	A. Every application for a driver's license, temporary driver's permit, or learner's permit shall be
15	made on a form prescribed by the Department and the applicant shall write his usual signature in ink in
16 17	the space provided on the form. The form shall include notice to the applicant of the duty to register with the Department of State Police of gravitad of a
17	with the Department of State Police as provided in § 19.2-298.1, if the applicant has been convicted of a felony in violation of §§ 18.2-61, 18.2-63, 18.2-64.1, 18.2-67.1, 18.2-67.2, 18.2-67.3, 18.2-67.5,
19	18.2-370 or § $18.2-370.1$ or, where the victim is a minor or is physically helpless or mentally
20	incapacitated as defined in § 18.2-67.10, subsection B of § 18.2-361 or subsection B of § 18.2-366,
21	including juveniles tried and convicted in the circuit courts pursuant to § 16.1-269 whether sentenced as
$\overline{22}$	adults or juveniles, or a felony under a substantially similar law of the United States or any other state.
23	B. Every application shall state the name, year, month and date of birth, social security number, sex,
24	and residence address of the applicant; whether or not the applicant has previously been licensed as a
25	driver and, if so, when and by what state, and whether or not his license has ever been suspended or
26	revoked and, if so, the date of and reason for such suspension or revocation. The Department, as a
27	condition for the issuance of any driver's license, temporary driver's permit, or learner's permit, may
28	require the surrender of any driver's license issued by another state and held by the applicant. The
29	applicant shall also answer any questions on the application form or otherwise propounded by the
30 31	Department incidental to the examination. The applicant may also be required to present to the person
31 32	conducting the examination a birth certificate or other evidence, reasonably acceptable to the Department, of his name and date of birth.
32 33	The applicant shall also certify that he is a resident of the Commonwealth by signing a certification
33 34	statement, on a form prescribed by the Commissioner, and by providing satisfactory proof that he is a
35	resident of the Commonwealth. The Commissioner may adopt regulations to determine the process by
36	which applicants prove that they are residents of the Commonwealth.
37	If the applicant either (i) fails or refuses to sign the certification statement or (ii) fails to follow the
38	process determined by the Commissioner for proving residency, the Department shall not issue the
39	applicant a driver's license, temporary driver's permit, or learner's permit.
40	Any applicant who knowingly makes a false certification of Virginia residency or supplies false or
41	fictitious evidence of Virginia residency shall be punished as provided in § 46.2-348.
42	The Commissioner may, on a case-by-case basis, waive any provision of such regulations for good cause shown.

45	C. Every application for a driver's license shall include a color photograph of the applicant supplied under arrangements made by the Department. The photograph shall be processed by the Department so
46	that the photograph can be made part of the issued license. Photographs, for applicants under twenty-one
47	years of age, shall be profile photographs; such photographs, for applicants twenty-one years of age and
48	older, shall be front face view photographs.
49	D. Notwithstanding the provisions of subsection C, the first and subsequent photographs for persons
50	under twenty-one years of age shall be profile photographs until the original issued license has expired.
51	E. Notwithstanding the provisions of § 46.2-334, every unlicensed applicant for a driver's license who
52	is under nineteen years of age shall furnish the Department with satisfactory proof of his successful
53	completion of a driver education program approved by the State Department of Education.
54	F. Any form used in applying for renewal of a driver's license shall include language permitting the
55 56	applicant to make a voluntary contribution of one dollar to Prevent Blindness Virginia, a not-for-profit
56 57	organization. All such contributions shall be collected by the Department, distributed quarterly to
57 58	Prevent Blindness Virginia, and used to prevent blindness and preserve the sight of the residents of the Commonwealth A statement providing an applanation of the purpose of these contributions shall be
58 59	Commonwealth. A statement providing an explanation of the purpose of these contributions shall be provided by the Department along with every application form for renewal of a Virginia driver's license.
