11 12 13	Be it enacted by the General Assembly of Virginia: 1. That the Code of Virginia is amended by adding in Chapter 13 of Title 22.1 an article numbered 1.2, consisting of sections numbered 22.1-212.5 through 22.1-212.15, as follows:

16 17	§ 22.1-212.5. Definitions. As used in this article:
18	"At-risk pupil" means a student who, because of physical, emotional, intellectual, socioeconomic, or
19	cultural factors, may not succeed in a conventional educational environment.
20 21 22 23 24	"Charter school" means a public, nonsectarian, nonreligious, or non-home-based school located within a public school division. A charter school may be created as a new public school or through the conversion of all or part of an existing public school; however, no charter school shall be established through the conversion of a private school or a nonpublic home-based educational program. § 22.1-212.6. Establishment and operation of charter schools; requirements.

A charter school shall be subject to all federal and state laws and constitutional provisions prohibiting discrimination on the basis of disability, race, creed, color, gender, national origin, religion, ancestry, or need for special education services, and shall be subject to any court-ordered desegregation plan in effect for the school division. Enrollment shall be open to any child who resides within the school division.
30 31 32 33 34 35	B. A charter school shall be administered and governed by a governing body in a manner agreed to by the charter school applicant and the local school board. Pursuant to a charter contract and as specified in § 221-212.7, a charter school may operate free from specified school division policies and state regulations, except for the requirements of the Standards of Quality. Upon request of the charter applicant, the Board of Education shall provide summaries of the regulations and policies to use in preparing a charter school application.

Pursuant to a charter agreement, a charter school shall be responsible for its own operations, including, but not limited to, budget preparation, contracts for services, and personnel matters as specified in the charter agreement. A charter school may negotiate and contract with a school division, the governing body of a public institution of higher education, or any third party for the use of a school building and grounds, the operation and maintenance thereof, and the provision of any service, activity, or undertaking which the charter school is required to perform in order to carry out the educational program described in its charter. Any services for which a charter school contracts with a school division shall not exceed the division's cost to provide such services.
44 45 46 47	D. In no event shall a charter school be required to pay rent for space which is deemed available, as negotiated by contract, in school division facilities. All other costs for the operation and maintenance of the facilities used by the charter school shall be subject to negotiation between the charter school and the school division.

61 B. The charter school application shall be a proposed agreement and shall include:

62 1. The mission statement of the charter school, which must be consistent with the principles of the 63 Standards of Quality.

64 2. The goals and educational objectives to be achieved by the charter school, which educational 65 objectives must meet or exceed the Standards of Learning.

66 3. Evidence that an adequate number of parents, teachers, pupils, or any combination thereof support the formation of a charter school. 67

68 4. A statement of the need for a charter school in a school division or in a geographic area within a 69 school division.

70 5. A description of the charter school's educational program, pupil performance standards, and 71 curriculum, which must meet or exceed any applicable Standards of Quality, the assessments to be used 72 to measure pupil progress towards achievement of the school's pupil performance standards, the timeline for achievement of such standards, and the procedures for taking corrective action in the event that 73 pupil performance at the charter school falls below such standards. 74

75 6. A description of an equitable selection process to be used if the charter school's capacity is insufficient to enroll all pupils who submit a timely application and, if appropriate, a tailored admission 76 77 policy that meets the specific mission or focus of the charter school and is consistent with all federal 78 and state laws and constitutional provisions prohibiting discrimination that are applicable to public 79 schools and with any court-ordered desegregation plan in effect for the school.

80 7. Evidence that the plan for the charter school is economically sound for both the charter school and the school division, a proposed budget for the term of the charter, and a description of the manner 81 in which an annual audit of the financial and administrative operations of the charter school, including 82 83 any services provided by the school division, is to be conducted.

84 8. A plan for the displacement of pupils, teachers, and other employees who will not attend or be 85 employed in the charter school and for the placement of charter school pupils, teachers, and employees 86 upon termination or revocation of the charter.

87 9. A description of the governance and operation of the charter school, including the nature and 88 extent of parental, professional educator, and community involvement in the governance and operation 89 of the charter school.

90 10. An explanation of the relationship that will exist between the proposed charter school and its 91 employees, including evidence that the terms and conditions of employment have been addressed with 92 affected employees.

93 11. An agreement between the parties regarding their respective legal liability and applicable 94 insurance coverage.

95 12. A description of how the charter school plans to meet the transportation needs of its pupils.

96 13. Assurances that the charter school (i) is nonsectarian in its programs, admission policies, 97 employment practices, and all other operations and (ii) does not charge tuition. 98

§ 22.1-212.9. Review of charter applications.

99 A. Upon adoption by the local school board of a resolution stating its intent to receive applications 100 for the establishment of charter schools in the school division, the local school board may receive and review all applications for charter schools. The local school board may establish a schedule for 101 102 receiving, reviewing, and ruling upon applications and shall make a copy of any such schedule 103 available to all interested parties upon request. If such board finds the charter school application is 104 incomplete, the board shall request the necessary information from the charter applicant.

105 B. To provide appropriate opportunity for input from parents, teachers, and other interested parties and to obtain information to assist the local school board in its decision to grant a charter school 106 107 application, the local school board may establish a procedure for public notice, comment, or hearings 108 on charter school applications.

109 § 22.1-212.10. Decision of local board final.

110 The decision of a local school board to grant or deny a charter school application or to revoke or fail to renew a charter agreement shall be final and not subject to appeal. 111

§ 22.1-212.11. Charter schools restrictions.

112

A. On and after July 1, 1996, local school boards electing to receive applications for charter schools 113 114 pursuant to § 22.1-212.9 may establish a charter school within the school division and shall be authorized to limit the number of schools so established. However, no more than two charters per 115 school division shall be granted prior to July 1, 1998. Priority shall be given to charter school 116 applications designed to increase the educational opportunities of at-risk students, and at least one-half 117 of the charters per division shall be reserved for such applications. 118

119 B. Local school boards that grant charter school applications shall report such action to the Board and shall specify the maximum number of charters that may be authorized, if any; the number of 120 charters granted; and whether a charter school is designed to increase the educational opportunities of 121

122 at-risk students.

123 C. Nothing in this article shall be construed to prevent a school that is the only school in the 124 division from applying to become a charter school.

125 § 22.1-212.12. Charter school term; renewals and revocations.

126 A. A charter may be approved or renewed for a period not to exceed three school years. A charter 127 school renewal application submitted to the local school board shall contain:

128 1. A report on the progress of the charter school in achieving the goals, objectives, program and 129 performance standards for students, and such other conditions and terms as the school board may 130 require upon granting initial approval of the charter application.

131 2. A financial statement, on forms prescribed by the Board, that discloses the costs of administration, 132 instruction, and other spending categories for the charter school that has been concisely and clearly 133 written to enable the public to compare such costs to those of other schools or comparable 134 organizations. 135

B. A local school board may revoke a charter if the charter school:

136 1. Violates the conditions, standards, or procedures established in the charter school application;

137 2. Fails to meet or make reasonable progress toward achievement of the content standards or 138 student performance standards identified in the charter application;

139 3. Fails to meet generally accepted standards of fiscal management; or

140 4. Violates any provision of law from which the charter school was not specifically exempted.

141 A charter may be revoked if the local school board determines, in its discretion, that it is not in the 142 public interest or for the welfare of the students within the school division to continue the operation of 143 the school.

144 C. Nothing in this section shall be construed to restrict the authority of the local school board to 145 decline to renew a charter agreement.

146 § 22.1-212.13. Employment of professional, licensed personnel. 147

A. Charter school personnel shall be employees of the local school board granting the charter.

148 B. Professional, licensed personnel may volunteer for assignment to a charter school. Assignment in 149 a charter school shall be for one contract year. Upon request of the employee and the recommendation 150 of the governing board of the charter school, reassignment to the charter school shall occur on an 151 annual basis.

152 C. At the completion of each contract year, professional, licensed personnel who request assignment 153 to a noncharter school in the school division or who are not recommended for reassignment in the 154 charter school, other than for the grounds cited in § 22.1-307, shall be guaranteed an involuntary 155 transfer to a noncharter school in the school division according to the employment policies of the school 156 division.

157 D. Professional, licensed personnel of a charter school shall be granted the same employment 158 benefits given to professional, licensed personnel in noncharter schools.

159 E. Nothing in this section shall be construed to restrict the authority of the local school board to assign professional, licensed personnel to a charter school or any other public school as provided in 160 § 22.1-295. 161

162 § 22.1-212.14. Funding of charter schools; services provided.

163 A. For the purposes of this chapter, students enrolled in a charter school shall be included in the 164 average daily membership of the school division; however, charter schools shall not be reported in fall 165 membership for purposes of calculating the state and local shares required to fund the Standards of 166 Quality.

167 B. Insofar as constitutionally valid, a local school board may establish by contract an agreement 168 stating the conditions for funding the charter school.

169 C. Services provided the charter school by the local school board may include food services; 170 custodial and maintenance services; curriculum, media, and library services; warehousing and 171 merchandising; and such other services not prohibited by the provisions of this chapter or state and 172 federal laws.

173 D. Funding and service agreements between local school boards and charter schools shall not 174 provide a financial incentive or constitute a financial disincentive to the establishment of a charter 175 school.

176 E. Any educational and related fees collected from students enrolled at a charter school shall be 177 credited to the account of such charter school established by the local school board.

178 F. Notwithstanding any other provision of law, the proportionate share of state and federal resources 179 allocated for students with disabilities and school personnel assigned to special education programs 180 shall be directed to charter schools enrolling such students. The proportionate share of moneys 181 allocated under other federal or state categorical aid programs shall be directed to charter schools

182 serving students eligible for such aid. G. The governing body of a charter school is authorized to accept gifts, donations, or grants of any kind made to the charter school and to spend such funds in accordance with the conditions prescribed by the donor. However, no gift, donation, or grant shall be accepted by the governing body of a charter school if the conditions for such funds are contrary to law or the terms of the agreement between the local school board and the charter school.

190 § 22.1-212.15. Evaluation of charter schools; reports.

School boards establishing charter schools shall submit annual evaluations of such schools to the
Board of Education. The Board shall review the evaluations against any Board regulations and policies
waived for the charter schools to determine the efficacy of such waivers and whether the charter schools
accomplished established goals and objectives. Such school boards shall also submit annually to the
Board a comparison of the performance of charter school students and students enrolled in the regular
schools of the school division and a report of the number of students enrolled in such charter schools at

198 The Board shall report annually its findings and evaluations of any charter schools established in **199** the Commonwealth to the Governor and the General Assembly, beginning in January 1997.
