6	Be it enacted by the General Assembly of Virginia:
7	1. That § 10.1-2212 of the Code of Virginia is amended and reenacted as follows:
8	§ 10.1-2212. Listing of certain historical societies receiving appropriations.
9	A. At the direction of the Director, the Comptroller of the Commonwealth is instructed and
10 11	empowered to draw annual warrants upon the State Treasurer, as provided in the general appropriations act, in favor of the treasurers of certain historical societies, museums, foundations, and associations for
11	use in caring for and maintaining collections, exhibits, sites, and facilities owned by such historical
13	organizations, specified as follows:
14	1. Virginia Historical Society. For aid in maintaining Battle Abbey at Richmond.
15	2. Confederate Museum at Richmond. For the care of Confederate collections and maintenance of the
16 17	Virginia Room. 3. Valentine Museum at Richmond. For providing exhibits to the public schools of Virginia.
18	4. Woodrow Wilson Birthplace Foundation, Incorporated. To aid in restoring and maintaining the

20	5. Robert E. Lee Memorial Association, Incorporated. To aid in further development of "Stratford" in
21	Westmoreland County.
22 23	6. Poe Foundation, Incorporated. To aid in maintaining the Poe Shrine at Richmond. 7. Patrick Henry Memorial Foundation at Brookneal. To aid in maintaining home.
23 24	8. Hanover County Branch, Association for the Preservation of Virginia Antiquities. To aid in
25	maintaining the Patrick Henry home at "Scotchtown" in Hanover County.
26	9. Historic Lexington Foundation. To aid in restoration and maintenance of the Stonewall Jackson
27 28	home at Lexington. 10. "Oatlands," Incorporated. To aid in maintaining "Oatlands" in Loudoun County.
2 9	11. Montgomery County Branch, Association for the Preservation of Virginia Antiquities. To aid in
30	maintaining Smithfield Plantation House.
31	12. The Last Capitol of the Confederacy. For the preservation of the Last Capitol of the Confederacy
32 33	in Danville.
33 34	13. Association for the Preservation of Virginia Antiquities. For assistance in maintaining certain historic landmarks throughout the Commonwealth.
35	14. The Corporation for Jefferson's "Poplar Forest." To aid in restoring, maintaining, and operating
36	"Poplar Forest," Thomas Jefferson's Bedford County home.
37 38	15. Belle Grove, Incorporated. To aid in providing educational programs for Virginia students.
30 39	16. George Washington Boyhood Home Foundation. To aid in the restoration and perpetuation of "Ferry Farm," George Washington's boyhood home.
40	17. Montpelier National Trust for Historic Preservation. To aid in restoring, maintaining, and
41	operating Montpelier, the lifelong home of President James Madison, in Orange County.
42	18. Eastern Shore of Virginia Historical Society. To aid in restoring, maintaining and operating Kerr
43 44	Place in Accomack County. 19. New Town Improvement and Civic Club, Inc. To aid in restoring, maintaining and operating
45	Little England Chapel, a landmark to Hampton's first generation of freedmen, in the City of Hampton.
46	20. Woodlawn Plantation. To aid in the preservation and maintenance of Woodlawn Plantation.
47	21. Friends of Historic Huntley. To support the research and preservation of Historic Huntley
48 49	Mansion. 22. Historic Gordonsville, Inc., the owner of the Gordonsville Exchange Hotel. To aid in maintaining
50	the Gordonsville Exchange Hotel and in providing educational programs for Virginia's students.
51	B. Organizations receiving state funds as provided for in this section shall certify to the satisfaction
52	of the Department that matching funds from local or private sources are available in an amount at least
53 54	equal to the amount of the request in cash or in kind contributions which are deemed acceptable to the
54 55	Department. C. Requests for funding of historical societies or like organizations as set forth in subsection A, shall
56	be considered by the Governor and the General Assembly only in even-numbered years.
