That the Code of Virginia is amended by adding sections numbered 58.1-3650.650 through 8 58.1-3650.665 as follows: 9 § 58.1-3650.650. Property of Rapidan Habitat for Humanity, Inc. 10 A. Rapidan Habitat for Humanity, Inc., a nonprofit organization, is hereby designated as a benevolent organization within the context of Section 6 (a) (6) of Article X of the Constitution of 11 12 Virginia. 13 B. Property located in Orange County, owned by Rapidan Habitat for Humanity, Inc., and used by it exclusively for benevolent purposes on a nonprofit basis as set forth in subsection A of this section, is 14 15 hereby determined to be exempt from local taxation. § 58.1-3650.651. Property of Our Lady of Hope Health Center, Inc. 16 17 A. Our Lady of Hope Health Center, Inc., a nonprofit corporation, is hereby designated as a 18 charitable and benevolent organization within the context of Section 6 (a) (6) of Article X of the 19 Constitution of Virginia. 20 B. Property located in Henrico County, owned by Our Lady of Hope Health Center, Inc., and used 21 by it exclusively for charitable and benevolent purposes on a nonprofit basis as set forth in subsection A 22 of this section, is hereby determined to be exempt from local taxation. 23 § 58.1-3650.652. Property of Family Life Services of Southern Virginia, Inc. 24 A. Family Life Services of Southern Virginia, Inc., a nonprofit corporation, is hereby designated as a 25 charitable and benevolent organization within the context of Section 6 (a) (6) of Article X of the 26 Constitution of Virginia. 27 B. Property located in the City of Danville, owned by Family Life Services of Southern Virginia, Inc., 28 and used by it exclusively for charitable and benevolent purposes on a nonprofit basis as set forth in 29 subsection A of this section, is hereby determined to be exempt from local taxation. 30 § 58.1-3650.653. Property of Appalachian Educational Communications Corporation. 31 A. The Appalachian Educational Communications Corporation, a nonprofit corporation, is hereby 32 designated as a charitable organization within the context of Section 6 (a) (6) of Article X of the 33 Constitution of Virginia. 34 B. Property located at 703 State Street in the City of Bristol, owned by the Appalachian Educational 35 Communications Corporation and used by it exclusively for charitable purposes on a nonprofit basis as 36 set forth in subsection A of this section, is hereby determined to be exempt from local taxation. 37 § 58.1-3650.654. Property of Mid-Atlantic Teen Challenge, Inc. 38 A. Mid-Atlantic Teen Challenge, Inc., a nonprofit organization, is hereby designated as a religious 39 organization within the context of Section 6 (a) (6) of Article X of the Constitution of Virginia. 40 B. Property located at 9302 Warwick Boulevard in the City of Newport News, owned by Mid-Atlantic 41 Teen Challenge, Inc., and used by it exclusively for religious purposes on a nonprofit basis as set forth 42 in subsection A of this section, is hereby determined to be exempt from local taxation. 43 § 58.1-3650.655. Property of Virginia Peninsula Shelter for Abused Children, Inc., t/a Safehaven. 44 A. Virginia Peninsula Shelter for Abused Children, Inc., t/a Safehaven, a nonprofit corporation, is 45 hereby designated as a charitable and benevolent organization within the context of Section 6 (a) (6) of Article X of the Constitution of Virginia.B. Property located at 12749 Nettles Drive in the City of Newport News, owned by Virginia 46 47 48 Peninsula Shelter for Abused Children, Inc., t/a Safehaven, and used by it exclusively for charitable and 49 benevolent purposes on a nonprofit basis as set forth in subsection A of this section, is hereby 50 determined to be exempt from local taxation. § 58.1-3650.656. Property of Triad Foundation, Inc. 51 52 A. Triad Foundation, Inc., a nonprofit corporation, is hereby designated as a religious, educational, 53 scientific, charitable and benevolent organization within the context of Section 6 (a) (6) of Article X of 54 the Constitution of Virginia.

55 B. Property located at 318 34th St., 332 34th St. and 3305 Warwick Boulevard in the City of 56 Newport News, owned by Triad Foundation, Inc., and used by it exclusively for religious, educational,

57 scientific, charitable and benevolent purposes on a nonprofit basis as set forth in subsection A of this 58 section, is hereby determined to be exempt from local taxation.

59 § 58.1-3650.657. Property of Jefferson Area Board for the Aging, Inc.

60 A. Jefferson Area Board for the Aging, Inc., a nonprofit organization, is hereby designated as a 61 charitable organization within the context of Section 6 (a) (6) of Article X of the Constitution of 62 Virginia.

63 B. Property containing 3.489 acres, with future improvements thereon, designated as Lot 2, 64 Branchlands, and more particularly described as tax map parcel number 61z-03-07, located on Hillside Drive in the County of Albemarle, owned by Jefferson Area Board for the Aging, Inc., and used by it 65 66 exclusively for charitable purposes on a nonprofit basis as set forth in subsection A of this section, is 67 hereby determined to be exempt from local taxation. 68

§ 58.1-3650.658. Property of Habitat for Humanity in the Roanoke Valley, Inc.

69 A. Habitat for Humanity in the Roanoke Valley, Inc., a nonprofit corporation, is hereby designated 70 as a charitable or benevolent organization within the context of Section 6 (a) (6) of Article X of the 71 Constitution of Virginia.

72 B. Property located in the City of Roanoke, owned by Habitat for Humanity in the Roanoke Valley, 73 Inc., and used by it exclusively for charitable or benevolent purposes on a nonprofit basis as set forth in 74 subsection A of this section, is hereby determined to be exempt from local taxation.

75 § 58.1-3650.659. Property of Crisis Pregnancy Center of Roanoke Valley, Inc.

76 A. The Crisis Pregnancy Center of Roanoke Valley, Inc., a nonprofit organization, is hereby 77 designated as a charitable or benevolent organization within the context of Section 6 (a) (6) of Article X78 of the Constitution of Virginia.

79 B. Property located in the City of Roanoke, owned by the Crisis Pregnancy Center of Roanoke Valley, Inc., and used by it exclusively for charitable or benevolent purposes on a nonprofit basis as set 80 forth in subsection A of this section, is hereby determined to be exempt from local taxation. 81 82

83 A. Richmond Metropolitan Habitat for Humanity, Inc., a nonprofit organization, is hereby designated as a charitable organization within the context of Section 6 (a) (6) of Article X of the Constitution of 84 85 Virginia.

B. Effective January 1, 1996, property located in Henrico County, owned by Richmond Metropolitan 86 Habitat for Humanity, Inc., and used by it exclusively for charitable purposes on a nonprofit basis as 87 88 set forth in subsection A of this section, is hereby determined to be exempt from local taxation.

89 § 58.1-3650.661. Property of St. Chivas Corporation.

90 A. St. Chivas Corporation, a nonprofit organization, is hereby designated as a charitable and 91 benevolent organization within the context of Section 6 (a) (6) of Article X of the Constitution of 92 Virginia.

93 B. Property located in the County of Tazewell, owned by St. Chivas Corporation and used by it 94 exclusively for charitable and benevolent purposes on a nonprofit basis as set forth in subsection A of 95 this section, is hereby determined to be exempt from local taxation. 96

97 A. Pathway Visions, Inc., a nonprofit organization, is hereby designated as a charitable and 98 benevolent organization within the context of Section 6 (a) (6) of Article X of the Constitution of 99 Virginia.

Property located in the City of Fairfax and property located in Fairfax County, owned by Pathway Visions, Inc., and used by it exclusively for charitable and benevolent purposes on a nonprofit 101 102 basis as set forth in subsection A of this section, is hereby determined to be exempt from local taxation. 103

Property located in Louisa County and in the Town of Louisa, owned by the Louisa County 108 Library Foundation and used by it exclusively for benevolent and cultural purposes on a nonprofit basis 109 as set forth in subsection A of this section, is hereby determined to be exempt from local taxation.
