SENATE BILL NO. 354

AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the House Committee on General Laws

on February 21, 1996)

(Patron Prior to Substitute—Senator Norment)

A BILL to amend and reenact § 2.1-341 of the Code of Virginia, relating to Virginia Freedom of Information Act definitions.

Be it enacted by the General Assembly of Virginia:

1. That § 2.1-341 of the Code of Virginia is amended and reenacted as follows:

§ 2.1-341. Definitions.

11 The following terms, whenever used or referred to in this chapter, shall have the following meanings, unless a different meaning clearly appears from the context: 12

"Criminal incident information" means a general description of the criminal activity reported, the date 13 and general location the alleged crime was committed, the identity of the investigating officer, and a 14 15 general description of any injuries suffered or property damaged or stolen; however, the identity of any victim, witness, undercover officer, or investigative techniques or procedures need not but may be 16 17 disclosed unless disclosure is prohibited or restricted under § 19.2-11.2. The identity of any individual providing information about a crime or criminal activity under a promise of anonymity shall not be 18 19 disclosed. 20

"Executive meeting" or "closed meeting" means a meeting from which the public is excluded. "Meeting" or "meetings" means the meetings including work sessions, when sitting physically, or 21 22 through telephonic or video equipment pursuant to § 2.1-343.1, as a body or entity, or as an informal 23 assemblage of (i) as many as three members, or (ii) a quorum, if less than three, of the constituent 24 membership, wherever held, with or without minutes being taken, whether or not votes are cast, of any 25 public body, including any legislative body, authority, board, bureau, commission, district or agency of the Commonwealth or of any political subdivision of the Commonwealth, including cities, towns and 26 27 counties; municipal councils, governing bodies of counties, school boards and planning commissions; 28 boards of visitors of state institutions of higher education; and other organizations, corporations or 29 agencies in the Commonwealth, supported wholly or principally by public funds. The notice provisions 30 of this chapter shall not apply to the said informal meetings or gatherings of the members of the 31 General Assembly. Nothing in this chapter shall be construed to make unlawful the gathering or 32 attendance of two or more members of a *public* body or entity (i) at any place or function where no part 33 of the purpose of such gathering or attendance is the discussion or transaction of any public business, 34 and such gathering or attendance was not called or prearranged with any purpose of discussing or 35 transacting any business of the public body or entity or (ii) at a public forum whose purpose is to 36 inform the electorate and not to transact public business or to hold discussions relating to the transaction of public business, even though the performance of the members individually or collectively 37 38 in the conduct of public business may be a topic of discussion or debate at such forum. The gathering of employees of a public body shall not be deemed a "meeting" subject to the provisions of this chapter. 39 40 No meeting shall be conducted through telephonic, video, electronic or other communication means 41 where the members are not physically assembled to discuss or transact public business, except as provided in § 2.1-343.1 or as may specifically be provided in Title 54.1 for the summary suspension of 42

professional licenses.

44 "Official records" means all written or printed books, papers, letters, documents, maps and tapes, photographs, films, sound recordings, reports or other material, regardless of physical form or 45 characteristics, prepared, owned, or in the possession of a public body or any employee or officer of a 46 47 public body in the transaction of public business.

"Open meeting" or "public meeting" means a meeting at which the public may be present.

49 "Public body" means any of the groups, agencies or organizations enumerated in the definition of 50 "meeting" as provided in this section, including any committees or subcommittees of the public body 51 created to perform delegated functions of the public body or to advise the public body. Corporations organized by the Virginia Retirement System, RF&P Corporation and its wholly owned subsidiaries also 52 53 are "public bodies" for purposes of this chapter.

54 "Scholastic records" means those records, files, documents, and other materials containing information about a student and maintained by a public body which is an educational agency or 55 institution or by a person acting for such agency or institution, but, for the purpose of access by a 56 57 student, does not include (i) financial records of a parent or guardian nor (ii) records of instructional, supervisory, and administrative personnel and educational personnel ancillary thereto, which are in the 58 59 sole possession of the maker thereof and which are not accessible or revealed to any other person except
