- CHAPTER 46. VIRGINIA INFORMATION PROVIDERS NETWORK AUTHORITY ACT.
- 120 § 9-350. Definitions.
- 121 As used in this chapter, unless the context clearly indicates otherwise:

122 "Authority" means the Virginia Information Providers Network Authority, a political subdivision of 123 the Commonwealth created by this chapter.

124 "Board" means the board of directors of the Authority.

125 "Gateway" means any centralized electronic information system by which public information shall be 126 provided via dial-in modem or continuous link to the public through subscription or through public 127 libraries.

128 "Public information" means any information created, acquired, or stored in electronic, magnetic, 129 optical or magneto-optical form by state agencies which is included within the information deemed to be 130 public pursuant to the Virginia Freedom of Information Act (§ 2.1-340 et sea.) or the Virginia Public 131 Records Act (§ 42.1-76 et seq.).

132 "State agency" means any agency, institution, board, bureau, commission, council, or instrumentality 133 of state government.

134 "User association" means an association of users of information through a gateway. 135

§ 9-351. Declaration of purpose; Authority established.

136 The General Assembly determines that there exists in the Commonwealth a need to provide for the 137 centralized marketing, provision, leasing or executing of license agreements for access on-line or in 138 volume on such terms and conditions as may be determined to be in the best interest of the 139 Commonwealth. Therefore, a political subdivision of the Commonwealth to be known as the Virginia 140 Information Providers Network Authority is hereby created. The Authority's exercise of powers conferred 141 by this chapter shall be deemed to be the performance of an essential governmental function and 142 matters of public necessity for which public moneys may be spent and private property acquired.

143 § 9-352. Board of directors.

144 The Authority shall be governed by a board of directors consisting of eleven members, two of whom 145 shall be the Secretary of Administration and the Director of the Council on Information Management, 146 both of whom shall serve during their terms of office. The remaining nine members shall be appointed by the Governor as follows: three members who are chief executive officers of agencies in the executive 147 148 branch; two members from a list submitted by the Virginia State Bar; three members from user 149 associations of a statewide character, except that no two shall represent the same user association; and 150 one member from a list submitted by the State Librarian. Three members appointed by the Governor 151 shall be appointed for terms of one year, three for terms of two years, and three for terms of three 152 years, effective from their dates of appointment. Thereafter, board members shall be appointed for terms 153 of three years. All board members appointed by the Governor shall be confirmed by the affirmative vote 154 of a majority of those voting in each house of the General Assembly. Vacancies in board membership 155 shall be filled by appointment for the unexpired portion of the term. Board members shall be subject to 156 removal from office for cause. The board shall annually elect one of its members as chairman, one as 157 vice chairman, and another as secretary. The board may also elect other subordinate officers, who may 158 or may not be members of the board, as it deems proper. The chairman or, in his absence, the vice 159 chairman shall preside at all meetings of the board. In the absence of both the chairman and vice 160 chairman, the board shall appoint a chairman pro tempore, who shall preside at such meetings. Six 161 members shall constitute a quorum for the transaction of the Authority's business, and no vacancy in the 162 membership shall impair the right of a quorum to exercise all the rights and perform all the duties of the Authority. Pursuant to § 14.1-5, board members shall be entitled to reimbursement for their 163 164 reasonable travel, meal and lodging expenses incurred in attending board meetings or while otherwise 165 engaged in discharging their duties. Such expenses shall be paid out of the treasury of the Authority 166 upon vouchers signed by the board chairman or by such other person as the board designates for this 167 purpose. The board shall employ a network manager of the Authority, who shall serve at the pleasure of 168 the board, to direct the day-to-day operations and activities of the Authority and carry out the powers and duties conferred upon him as may be delegated to him by the board. The network manager and 169 170 employees of the Authority shall be compensated in the manner provided by the board. § 9-353. Powers and duties of the Authority.

171

172 The Authority may exercise all powers necessary or convenient for carrying out its statutory 173 purposes, including, without limitation, the power to:

174 1. Sue and be sued, implead and be impleaded, complain and defend in all courts; 175

2. Adopt, use, and alter at will a common seal;

176 3. Foster the development of a coordinated, comprehensive system for providing ready access to 177 electronic public state government information for individuals, businesses, and other entities;

178 4. Make and execute contracts, lease agreements and all other instruments necessary or convenient 179 to exercise the powers of the Authority or to further the public purpose for which the Authority is 180 created;

181 5. Acquire by purchase, lease, or otherwise and to hold, lease, and dispose of real or personal 182 property of every kind and character, or any interest therein, in furtherance of the public purpose of the

183 Authority:

184 6. Apply for and accept any gifts or grants or loan guarantees or loans of funds or property or 185 financial and other aid in any form from the federal government or any agency or instrumentality 186 thereof, or from the state or any agency or instrumentality thereof, or from any other source for any or 187 all of the purposes specified in this chapter and to comply, subject to the provisions of this chapter, with 188 the terms and conditions thereof:

189 7. Contract with state agencies or any local government for the use by the Authority of any property, 190 facilities, or services of the state or any such state agency or local government or for the use by any 191 state agency or local government of any facilities or services of the Authority; and such state agencies 192 and local governments are authorized to enter into such contracts;

193 8. Fix and collect fees and charges for public information, media, and incidental services furnished 194 by it to any private individual or entity, notwithstanding the charges set forth in 2.1-342;

195 9. Deposit or invest funds held by it in any state depository or in any investment which is authorized 196 for the investment of proceeds of state general obligation bonds, and use, redeposit, or reinvest interest 197 earned on such funds for the purposes set forth in this chapter;

198 10. Exercise any power granted by the laws of the Commonwealth not in conflict with the public 199 purpose of the Authority; and

200 11. Make rules and regulations for its own governance.

§ 9-354. Network manager: duties.

202 The network manager shall (i) direct and supervise the day-to-day operations and expansion of the 203 gateway and network, including the initial phase of operations necessary to make such gateway 204 operational; (ii) attend meetings of the Authority; (iii) keep a record of all gateway, network and related 205 operations of the Authority, which shall be the property of the Authority; (iv) maintain and be custodian of all financial and operational records, documents, and papers filed with the Authority; and (v) update 206 207 and revise annually the business plan of the Authority, in consultation with and under the direction of 208 the Authority's board of directors. 209

§ 9-355. Access to public information of state agencies.

210 A. All state agencies may make available to the Authority access to public information upon terms 211 mutually agreed upon by the Authority and any such state agency.

212 B. The Authority shall reimburse the state agency for costs incurred to provide such access to the 213 Authority. The terms of the agreement between the Authority and state agency shall provide, inter alia, 214 that the Authority shall retain from the proceeds from providing access to public information only an 215 agreed-upon amount sufficient to cover an appropriate share of the expenses incurred by the Authority 216 in accomplishing the purposes set forth in this chapter. If the state agency is the Department of Motor 217 Vehicles, such agreements shall provide that the balance of the proceeds from the sale or licensing of 218 such public information shall be distributed to such state agency. For any other state agency, such 219 agreements shall provide that one-half of the balance of the proceeds shall be distributed to the state 220 agency and the other one-half of the balance of the proceeds shall be distributed to the general fund of 221 the state treasury.

222 § 9-356. Access to public information; receipt of information; application of statutory restrictions on 223 confidentiality to Authority.

224 A. The Authority may provide electronic access to public information provided to it by any state 225 agency and to the extent provided in the agreement with the providing agency. The Authority shall 226 explore ways and means of expanding the amount and kind of public information provided, increasing 227 the utility of the public information provided and the form in which it is provided, expanding the base of 228 users who access such public information and, where appropriate, implementing changes.

229 B. The Authority shall be authorized to execute license agreements which provide access to public 230 information in any electronic medium or format. However, any licensing agreement executed by the 231 Authority shall contain language or terms that prohibit the disclosure of information that reveals or 232 reasonably could be expected to reveal the identity of any individual who is a data subject. Further, 233 information subject to any such licensing agreement shall be designed to prevent persons from 234 combining data elements to reveal the identity of individual data subjects. For the purposes of this 235 subsection, "data subject" and "personal information" mean the same as those terms are defined in 236 § 2.1-379. Nothing contained in this chapter shall preclude any state agency from providing access to 237 public information to the public or other government agencies or entities, or from disseminating any 238 public information to which the Authority does not provide access.

239 C. The Authority may be authorized by the judicial and legislative branches to execute license 240 agreements which provide access to public information in any electronic medium or format on their 241 behalf. However, nothing in this chapter shall be construed to affect or pertain to records originating 242 from or under the control of the clerks of the circuit courts of the Commonwealth except upon terms 243 mutually agreed upon by the Authority, any state agency that may be holding such records for archival 244 purposes, and the clerk's office where such records originated.

245 D. The Authority may receive public information in electronic format from members of the public for 246 the purpose of transmitting such public information electronically to state agencies.

247 E. In circumstances where official records subject to the Virginia Freedom of Information Act 248 (§ 2.1-340 et seq.) are furnished to the Authority by any state agency and such records are no longer 249 available from such agency, the Authority, as custodian of such records, shall be subject to requests for such records made pursuant to the Freedom of Information Act. All statutory provisions governing 250 251 public or official records, including, but not limited to, the Freedom of Information Act (§ 2.1-340 et 252 seq.), the Privacy Protection Act of 1976 (§ 2.1-377 et seq.), and the Virginia Public Records Act 253 (§ 42.1-76 et seq.), and all penalties for any violation thereof shall apply to the Authority and its 254 employees. Nothing in this chapter shall relieve any public body, including the Authority, of any duty 255 imposed by such statutory provisions governing public or official records, nor shall this chapter be 256 construed to authorize or encourage the destruction or deletion of such records by public bodies.

257 § 9-357. Exemption from taxes.

258 The exercise of the powers granted by this chapter shall be in all respects for the benefit of the 259 people of the Commonwealth. As the operation of the Authority and the undertaking of activities in the 260 furtherance of the purposes of the Authority shall constitute performance of essential governmental 261 functions, the Authority shall not be required to pay any taxes upon the income therefrom, including 262 sales and use taxes on the tangible personal property used in the operations of the Authority. The 263 exemption hereby granted shall not be construed to extend to persons conducting a business on the 264 premises of the facility for which local or state taxes would otherwise be required.

265 § 9-358. Ownership of public information not affected.

266 Nothing in this chapter shall be deemed to effect a transfer of ownership of any public information 267 from any state agency to the Authority.

268 § 9-359. Financing and operations; Virginia Information Providers Network Fund established.

269 A. Initial funding for start-up costs incurred by the Authority shall be obtained from private 270 donations. No state funds shall be used for any Authority purpose.

271 B. The Authority shall fund its operations from revenues generated from providing access to public 272 information, and from money, goods or in-kind services donated to the Authority by private sources.

273 C. There is hereby established a special fund in the state treasury to be known as the Virginia 274 Information Providers Network Fund, hereinafter referred to as "the Fund." All moneys received by the 275 Authority, including revenues generated from providing access to public information, and any gifts, 276 donations, grants, or other contributions from any source, public or private, shall be deposited in the 277 Fund. Expenses incurred by the Authority in accomplishing its purposes set forth in this chapter, as 278 determined by the Board, shall be paid out of the Fund on warrant of the Comptroller. The Comptroller 279 shall transfer the balance of the moneys in the Fund to the appropriate state agency or to the general 280 fund, as required by the terms of the agreements between state agencies and the Authority pursuant to 281 § 9-355, no later than June 30 of each year. 282

§ 9-360. Exemption of Authority from personnel and procurement procedures.

283 The provisions of Chapter 10 (§ 2.1-110 et seq.) of Title 2.1 and Chapter 7 (§ 11-35 et seq.) of Title 284 11 of the Code of Virginia shall not apply to the Authority in the exercise of any power conferred under 285 this chapter. 286

§ 9-361. Forms of accounts and records; audit; annual report.

287 The accounts and records of the Authority showing the receipt and disbursement of funds from 288 whatever source derived, shall be in such form as the Auditor of Public Accounts prescribes. The 289 Auditor of Public Accounts, or his legally authorized representatives, shall annually examine the 290 accounts and books of the Authority. The Authority shall submit an annual report to the Governor and 291 General Assembly on or before November 1 of each year. Such report shall contain the audited annual 292 financial statements of the Authority for the year ending the preceding June 30. The annual report shall 293 be distributed in accordance with the provisions of § 2.1-467.
