6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 62.1-44.15:4 of the Code of Virginia is amended and reenacted as follows:**

8 § 62.1-44.15:4. Notification of local government.

9 A. Upon determining that there has been a violation of a regulation promulgated under this chapter
10 and such violation poses an imminent threat to the health, safety or welfare of the public, the Executive
11 Director shall immediately notify the chief administrative officer of any potentially affected local
12 government. Neither the Executive Director, the Commonwealth, nor any employee of the
13 Commonwealth shall be liable for a failure to provide, or a delay in providing, the notification required
14 by this ~~section~~ subsection.

15 B. Upon receiving a nomination of a waterway or segment of a waterway for designation as an
16 exceptional state water pursuant to the Board's antidegradation policy, as required by 40 C.F.R.
17 § 131.12, the Board shall notify each locality in which the waterway or segment lies and shall provide
18 notice to impacted property owners. The written notice shall include, at a minimum: (i) a description of
19 the location of the waterway or segment; (ii) the procedures and criteria for designation as well as the
20 impact of designation; (iii) the name of the person making the nomination; and (iv) the name of a
21 contact person at the Department of Environmental Quality who is knowledgeable about the nomination
22 and the waterway or segment. After receipt of the notice of the nomination localities shall be provided
23 sixty days to comment on the consistency of the nomination with the locality's comprehensive plan.

24 C. Upon determining that a waterway or any segment of a waterway does not meet its water quality
25 standard use designation as set out in the Board's regulations and as required by § 1313 (d) of the
26 federal Clean Water Act (33 U.S.C. § 1251 et seq.) and 40 C.F.R. § 130.7 (b), the Board shall notify
27 each locality in which the waterway or segment lies. The written notification shall include, at a
28 minimum: (i) a description of the reasons the waters do not meet the water quality standard including
29 specific parameters and criteria not met; (ii) a layman's description of the location of the waters; (iii)
30 the known sources of the pollution; and (iv) the name of a contact person at the Department of
31 Environmental Quality who is knowledgeable about the failure of the waterway or segment to meet the
32 standards. After receipt of the notification, local governments shall have thirty days to comment.

33 D. Upon receipt of an application for a permit or for a modification of a permit, the Board shall
34 cause to be notified, in writing, the locality wherein the discharge does or is proposed to take place of,
35 at a minimum: (i) the name of the applicant; (ii) the nature of the application and proposed discharge;
36 and (iii) upon request, any other information known to, or in the possession of, the Board or the
37 Department regarding the applicant not required to be held confidential by this chapter.

38 E. The comment periods established in subsections B and C shall in no way impact a locality's
39 ability to comment during any additional comment periods established by the Board.
