Article 4.

Division of Forensic Science.

192 § 9-196.1. Division of Forensic Science.

193 There is hereby established within the Department of Criminal Justice Services, a Division of 194 Forensic Science, which heretofore existed as a division within the Department of General Services. The 195 Division shall be headed by a Director. It shall be the responsibility of the Division to provide forensic 196 laboratory services upon request of the Superintendent of State Police; the Chief Medical Examiner, the Assistant Chief Medical Examiners, and local medical examiners; any attorney for the Commonwealth; 197 198 any chief of police, sheriff, or sergeant responsible for law enforcement in the jurisdiction served by 199 him; any local fire department; or any state agency in any criminal matter. The Division may provide 200 such services to any federal investigatory agency within available resources.

201 The Division shall provide forensic laboratory services to all law-enforcement agencies throughout 202 the Commonwealth and provide laboratory services, research, and scientific investigations for agencies of the Commonwealth as needed. In addition, the Division shall establish a DNA testing program in 203 accordance with Article 1.1 (§ 19.2-310.2 et seq.) of Chapter 18 of Title 19.2 to determine identification 204 205 characteristics specific to an individual. 206

§ 9-196.2. Forensic Science Advisory Board.

The Forensic Science Advisory Board is hereby created and shall be referred to in this article as the 207 208 Board. The Board shall consist of the following members: (i) five members, appointed by the Governor to serve at his pleasure for a term coincident with that of the Governor, one of whom shall be a circuit 209 210 court judge, one of whom shall be a representative of the Virginia Association of Chiefs of Police, one of whom shall be a representative of the attorneys for the Commonwealth, and one of whom shall be a 211 212 member of the Virginia State Sheriffs' Association; (ii) the Superintendent of the Department of State Police or his designee; (iii) the Director of the Department of Criminal Justice Services or his designee; 213 214 (iv) the Director of the Virginia State Crime Commission or his designee; (v) the Chief Medical 215 Examiner or his designee; and (vi) the Executive Director of the Virginia Board of Pharmacy or his 216 designee. The Board shall elect its chairman and vice chairman. Members of the Board shall receive no compensation for their services as members of the Board. The Board shall meet at the call of the 217 chairman or Director of the Department of Criminal Justice Services. 218 219

§ 9-196.3. Functions of Board.

A. The Board may review laboratory operations of the Division and make recommendations 220 221 concerning the quality of services furnished to user agencies.

222 B. The Board shall review and make recommendations to the Director of the Department of Criminal 223 Justice Services or his designee on the following:

224 1. New major programs and plans for activities of the Division and elimination of programs no 225 longer needed; 226

2. Policy and priorities in response to agency needs;

3. General fund biennium operational budget and any major changes in appropriated funds;

228 4. Actions to foster and promote coordination and cooperation between the Division and the user 229 programs which are served; and 230

5. Rules and regulations to carry out the purposes and intent of this article.

§ 9-196.4. Forensic Science Academy.

232 The Forensic Science Academy, which previously operated as a function of the Department of 233 General Services, is hereby transferred to the Division of Forensic Science within the Department of 234 Criminal Justice Services. It shall be the function of the Academy to provide advanced training to 235 law-enforcement agencies in the location, collection, and preservation of evidence. 236

§ 9-196.5. Division of Forensic Science to be isolated.

237 The Division of Forensic Science shall be isolated within the Department of Criminal Justice 238 Services as much as necessary to ensure the protection of evidence and to ensure that its services are performed by skilled professionals who are qualified to testify in court regarding such services. 239 240

§ 9-196.6. Security and protection of evidence, etc.

241 The Division shall provide for security and protection of evidence, official samples, and all other samples submitted to the Division for analysis or examination. 242

243 § 9-196.7. Special conservators of the peace.

Upon application of the Director of the Division of Forensic Science, the Circuit Court of the City of 244

245 Richmond may appoint security personnel employed by the Division as special conservators of the 246 peace, who shall exercise the powers and functions of conservators of the peace throughout the 247 Commonwealth for the time specified in the order of appointment, while in the performance of their 248 official duties as security personnel. Such appointments as special conservators of the peace shall 249 terminate upon the order of the Division or upon the termination of employment as security personnel of 250 the Division. The circuit court shall be notified forthwith by the Division whenever an appointment is 251 terminated.

252 § 9-196.8. Disposal of certain hazardous materials.

253 Any material which is seized in any criminal investigation and which is deemed to be hazardous to 254 health and safety, may be disposed of upon written application of the Division of Forensic Science to 255 the attorney for the Commonwealth in the city or county where the material is seized or where any criminal prosecution in which such material is proposed to be evidence is pending. Upon receipt thereof, the attorney for the Commonwealth shall file the application in the circuit court of such county 256 257 258 or city. A sworn analysis report signed by a person designated by the Director of the Division of 259 Forensic Science shall accompany the application for disposal and shall clearly identify and designate 260 the material to be disposed of. The application shall state the nature of the hazardous materials, the 261 quantity thereof, the location where seized, the person or persons from whom the materials were seized, and the manner whereby such materials shall be destroyed. When the ownership of the hazardous 262 263 material is known, notice shall be given to the owner thereof at least three days prior to any hearing 264 relating to the destruction, and, if any criminal charge is pending in any court as a result of such 265 seizure, such notice shall be given to the accused if other than the owner. Upon receipt of the analysis 266 report and the application, the court may order the destruction of all, or a part of, such material; however, a sufficient and representative quantity of such material shall be retained to permit an 267 268 independent analysis when a criminal prosecution may result from such seizure. A return under oath, 269 reporting the time, place, and manner of destruction, shall be made to the courts. Copies of the analysis 270 report, application, order, and return shall be made a part of the record of any criminal prosecution. 271 The sworn analysis report shall be admissible as evidence to the same extent as the disposed-of material 272 would have been admissible. 273

§ 9-196.9. Disposal of certain other property.

274 Personal property, including drugs, not subject to be disposed of under § 2.1-434.8, which has been 275 submitted to the Division of Forensic Science or the former Bureau of Forensic Science for analysis or 276 examination and which has not been reclaimed by the agency submitting such property for analysis or 277 examination, may be disposed of by the Division in accordance with this section if, after the expiration 278 of 120 days after the receipt by the Division of the property, the Director notifies the circuit court of the 279 county or city from which the property was taken, in writing, that the analysis or examination has been 280 completed, and a report submitted to the agency that the property has not been reclaimed by the agency 281 submitting it and that the Division proposes to dispose of such property. The notice shall state the nature of the property, the quantity thereof, the location where seized, the name of the accused, if 282 283 known, and the proposed method of disposing of the property. When the ownership of the property is known, a copy of such notice shall be sent simultaneously with the notice to the court to the owner, or, 284 285 if any criminal charge is pending in any court relating to the property, the copy shall be sent to the 286 accused at his last known address. Notice shall be by certified mail. The court, within thirty days after 287 receipt of the notice, may direct that the property be disposed of by the Division, by an alternative method designed to preserve the property, at the expense of the agency submitting the property to the 288 289 Division. If the court does not so direct within such thirty-day period, then the Division may dispose of the property by the method set out in the notice. Copies of the analysis report and notice shall be made 290 291 a part of the record of any criminal prosecution. The report, if sworn to, shall be admissible as 292 evidence to the same extent as the disposed-of property would have been admissible. 293

§ 9-196.10. Disposal of property obtained prior to January 1, 1974.

294 Notwithstanding the provisions of §§ 2.1-434.8 and 2.1-434.9, the Division of Forensic Science may 295 file an application in the Circuit Court of the City of Richmond seeking an order authorizing the 296 disposal of all personal property, including drugs, received by the Division prior to January 1, 1974. 297 The application, under oath, shall list each item of property, the date of submission to the Division, the 298 agency or individual submitting the property, and the proposed method of disposal. The application 299 shall also state that written notice by first-class mail was given to each agency or individual submitting 300 property listed at least thirty days prior to the application, and that no agency or individual objected to 301 the disposal. A return, under oath, reporting the time, place, and manner of disposal, shall be made to 302 the court.

303 § 9-196.11. Rights of accused person or his attorney to results of investigation or to investigation.

304 Upon the request of any person accused of a crime or upon the request of an accused person's 305 attorney, the Division of Forensic Science or the Division of Consolidated Laboratory Services shall 324

306 furnish to the accused or his attorney the results of any investigation which has been conducted by it 307 and which is related in any way to a crime for which such person is accused. In any case in which an 308 attorney of record for a person accused of violation of any criminal law of the Commonwealth, or the 309 accused, may desire a scientific investigation, he shall, by motion filed before the court in which the 310 charge is pending, certify that in good faith he believes that a scientific investigation may be relevant to 311 the criminal charge. The motion shall be heard ex parte as soon as practicable, and the court shall, 312 after a hearing upon the motion and being satisfied as to the correctness of the certification, order that the same be performed by the Division of Forensic Science or the Division of Consolidated Laboratory 313 Services and shall prescribe in its order the method of custody, transfer, and return of evidence submitted for scientific investigation. Upon the request of the attorney for the Commonwealth of the jurisdiction in which the charge is pending, he shall be furnished the results of the scientific 314 315 316 317 investigation.

318 § 9-196.12. Reexamination by independent experts.

319 Independent experts employed by an attorney of record for a person accused of violation of any 320 criminal law of the Commonwealth, or the accused, for the purpose of reexamination of materials previously examined in any laboratory of the Division of Forensic Science or the former Bureau of 321 322 Forensic Science, shall conduct their analyses or examinations independently of the facilities, equipment, 323 or supplies of the Division.

§ 18.2-267. Preliminary analysis of breath to determine alcoholic content of blood.

325 A. Any person who is suspected of a violation of § 18.2-266 or § 18.2-266.1 shall be entitled, if such 326 equipment is available, to have his breath analyzed to determine the probable alcoholic content of his 327 blood. The person shall also be entitled, upon request, to observe the process of analysis and to see the blood-alcohol reading on the equipment used to perform the breath test. His breath may be analyzed by 328 any police officer of the Commonwealth, or of any county, city or town, or by any member of a 329 330 sheriff's department in the normal discharge of his duties.

B. The Department of General Criminal Justice Services, Division of Forensic Science, shall 331 332 determine the proper method and equipment to be used in analyzing breath samples taken pursuant to 333 this section and shall advise the respective police and sheriff's departments of the same.

334 C. Any person who has been stopped by a police officer of the Commonwealth, or of any county, 335 city or town, or by any member of a sheriff's department and is suspected by such officer to be guilty 336 of a violation of § 18.2-266 or § 18.2-266.1, shall have the right to refuse to permit his breath to be so 337 analyzed, and his failure to permit such analysis shall not be evidence in any prosecution under 338 § 18.2-266 or § 18.2-266.1.

339 D. Whenever the breath sample analysis indicates that alcohol is present in the person's blood, the officer may charge the person with a violation of § 18.2-266 or § 18.2-266.1, or a similar ordinance of the county, city or town where the arrest is made. The person so charged shall then be subject to the 340 341 342 provisions of §§ 18.2-268.1 through 18.2-268.12, or of a similar ordinance of a county, city or town.

343 E. The results of the breath analysis shall not be admitted into evidence in any prosecution under 344 § 18.2-266 or § 18.2-266.1, the purpose of this section being to permit a preliminary analysis of the 345 alcoholic content of the blood of a person suspected of having violated the provisions of § 18.2-266 or 346 § 18.2-266.1.

F. Police officers or members of any sheriff's department shall, upon stopping any person suspected 347 348 of having violated the provisions of § 18.2-266 or § 18.2-266.1, advise the person of his rights under the 349 provisions of this section.

350 G. Nothing in this section shall be construed as limiting the provisions of §§ 18.2-268.1 through 351 18.2-268.12. 352

§ 18.2-268.9. Assurance of breath-test validity; use of test results as evidence.

353 To be capable of being considered valid as evidence in a prosecution under § 18.2-266 or 354 § 18.2-266.1, chemical analysis of a person's breath shall be performed by an individual possessing a valid license to conduct such tests, with a type of equipment and in accordance with methods approved 355 356 by the Department of General Criminal Justice Services, Division of Forensic Science. The Division 357 shall test the accuracy of the breath-testing equipment at least once every six months.

358 The Division shall establish a training program for all individuals who are to administer the breath 359 tests. The program shall include at least forty hours of instruction in the operation of the breath-test 360 equipment and the administration of such tests. Upon a person's successful completion of the training 361 program, the Division may license him to conduct breath-test analyses.

362 Any individual conducting a breath test under the provisions of § 18.2-268.2 shall issue a certificate which will indicate that the test was conducted in accordance with the Division's specifications, the 363 364 equipment on which the breath test was conducted has been tested within the past six months and has been found to be accurate, the name of the accused, that prior to administration of the test the accused 365 was advised of his right to observe the process and see the blood alcohol reading on the equipment used 366 367 to perform the breath test, the date and time the sample was taken from the accused, the sample's alcohol content, and the name of the person who examined the sample. This certificate, when attested by
the individual conducting the breath test, shall be admissible in any court in any criminal or civil
proceeding as evidence of the facts therein stated and of the results of such analysis. Any such
certificate of analysis purporting to be signed by a person authorized by the Division shall be admissible
in evidence without proof of seal or signature of the person whose name is signed to it. A copy of the
certificate shall be promptly delivered to the accused.

The officer making the arrest, or anyone with him at the time of the arrest, or anyone participating in
the arrest of the accused, if otherwise qualified to conduct such test as provided by this section, may
make the breath test or analyze the results.

\$ 19.2-310.2. Blood sample required for DNA analysis upon conviction of a felony.

Every person convicted of a felony on or after July 1, 1990, and every person convicted of a felony
offense under Article 7 (§ 18.2-61 et seq.) of Chapter 4 of Title 18.2 who was incarcerated on July 1,
1989, shall have a sample of his blood taken for DNA (deoxyribonucleic acid) analysis to determine
identification characteristics specific to the person. The analysis shall be performed by the Division of
Forensic Science, Department of General Criminal Justice Services. The identification characteristics of
the profile resulting from the DNA analysis shall be stored and maintained by the Division in a DNA
data bank and shall be made available only as provided in § 19.2-310.5.

385 After July 1, 1990, the blood sample shall be taken prior to release from custody.

Notwithstanding the provisions of § 53.1-159, any person convicted of a felony who is in custody
after July 1, 1990, shall provide a blood sample prior to his release. Every person so convicted after
July 1, 1990, who is not sentenced to a term of confinement shall provide a blood sample as a condition
of such sentence.

390 § 46.2-341.25. Preliminary analysis of breath of commercial drivers to determine alcohol content of391 blood.

A. Any person who is reasonably suspected of a violation of § 46.2-341.24 or of having any alcohol in his blood while driving or operating a commercial motor vehicle may be required by any law-enforcement officer to provide a sample of such person's breath for a preliminary screening to determine the probable alcohol content of his blood. Such person shall be entitled, upon request, to observe the process of analysis and to see the blood-alcohol reading on the equipment used to perform the breath test. Such breath may be analyzed by any police officer of the Commonwealth, or of any county, city, or town, or by any member of a sheriff's department in the normal discharge of his duties.

B. The Department of General Criminal Justice Services, Division of Forensic Science, shall
 determine the proper method and equipment to be used in analyzing breath samples taken pursuant to
 this section and shall advise the respective police and sheriff's departments of the same.

402 C. If the breath sample analysis indicates that there is alcohol present in the person's blood, or if the
403 person refuses to provide a sample of his breath for a preliminary screening, such person shall then be
404 subject to the provisions of §§ 46.2-341.26:1 through 46.2-341.26:11.

405 D. The results of a breath analysis conducted pursuant to this section shall not be admitted into
406 evidence in any prosecution under § 46.2-341.24 or § 46.2-341.31, but may be used as a basis for
407 charging a person for a violation of the provisions of § 46.2-341.24 or § 46.2-341.31.

408 E. The law-enforcement officer requiring the preliminary screening test shall advise the person of his obligations under this section and of the provisions of subsection C of this section.

410 2. That Article 2.1 (§§ 2.1-434.1 through 2.1-434.12) of Chapter 32 of Title 2.1 of the Code of 411 Virginia is repealed.

412 3. That wherever the term "Division of Forensic Science" is used in this Code, it shall be taken to 413 mean the Division of Forensic Science within the Department of Criminal Justice Services.

414 4. That the Forensic Science Advisory Board shall continue with the same membership as 415 appointed under the Department of General Services until those appointments expire.
