# VIRGINIA ACTS OF ASSEMBLY - CHAPTER

2 An Act to amend and reenact § 2.1-548.29 of the Code of Virginia and to amend the Code of Virginia by adding in Chapter 16 of Title 23 an article numbered 2, consisting of sections numbered 3 4 23-220.2, 23-220.3, and 23-220.4, relating to incentive scholarships for community college students.

### Approved

#### 7 Be it enacted by the General Assembly of Virginia:

1. That § 2.1-548.29 of the Code of Virginia is amended and reenacted and that the Code of 8 9 Virginia is amended by adding in Chapter 16 of Title 23 an article numbered 2, consisting of 10 sections numbered 23-220.2, 23-220.3, and 23-200.4, as follows:

§ 2.1-548.29. Economic development services. 11

12 It shall be the duty of the Authority to encourage, stimulate, and support the development and 13 expansion of the economy of the Commonwealth. The Authority is charged with the following duties 14 and responsibilities:

15 1. To see that there are prepared and carried out effective economic development marketing and 16 promotional programs;

2. To make available, in conjunction and cooperation with localities, chambers of commerce, 17 18 industrial authorities, and other public and private groups, to prospective new businesses basic 19 information and pertinent factors of interest and concern to such businesses;

3. To formulate, promulgate, and advance programs throughout the Commonwealth for encouraging 20 21 the location of new businesses in the Commonwealth and the retention and growth of existing 22 businesses;

23 4. To encourage and solicit private sector involvement, support, and funding for economic 24 development in the Commonwealth;

25 5. To encourage the coordination of the economic development efforts of public institutions, regions, 26 communities, and private industry and collect and maintain data on the development and utilization of 27 economic development capabilities;

28 6. To establish such offices within and without the Commonwealth that are necessary to the 29 expansion and development of industries and trade; and

30 7. To encourage the export of products and services from the Commonwealth to international 31 markets; and

32 8. Upon request, to advise the State Board for Community Colleges in designating technical training 33 programs in Virginia's comprehensive community colleges for the Community College Incentive 34 Scholarship Program pursuant to § 23-220.4. 35

### Article 2.

## Community College Incentive Scholarship Program.

§ 23-220.2. Incentive scholarships program; Board to administer; promulgation of regulations.

38 There is hereby created the Community College Incentive Scholarship Program to provide incentive 39 scholarships to eligible students attending comprehensive community colleges in Virginia. Funds may be 40 paid to any comprehensive community college on behalf of students who have been awarded such 41 scholarships pursuant to § 23-220.4. 42

§ 23-220.3. Community College Incentive Scholarship Fund created.

43 A. From such funds as are appropriated for this purpose and from such gifts, donations, grants, bequests, and other funds as may be received on its behalf, there is hereby created in the state treasury 44 a special nonreverting fund to be known as the Community College Incentive Scholarship Fund, 45 hereafter referred to as "the Fund." The Fund shall be established on the books of the Comptroller. 46 Interest earned on moneys in the Fund shall remain in the Fund and be credited to it. Any moneys 47 remaining in the Fund, including interest thereon, at the end of each fiscal year shall not revert to the 48 49 general fund but shall remain in the Fund. Funds may be paid to any comprehensive community college 50 on behalf of students who have been awarded scholarships pursuant to § 23-220.4. The first such 51 scholarships shall be awarded after July 1, 1998.

Expenditures and disbursements from the Fund shall be made by the State Treasurer on warrants 52 53 issued by the Comptroller upon written request signed by the State Board for Community Colleges.

54 B. The Board shall promulgate regulations for the implementation of the provisions of this article 55 and shall award scholarships to eligible students meeting the criteria established pursuant to § 23-220.4. 56 § 23-220.4. Eligible students; criteria for award of scholarships.

A. Only students who (i) are domiciled residents of Virginia as defined by § 23-7.4, (ii) are enrolled
as second-year students on a full-time basis in a designated technical training program at a
comprehensive community college in Virginia, and (iii) have a cumulative grade point average of at
least 3.0 on a scale of 4.0 or its equivalent upon the completion of one year as a full-time student at a
comprehensive community college in Virginia shall be eligible to receive such scholarships.

62 B. The Board, in consultation with the Virginia Economic Development Partnership, shall designate
63 those technical training programs for which scholarships may be awarded. The selected programs shall
64 reflect current and projected workforce training needs in the Commonwealth.

65 C. Scholarships awarded pursuant to this article shall provide for the payment in full of tuition and 66 fees for enrollment for one year as a full-time, second-year student.
