2 *An Act to amend and reenact § 15.1-11.3 of the Code of Virginia, relating to removal or repair of*
 3 *certain structures or vessels.*

6 **Be it enacted by the General Assembly of Virginia:**

7 **1. That § 15.1-11.3 of the Code of Virginia is amended and reenacted as follows:**

8 § 15.1-11.3. Authority to require removal, repair, etc., of wharves, piers, pilings, bulkheads, vessels
 9 or abandoned, obstructing or hazardous property; ~~civil penalty.~~

10 The governing body of any county, city or town by ordinance may provide:

11 1. That the owners of property therein shall at such time or times as the governing body may
 12 prescribe, remove, repair or secure *any vessel which has been abandoned or* any wharf, pier, piling,
 13 bulkhead or any other structure or vessel which might endanger the public health or safety of other
 14 persons, or which might constitute an obstruction or hazard to the lawful use of the waters within or
 15 adjoining such county, city or town; ~~and~~ . If such property is deemed to be abandoned, the governing
 16 body may designate and empower an official to ascertain the lawful owner of such property and to have
 17 the owner repair, remove or secure such property;

18 2. That the governing body of such county, city or town, through its own agents or employees, may
 19 remove, repair or secure *any vessel which has been abandoned or* any wharf, pier, piling, bulkhead, or
 20 other structure or vessel which might endanger the public health or safety of other persons or which
 21 might constitute a hazard or obstruction to the lawful use of the waters within such county, city or town,
 22 wherein the owner of such property, after reasonable notice and reasonable time to do so, has failed to
 23 remove, repair or secure such wharf, pier, piling, bulkhead or other structure or vessel;

24 3. That in the event the governing body of such county, city or town, through its own agents or
 25 employees removes, repairs or secures any wharf, pier, piling, bulkhead or other structure or vessel after
 26 complying with the notice provisions of this section, the cost or expenses thereof shall be chargeable to
 27 and paid by the owners of such property and to the extent applicable may be collected by the county,
 28 city or town as taxes and levies are collected;

29 4. That if the identity or whereabouts of the lawful owner is unknown or not able to be ascertained
 30 after a reasonable search and after lawful notice has been made to the last known address of any known
 31 owner, the governing body of such county, city or town through its own agents or employees, may
 32 repair such wharf, pier, piling, bulkhead or other structure or ~~boat~~ *vessel* or remove such property after
 33 giving notice by publication once each week for two weeks in a newspaper of general circulation in the
 34 area where such property is located;

35 5. That every charge authorized by this section with which the owner of any such property shall
 36 have been assessed and which remains unpaid, to the extent applicable, shall constitute a lien against
 37 ~~such the owner's real~~ property, and such lien shall be recorded in the judgment lien docket book in the
 38 circuit court of such county, city or town. Such lien may ~~also be released~~ *reduced* to a personal
 39 judgment against the owner.
