5	(Patron Prior to Substitute—Delegate Morgan)
6	A BILL to amend and reenact §§ 54.1-1128 through 54.1-1135 of the Code of Virginia, relating to the
7	Board for Contractors; regulation of tradesman; penalty.
8 9	Be it enacted by the General Assembly of Virginia: 1. That §§ 54.1-1128 through 54.1-1135 of the Code of Virginia are amended and reenacted as
9 10	follows:
11	§ 54.1-1128. Definitions.
12	"Backflow prevention device worker" means any individual who engages in, or offers to engage in,
13	the maintenance, repair, testing, or periodic inspection of cross connection control devices, including but
14	not limited to reduced pressure principle backflow preventors, double check-valve assemblies,
15	double-detector check-valve assemblies, pressure type vacuum breaker assemblies, and other such
16	devices designed, installed, and maintained in such a manner so as to prevent the contamination of the
17	potable water supply by the introduction of nonpotable liquids, solids, or gases, thus ensuring that the
18	potable water supply remains unaltered and free from impurities, odor, discoloration, bacteria, and other
19 20	contaminants which would make the potable water supply unfit or unsafe for consumption and use. "Board" means the Board for Contractors.
20 21	"Liquefied petroleum gas fitter" means any individual who engages in, or offers to engage in, work
$\frac{21}{22}$	for the general public for compensation in work that includes the installation, repair, improvement,
23	alterations or removal of piping, liquefied petroleum gas tanks and appliances (excluding hot water
24	heaters, boilers and central heating systems which require a heating, ventilation and air conditioning or
25	plumbing certification) annexed to real property.
26	"Tradesman" means any individual who engages in, or offers to engage in, work for the general
27	public for compensation in the trades of electrical, plumbing and heating, ventilation and air
28	conditioning.
29 30	§ 54.1-1129. Necessity for certification. A. Beginning July 1, 1995, no individual shall engage in, or offer to engage in, work as a tradesman
30 31	as defined in § 54.1-1128 unless he has been certified under the provisions of this article. Individuals
32	shall not be subject to tradesman certification when working under the supervision of a tradesman who
33	is certified in the specialty for which work is being performed. Individuals holding a certification in one
34	specialty shall not be required to have a tradesman certification in another specialty when performing
35	work which is incidental to work being performed under their own specialty certification.
36	B. Beginning July 1, 1998, no individual shall engage in, or offer to engage in, work as a backflow
37	prevention device worker as defined in § 54.1-1128 unless he has been certified under the provisions of
38	this article. Individuals certified as backflow prevention device workers shall not be required to hold any
39 40	other professional or occupational license or certification; however, nothing in this subsection shall prohibit an individual from holding more than one professional or occupational license or certification.
41	C. Beginning July 1,1999, no individual shall engage in, or offer to engage in, work as a liquefied
42	petroleum gas fitter as defined in § 54.1-1128 unless he has been licensed under the provisions of this
43	article.
44	§ 54.1-1130. Application for certification or license; fees; examinations; issuance.
45	Any individual desiring to be certified as a tradesman or backflow prevention device worker, or
46	licensed as a liquefied petroleum gas fitter shall file a written application on a form prescribed by the
47	Board. The application shall be accompanied by a fee set by the Board pursuant to § 54.1-201. The
48 49	application shall contain, <i>at a minimum</i> , the applicant's name, place of employment, and business address; information on the knowledge, skills, abilities and education or training of the applicant; and an
49 50	affidavit stating that the information on the application is correct.
50 51	If the application is satisfactory to the Board, the applicant shall be required by Board regulations to
52	take an oral or written examination to determine his general knowledge of the trade in which he desires
53	certification or licensure or of backflow prevention devices unless he is exempt pursuant to § 54.1-1131.
54	If the applicant successfully completes the examination, certification as a tradesman or backflow
55	prevention device worker or licensure as a liquefied petroleum gas fitter shall be issued.
56	§ 54.1-1131. Exemptions.
57	A. An individual certified or licensed by any one of the following agencies shall not be required to

A. An individual certified or licensed by any one of the following agencies shall r fulfill the examination requirement specified in § 54.1-1130 for tradesman certification:
1. The Board of Housing and Community Development prior to July 1, 1995. 58 59

60 2. Any local governing body prior to July 1, 1978.

3. An apprenticeship program which is approved by the Virginia Apprenticeship Council. 61

Individuals applying for tradesman certification between July 1, 1995, and July 1, 1998, shall be 62 63 deemed to have fulfilled the examination requirement if they are able to demonstrate the required 64 number of years of discipline-free experience set forth in Board regulations.

B. Upon satisfactory evidence to the Board, the following individuals shall not be required to fulfill 65 66 the examination requirement specified in § 54.1-1130 to be certified as a backflow prevention device worker or licensed as a liquefied petroleum gas fitter: 67

1. Individuals approved, or recognized as having expertise, by a local governing body prior to July 1, 68 69 1998, to perform backflow prevention device work; or

2. Individuals applying for certification or licensure between July 1, 1998, and July 1, 1999, who are 70 71 able to demonstrate that they have the required number of years of discipline-free experience and 72 education or training set forth in Board regulations.

73 C. The provisions of this article shall not apply to any individual who is performing work on any 74 ship, boat, barge or other floating vessel. 75

§ 54.1-1132. Expiration and renewal of certification or license.

A certificate as a tradesman or backflow prevention device worker or a license as a liquefied 76 petroleum gas fitter issued pursuant to this article shall expire as provided in Board regulations and shall 77 78 become invalid on that date unless renewed, subject to approval of the Board. Application for renewal 79 of any certificate or license issued pursuant to this article shall be made as provided by Board 80 regulations and shall be accompanied by a fee set by the Board pursuant to § 54.1-201. 81

§ 54.1-1133. Continuing education.

The Board may establish in the regulations requirements for continuing education as a prerequisite to 82 83 renewal of any certification or licensure issued under this article.

84 § 54.1-1134. Grounds for denial or revocation of certification or license; reports of building officials 85 and others.

The Board shall have the power to require remedial education and to suspend, revoke or deny 86 87 renewal of the certification or licensure of any individual who is found to be in violation of the statutes 88 or regulations governing the practice of certified tradesmen or backflow prevention device workers or 89 licensed liquefied petroleum gas fitters in the Commonwealth.

90 Any building official who finds that an individual is practicing as a tradesman or backflow 91 prevention device worker without certification or as a liquefied petroleum gas fitter without a license as 92 required by this article shall file a report to such effect with the Board. Any water purveyor who finds 93 that an individual is practicing as a backflow prevention device worker without certification as required 94 by this article shall file a report to such effect with the Board.

95 Any building official who has reason to believe that (i) a tradesman or a liquefied petroleum gas 96 fitter is performing incompetently as demonstrated by an egregious or repeated violation of the Uniform 97 Statewide Building Code (§ 36-97 et seq.) or (ii) a backflow prevention device worker is performing incompetently as demonstrated by an egregious or repeated violation of the standards adopted by the 98 99 American Society of Sanitary Engineering referenced in the plumbing code adopted by the Virginia Uniform Statewide Building Code shall file a report to such effect with the Board. Any water purveyor 100 101 who has reason to believe that a backflow prevention device worker is performing incompetently as 102 demonstrated by an egregious or repeated violation of the standards adopted by the American Society of 103 Sanitary Engineering referenced in the plumbing code adopted by the Virginia Uniform Statewide Building Code shall file a report to such effect with the Board and local building official. 104 105

§ 54.1-1135. Prohibited acts.

106 A. Practicing or attempting to practice as a tradesman  $\Theta$ , backflow prevention device worker or 107 liquefied petroleum gas fitter in the Commonwealth, except as provided for in this article, is prohibited 108 and shall constitute the commission of a Class 3 misdemeanor.

109 B. No person shall be entitled to assert the lack of certification or licensure as required by this 110 article as a defense to any action at law or suit in equity if the party who seeks to recover from such person gives substantial performance within the terms of the contract in good faith and without actual 111 112 knowledge of the certification *or licensure* requirements of this article.
