A BILL to amend and reenact § 2.1-1.7 of the Code of Virginia and to amend the Code of Virginia by adding in Title 9 a chapter numbered 46, consisting of sections numbered 9-350 through 9-355, relating to the creation of the Southwest Virginia Economic Development Council; appropriation.

Be it enacted by the General Assembly of Virginia:

1. That § 2.1-1.7 of the Code of Virginia is amended and reenacted and that the Code of Virginia is amended by adding in Title 9 a chapter numbered 46, consisting of sections numbered 9-350 through 9-355, as follows:

§ 2.1-1.7. State councils.

A. There shall be, in addition to such others as may be established by law, the following permanent collegial bodies either affiliated with more than one agency or independent of an agency within the executive branch:

64 CHAPTER 46.

65 SOUTHWEST VIRGINIA ECONOMIC DEVELOPMENT COUNCIL.

66 § 9-350. Council created; purpose.

67 There is hereby created the Southwest Virginia Economic Development Council, the "Council." The
68 purpose of the Council shall be, through the exercise of its powers and performance of its duties to
69 study, report, and propose recommendations as to measures which might be taken to improve and
70 enhance economic development in the Southwest Region of the Commonwealth. The Council shall
71 identify ways in which industry might be attracted to the Region by activities of the state government, by
72 individual and joint efforts of the local governments in the region, by regional efforts with the
73 governments of neighboring states and their local governments, by programs provided by or through the
74 educational institutions located in the area, and by programs of the regional business, banking, and
75 industrial community.

76 For the purposes of this chapter, the "Southwest Region" includes the Counties of Bland, Buchanan,
77 Carroll, Dickenson, Giles, Grayson, Lee, Montgomery, Pulaski, Russell, Scott, Smyth, Tazewell,
78 Washington, Wise, and Wythe and the Cities of Bristol, Galax, and Norton.

79 § 9-351. Membership; terms, vacancies; compensation.

80 The Council shall be composed of seventeen members as follows: three members of the House of
81 Delegates appointed by the Speaker; two members of the Senate of Virginia appointed by the Senate
82 Committee on Privileges and Elections. The remaining twelve members shall be appointed by the
83 Governor from the Southwest Region and shall include two representatives of local governments, two
84 local economic development officials, two representatives each from the business and industrial
85 communities, one representative of the banking community, one representative of a major utility, one
86 president of a community college, one representative of a four-year institution of higher education. A
87 representative of the Southwest Office of the Department of Economic Development, to be designated by
88 the Director of the Department, shall be an ex officio member of the Council.

89 Of the twelve members appointed by the Governor, three shall serve four-year terms, four shall serve
90 three-year terms, three shall serve two-year terms, and two shall serve one-year terms. Thereafter, all
91 appointments shall be for terms of four years, except that appointments to fill vacancies shall be for the
92 unexpired terms. No member shall be eligible to serve more than two successive four-year terms.

93 Members of the Council shall receive no compensation but shall receive their actual and necessary
94 expenses incurred in the performance of their duties.

95 § 9-352. Powers and duties of the Council.

96 The Council shall:

97 1. Attract new business prospects to Southwest Virginia and enhance existing local business through
98 marketing and promotional activities;

99 2. Encourage Southwest localities to work cooperatively to promote the Region's strengths and
100 advantages;

101 3. Support regional promotion through the distribution of funds which may be appropriated or
102 received for marketing;

103 4. Apply for, accept, and expend gifts, grants, or donations from public or private sources to enable
104 it to carry out its objectives; and

105 5. Perform any act or function which is in accord with the purposes of this chapter.

106 § 9-353. Staff support.

107 The Institute for Community Resource Development at Virginia Polytechnic Institute and State
108 University shall provide staff assistance to the Council. The Council is further authorized to employ
109 such professional, consultative, and secretarial services and to rent such office space and equipment as
110 may be necessary to carry out the purposes of this chapter.

111 § 9-354. Annual report.

112 Following the close of the calendar year, the Council shall submit an annual report of its activities
113 for the preceding year to the Governor and the General Assembly. Each such report shall set forth a
114 complete operating and financial statement covering the operation of the Council during the year.

115 § 9-355. Cooperation of state agencies.

116 All agencies of the Commonwealth shall cooperate with the Council and, upon request, assist the
117 Council in the performance of its duties and responsibilities.

118 2. That there is hereby appropriated from the general fund of the state treasury the sum of
119 \$50,000 to carry out the purposes of this act.
