128 § 23-9.4. Employment of director and other personnel.

Virginia Museum of Natural History.

A. The Council shall employ and appoint a director who shall be the chief executive officer of the
 Council, and such personnel as may be required to assist it in the exercise and performance of its
 powers and duties.

B. The director shall serve as executive secretary of the Commonwealth Health Research Board. The director and other personnel are authorized to perform all duties imposed on them pursuant to Chapter 134 22 (§ 23-277 et seq.) of this title.
CHAPTER 1.3.

CHAPTER 1.3. COMMONWEALTH HEALTH RESEARCH FUND.

137 § 23-277. Definitions.

As used in this chapter, unless the context clearly indicates otherwise:

139 "Board" means the Commonwealth Health Research Board.

140 "Council" means the State Council of Higher Education for Virginia.

141 "Fund" means the Commonwealth Health Research Fund.

142 § 23-278. Commonwealth Health Research Board created.

A. There is hereby created, as an independent body, the Commonwealth Health Research Board. The
purpose of the Board shall be to provide financial support, in the form of grants, donations, or other
assistance, for research efforts that have the potential of maximizing human health benefits for the
citizens of the Commonwealth. Research efforts eligible for support by the Board shall include
traditional medical and biomedical research relating to the causes and cures of diseases as well as
research related to health services and the delivery of health care.

149 B. The Board shall be composed of seven members. The Governor shall appoint three members of 150 the Board who shall be confirmed by the affirmative vote of a majority of those voting in each house of the General Assembly. The Joint Rules Committee shall appoint the other four members of the Board 151 152 who shall be confirmed by the affirmative vote of a majority of those voting in each house of the 153 General Assembly. The initial members shall be appointed for terms of office as follows: one of the 154 members appointed by the Governor shall be appointed for a term of one year; one of the members 155 appointed by the Joint Rules Committee shall be appointed for a term of two years; one of the members 156 appointed by the Governor and one of the members appointed by the Joint Rules Committee shall be 157 appointed for terms of three years; one of the members appointed by the Joint Rules Committee shall be 158 appointed for a term of four years; and one of the members appointed by the Governor and one of the members appointed by the Joint Rules Committee shall be appointed for terms of five years. 159 Appointments thereafter shall be for terms of five years. Vacancies in the membership of the Board shall 160 161 be filled by appointment of the entity initially making the appointment for the unexpired portion of the term. No member shall be eligible to serve for more than two successive five-year terms; however, after 162 the expiration of a term of four years or less, or after the expiration of the remainder of a term to 163 164 which he was appointed to fill a vacancy, two additional terms may be served by such member if 165 appointed thereto. Immediately after such appointment, the members shall enter upon the performance of 166 their duties.

167 C. The members shall have substantial experience or expertise, personal or professional, in at least
168 one of the following areas: medicine, medical or scientific research, public policy, government, business,
169 or education. No member shall be an incumbent elected official, state official or employee, or member
170 of the governing board of a state agency or institution. Members of the Board need not be residents of
171 the Commonwealth.

D. The members shall elect annually a chairman and vice-chairman from among its members. The chairman, or in his absence, the vice-chairman, shall preside at all meetings of the Board. A majority of the members of the Board serving at any one time shall constitute a quorum for the transaction of business. The Board shall meet annually or more frequently at the call of the chairman.

E. Members of the Board shall receive compensation for their services at the rate provided in
§ 2.1-20.3 and shall receive reimbursement for actual expenses incurred in the performance of their
duties on behalf of the Board. Such compensation and expenses shall be paid from the Fund.

179 § 23-279. Duties of the Board.

180 The Board shall perform the following duties:

181 1. Establish specific criteria and procedures governing its decisions to support research efforts
 182 consistent with its purposes, including, but not limited to, (i) encouraging collaborative research efforts

183 among two or more institutions or organizations, (ii) giving priority to those research efforts where 184 Board support can be leveraged to foster contributions from federal agencies or other entities, and (iii) 185 supporting both new research efforts and the expansion or continuation of existing research efforts;

186 2. Establish requirements for the submission of research proposals, including, but not limited to, (i) a 187 clear statement of the problem or opportunity to be addressed; (ii) the specific objectives; (iii) a 188 description of how the results will maximize human health benefits for the citizens of the 189 Commonwealth; (iv) a budget for the research effort including other anticipated sources of financial 190 assistance; and (v) the time frame for the conduct of the research;

191 3. Evaluate the proposals in accordance with the criteria established by the Board and the 192 provisions of this chapter; and

193 4. Evaluate the implementation and results of all research efforts receiving support from the Board.

194 § 23-280. Conditions and restrictions on financial assistance.

195 A. The Board shall provide financial support only to research efforts that satisfy the following 196 conditions:

197 1. The research shall be conducted by state institutions or nonprofit organizations exempt from 198 income taxation pursuant to § 501 (c) (3) of the Internal Revenue Code and located in the 199 *Commonwealth*;

200 2. The institution or organization shall provide a cash amount for the support provided by the Board 201 in such percentage of the Board's support as the Board deems appropriate;

202 3. Support provided by the Board shall not be used by the recipient to finance capital improvements 203 or renovations, indirect costs incurred by the institution or organization in its administration of the 204 financial support, or for any other purpose proscribed by the Board; and

4. Recipients of support provided by the Board shall agree to provide the Board with such 205 206 information regarding the implementation of the research effort, and to allow monitoring and review of 207 the research effort, as may be required by the Board to ensure compliance with the terms by which the 208 support is provided.

209 B. Any support provided by the Board shall be used by the recipient only for personal services, 210 contractual services, material, supplies, and equipment directly related to the approved research effort. 211 § 23-281. Powers of the Board.

In order to carry out its purpose, the Board shall have the power to:

213 1. Make grants or other expenditures or disbursements from the Fund to provide support for 214 research efforts approved by the Board in accordance with the purposes of this chapter; however, the 215 Board shall not be obligated to make annual or other periodic disbursements or expenditures;

216 2. Contract for the services of consultants to review research proposals and to assist in the 217 evaluation of the research efforts funded by the Board;

218 3. Accept, hold, administer, and solicit, gifts, grants, bequests, contributions or other assistance from 219 federal agencies, the Commonwealth, or any other public or private source to carry out the purposes of 220 this chapter;

221 4. Enter into any agreement or contract relating to the acceptance or use of any grant, assistance or 222 support provided by or to the Board, or otherwise in furtherance of the purposes of this chapter; and 223

5. Perform any lawful acts necessary or appropriate to carry out the purposes of the Board.

§ 23-282. Executive secretary; staffing; location.

225 The director of the Council shall serve as executive secretary to the Board and shall be responsible 226 for the performance of such duties that the Board may direct. The director and other personnel of the 227 Council shall provide such administrative services as the Board shall request. The actual expenses 228 incurred by such persons in the performance of such administrative duties on behalf of the Board, which 229 shall not include the value of any services, rent, or overhead expenses, shall be paid from the Fund. The 230 office of the Board shall be housed at the offices of the Council. The Board shall not be authorized to 231 employ any personnel. 232

§ 23-283. Cooperation with other agencies.

233 All agencies of the Commonwealth shall cooperate with the Board and, upon request, assist the 234 Board in the performance of its duties and responsibilities. 235

§ 23-284. Commonwealth Health Research Fund established; administration.

236 A. There is hereby created in the State Treasury a special, nonreverting revolving fund to be known 237 as the Commonwealth Health Research Fund. The Fund shall be established on the books of the State 238 Comptroller.

239 \vec{B} . The Fund shall consist of all stock distributed to the Commonwealth as a policyholder pursuant to 240 the conversion of Blue Cross and Blue Shield of Virginia, doing business as Trigon Blue Cross Blue 241 Shield, from a mutual insurance company to a Virginia stock corporation known as Trigon Healthcare, Inc., and any moneys appropriated from the general fund, grants and donations received by the Board, 242 243 and other moneys received by the State Treasurer and designated for deposit in the Fund. Interest and other income earned on the Fund shall be credited to the Fund. Any moneys remaining in the Fund, 244

245 including interest and other income thereon, at the end of each fiscal year shall not revert to the 246 general fund but shall remain in the Fund.

C. Notwithstanding any other provision of law, the moneys and other property comprising the Fund 247 248 shall be invested, reinvested and managed by the Board of the Virginia Retirement System as provided 249 in § 51.1-124.36.

250 D. The Fund shall be expended solely for the purpose of supporting research efforts approved by the 251 Board and any other purpose permitted by this chapter.

252 E. Not more than an amount equal to ninety percent of the annual income, including but not limited 253 to interest, dividends, realized gains, fees, and other earnings, from the investment, reinvestment and 254 management of the Fund, net of any administrative fee assessed pursuant to subsection E of 255 § 51.1-124.36, shall be expended in such year for any purpose permitted by this chapter. The Board 256 shall not be required to expend such amount in any year.

257 F. The disbursement of moneys from the Fund shall be made by the State Comptroller at the written 258 request of the Board. 259

§ 23-285. Forms of accounts and records; audit of same.

260 A. The accounts and records of the Board showing the receipt and disbursement of funds from 261 whatever source derived shall be in such form as the Auditor of Public Accounts prescribes.

262 B. The accounts and records of the Board shall be subject to an annual audit by the Auditor of 263 Public Accounts or his legal representative.

264 § 23-286. Reports to the Governor and General Assembly.

265 The Board shall submit a report annually to the Governor and the General Assembly. The report 266 shall include information regarding research efforts supported by the Board and expenditures from the Fund. 267 268

§ 51.1-124.36. Investment of assets of the Commonwealth Health Research Fund.

269 A. In addition to such other powers as shall be vested in the Board, the Board shall have the full 270 power to invest, reinvest, and manage the assets of the Commonwealth Health Research Fund. The 271 Board shall maintain a separate accounting for the assets of the Commonwealth Health Research Fund.

272 B. The Board shall invest the assets of the Commonwealth Health Research Fund with the care, skill, 273 prudence, and diligence under the circumstances then prevailing that a prudent person acting in a like 274 capacity and familiar with such matters would use in the conduct of an enterprise of a like character 275 and with like aims. The Board shall also diversify such investments so as to minimize the risk of large 276 losses unless under the circumstances it is clearly prudent not to do so.

277 C. No officer, director, or member of the Board or of any advisory committee of the Retirement 278 System or any of its tax exempt subsidiary corporations whose actions are within the standard of care in 279 subsection B above shall be held personally liable for losses suffered by the Retirement System on 280 investments made under the authority of this section.

D. The provisions of §§ 51.1-124.32, 51.1-124.33, and 51.1-124.34 shall apply to the Board's 281 282 activities with respect to funds in the Commonwealth Health Research Fund.

283 E. The Board may assess the Commonwealth Health Research Board a reasonable administrative fee for its services provided pursuant to this section, which fee shall be paid only from any annual income, 284 285 including but not limited to interest, dividends, realized gains, fees, and other earnings, earned from the 286 investment, reinvestment and management of the assets of the Commonwealth Health Research Fund.

287 2. That the Commonwealth Health Research Board, the State Council on Higher Education for 288 Virginia, the Board of the Virginia Retirement System, the State Treasurer, and the Department 289 of Accounts shall enter into a memorandum of understanding establishing procedures governing 290 the management, administration, and disbursement of moneys in the Commonwealth Health 291 Research Fund, and other financial activities related to the implementation of this act, by 292 September 1, 1997.
