VIRGINIA ACTS OF ASSEMBLY - CHAPTER

An Act to amend the Code of Virginia by adding sections numbered 58.1-3650.695 through 58.1-3650.719, designating certain organizations to be exempt from property taxation.

Approved

Be it enacted by the General Assembly of Virginia:

1. That the Code of Virginia is amended by adding sections numbered 58.1-3650.695 through 58.1-3650.719 as follows:

§ 58.1-3650.695. Property of Virginia United Methodist Homes, Inc.

10 A. Virginia United Methodist Homes, Inc., a nonprofit organization, is hereby designated as a charitable and benevolent organization within the context of Section 6(a)(6) of Article X of the 11 12 Constitution of Virginia.

13 B. Property located in Henrico County, owned by Virginia United Methodist Homes, Inc., and used 14 by it exclusively for charitable and benevolent purposes on a nonprofit basis as set forth in subsection A

of this section, is hereby determined to be exempt from local taxation.

§ 58.1-3650.696. Property of E-TRON Systems, Inc.

17 A. E-TRON Systems, Inc., a nonprofit corporation, is hereby designated as a charitable and 18 benevolent organization within the context of Section 6(a)(6) of Article X of the Constitution of Virginia. 19 B. Property located in the County of Fairfax, owned by E-TRON Systems, Inc., and used by it

20 exclusively for charitable and benevolent purposes on a nonprofit basis as set forth in subsection A of 21 this section, is hereby determined to be exempt from local taxation. 22

§ 58.1-3650.697. Property of the Izaak Walton League.

23 A. The Izaak Walton League, a nonprofit organization, is hereby designated as a benevolent 24 organization within the context of Section 6(a)(6) of Article X of the Constitution of Virginia.

25 B. Property located in Montgomery County, owned by the Izaak Walton League and used by it 26 exclusively for benevolent purposes on a nonprofit basis as set forth in subsection A of this section, is 27 hereby determined to be exempt from local taxation. 28

§ 58.1-3650.698. Property of the Goochland County Historical Society.

29 A. The Goochland County Historical Society, a nonprofit corporation, is hereby designated as an 30 historical organization within the context of Section 6(a)(6) of Article X of the Constitution of Virginia.

31 B. Real and personal property located in Goochland County, owned by the Goochland County 32 Historical Society, and used by it exclusively for historical purposes on a nonprofit basis as set forth in 33 subsection A of this section, is hereby determined to be exempt from local taxation. 34

§ 58.1-3650.699. Property of The Potomac Conservancy.

35 A. The Potomac Conservancy, a nonprofit organization, is hereby designated as a public park and playground organization within the context of Section 6(a)(6) of Article X of the Constitution of 36 37 Virginia.

38 B. Property located in Fairfax County, owned by The Potomac Conservancy and used by it 39 exclusively for public park and playground purposes on a nonprofit basis as set forth in subsection A of 40 this section, is hereby determined to be exempt from local taxation. 41

§ 58.1-3650.700. Property of Mosby Woods Recreation Association, Inc.

42 A. Mosby Woods Recreation Association, Inc., a nonprofit corporation, is hereby designated as a 43 public park and cultural organization within the context of Section 6(a)(6) of Article X of the 44 Constitution of Virginia.

45 B. Real property located at 3144 Plantation Parkway in the City of Fairfax, owned by Mosby Woods 46 Recreation Association, Inc., and used by it exclusively for public park and cultural purposes on a 47 nonprofit basis as set forth in subsection A of this section, is hereby determined to be exempt from local 48 taxation.

§ 58.1-3650.701. Property of Country Club Hills Recreation Corporation.

50 A. Country Club Hills Recreation Corporation, a nonprofit corporation, is hereby designated as a 51 public park or playground organization within the context of Section 6(a)(6) of Article X of the Constitution of Virginia. 52

53 B. Real property located at 3622 and 3624 Old Post Road in the City of Fairfax, owned by Country 54 Club Hills Recreation Corporation and used by it exclusively for public park or playground purposes on

55 a nonprofit basis as set forth in subsection A of this section, is hereby determined to be exempt from

56 local taxation.

57 § 58.1-3650.702. Property of Fairfax Swimming Pool, Inc.

58 A. Fairfax Swimming Pool, Inc., a nonprofit corporation, is hereby designated as a benevolent organization within the context of Section 6(a)(6) of Article X of the Constitution of Virginia. B. Real property located at 4200 Roberts Road and 10201 Forest Avenue in the City of Fairfax, 59

60 61 owned by Fairfax Swimming Pool, Inc., and used by it exclusively for benevolent purposes on a 62 nonprofit basis as set forth in subsection A of this section, is hereby determined to be exempt from local 63 taxation.

64 § 58.1-3650.703. Property of the Prince William Chapter of the Izaak Walton League of America.

65 A. The Prince William Chapter of the Izaak Walton League of America, a nonprofit organization, is 66 hereby designated as a religious, charitable and benevolent organization within the context of Section 6(a)(6) of Article X of the Constitution of Virginia. 67

68 B. Property located in Prince William County, owned by the Prince William Chapter of the Izaak Walton League of America, and used by it exclusively for religious, charitable and benevolent purposes 69 70 on a nonprofit basis as set forth in subsection A of this section, is hereby determined to be exempt from 71 local taxation.

§ 58.1-3650.704. Property of the Sedalia Center, Inc.

73 A. The Sedalia Center, Inc., a nonprofit organization, is hereby designated as a cultural organization 74 within the context of Section 6(a)(6) of Article X of the Constitution of Virginia.

75 B. Real and personal property located in Bedford County, owned by the Sedalia Center, Inc., and 76 used by it exclusively for cultural purposes on a nonprofit basis as set forth in subsection A of this 77 section, is hereby determined to be exempt from local taxation. 78

§ 58.1-3650.705. Property of The Junior League of Hampton Roads, Inc.

79 A. The Junior League of Hampton Roads, Inc., a nonprofit organization, is hereby designated as a 80 charitable and benevolent organization within the context of Section 6(a)(6) of Article X of the Constitution of Virginia. 81

B. Property located at 729 Thimble Shoals Boulevard, Suite 4-D, in the City of Newport News, 82 83 owned by The Junior League of Hampton Roads, Inc., and used by it exclusively for charitable and 84 benevolent purposes on a nonprofit basis as set forth in subsection A of this section, is hereby 85 determined to be exempt from local taxation. 86

§ 58.1-3650.706. Property of the Rosser Family Foundation.

87 A. The Rosser Family Foundation, a nonprofit organization, is hereby designated as a charitable 88 organization within the context of Section 6(a)(6) of Article X of the Constitution of Virginia.

89 B. Property located in the City of Hampton, owned by the Rosser Family Foundation, and used by it 90 exclusively for charitable purposes on a nonprofit basis as set forth in subsection A of this section, is 91 hereby determined to be exempt from local taxation. 92

§ 58.1-3650.707. Property of the Foundation for Senior Independence.

93 A. The Foundation for Senior Independence, a nonprofit organization, is hereby designated as a charitable and benevolent organization within the context of Section 6(a)(6) of Article X of the 94 95 Constitution of Virginia.

B. Real and personal property located at (i) 4216 Lamplighter Drive, (ii) 6218 Omo Road, and (iii) 96 97 6330 Dorious Drive, in Chesterfield County, owned by the Foundation for Senior Independence and 98 used by it exclusively for charitable and benevolent purposes on a nonprofit basis as set forth in 99 subsection A of this section, is hereby determined to be exempt from local taxation. 100

§ 58.1-3650.708. Property of the United Rappahannock Tribe, Inc.

101 A. The United Rappahannock Tribe, Inc., a nonprofit organization, is hereby designated as a 102 charitable, historical and cultural organization within the context of Section 6(a)(6) of Article X of the 103 Constitution of Virginia.

104 B. Real property located in King and Queen County, owned by the United Rappahannock Tribe, Inc., 105 and used by it exclusively for charitable, historical and cultural purposes on a nonprofit basis as set 106 forth in subsection A of this section, is hereby determined to be exempt from local taxation.

§ 58.1-3650.709. Property of Mathews Youth Center, Inc.

108 A. The Mathews Youth Center, Inc., a nonprofit organization, is hereby designated as a benevolent 109 organization within the context of Section 6(a)(6) of Article X of the Constitution of Virginia.

110 B. Property located in Mathews County, owned by the Mathews Youth Center, Inc., and used by it exclusively for benevolent purposes on a nonprofit basis as set forth in subsection A of this section, is 111 112 hereby determined to be exempt from local taxation.

§ 58.1-3650.710. Property of Mathews County Woman's Club and Mathews County Junior Woman's 113 Club. 114

115 A. The Mathews County Woman's Club and the Mathews County Junior Woman's Club, two nonprofit organizations, are hereby designated as benevolent organizations within the context of Section 116 6(a)(6) of Article X of the Constitution of Virginia. 117

B. Property located in Mathews County, owned by the Mathews County Woman's Club and the 118 119 Mathews County Junior Woman's Club and used by them exclusively for benevolent purposes on a 120 nonprofit basis as set forth in subsection A of this section, is hereby determined to be exempt from local 121 taxation.

122 § 58.1-3650.711. Property of the National Wildlife Federation.

123 A. The National Wildlife Federation, a nonprofit organization, is hereby designated as a charitable 124 and benevolent organization within the context of Section 6(a)(6) of Article X of the Constitution of 125 Virginia.

126 B. Property located in Frederick County, owned by the National Wildlife Federation and used by it 127 exclusively for charitable and benevolent purposes on a nonprofit basis as set forth in subsection A of 128 this section, is hereby determined to be exempt from local taxation. 129

§ 58.1-3650.712. Property of Shenandoah Valley Community Residences, Inc.

130 A. Shenandoah Valley Community Residences, Inc., a nonprofit organization, is hereby designated as a charitable organization within the context of Section 6(a)(6) of Article X of the Constitution of 131 132 Virginia.

133 B. Property located in the City of Winchester, owned by Shenandoah Valley Community Residences, 134 Inc., and used by it exclusively for charitable purposes on a nonprofit basis as set forth in subsection A 135 of this section, is hereby determined to be exempt from local taxation.

136 § 58.1-3650.713. Property of Fairfax County Police Association, Inc.

137 A. Fairfax County Police Association, Inc., a nonprofit corporation, is hereby designated as a 138 charitable and benevolent organization within the context of Section 6(a)(6) of Article X of the Constitution of Virginia. 139

140 B. Property in Fairfax County that is owned by Fairfax County Police Association, Inc., and used by 141 it exclusively for charitable and benevolent purposes on a nonprofit basis as set forth in subsection A of 142 this section, is hereby determined to be exempt from local taxation. 143

§ 58.1-3650.714. Property of Resources for Independence of Virginia, Inc.

144 A. Resources for Independence of Virginia, Inc., a nonprofit corporation, is hereby designated as a 145 charitable and benevolent organization within the context of Section 6(a)(6) of Article X of the 146 Constitution of Virginia.

147 B. Real and personal property located at 6200 Erman Court and 2323 Arden Street in Fairfax 148 County, owned by Resources for Independence of Virginia, Inc., and used by it exclusively for charitable 149 and benevolent purposes on a nonprofit basis as set forth in subsection A of this section, is hereby 150 determined to be exempt from local taxation.

151 § 58.1-3650.715. Property of Preston Community Center.

152 A. Preston Community Center, a nonprofit organization, is hereby designated as a charitable 153 organization within the context of Section 6(a)(6) of Article X of the Constitution of Virginia.

154 B. Real property located in Henry County, owned by Preston Community Center and used by it 155 exclusively for charitable purposes on a nonprofit basis as set forth in subsection A of this section, is 156 hereby determined to be exempt from local taxation. 157

§ 58.1-3650.716. Property of J.E.B. Stuart Birthplace Preservation Trust, Inc.

158 A. The J.E.B. Stuart Birthplace Preservation Trust, Inc., a nonprofit corporation, is hereby 159 designated as an historical organization within the context of Section 6(a)(6) of Article X of the 160 Constitution of Virginia.

161 B. Property located in Patrick County, owned by the J.E.B. Stuart Birthplace Preservation Trust, 162 Inc., and used by it exclusively for historical purposes on a nonprofit basis as set forth in subsection A 163 of this section, is hereby determined to be exempt from local taxation.

164 § 58.1-3650.717. Property of Hartwood Terrace, Inc.

165 A. Hartwood Terrace, Inc., a nonprofit corporation, is hereby designated as a charitable and benevolent organization within the context of Section 6(a)(6) of Article X of the Constitution of Virginia. 166 B. Property located in Fairfax County owned by Hartwood Terrace, Inc., and used by it exclusively 167

168 for charitable and benevolent purposes on a nonprofit basis as set forth in subsection A of this section, 169 is hereby determined to be exempt from local taxation.

170 § 58.1-3650.718. Property of Tacoma School Community Center, Inc.

171 A. Tacoma School Community Center, Inc., a nonprofit corporation, is hereby designated as a 172 charitable organization within the context of Section 6(a)(6) of Article X of the Constitution of Virginia.

173 B. Property located in Wise County owned by Tacoma School Community Center, Inc., and used by 174 it exclusively for charitable purposes on a nonprofit basis as set forth in subsection A of this section, is 175 hereby determined to be exempt from local taxation.

176 § 58.1-3650.719. Property of the Naval Submarine League.

177 A. The Naval Submarine League, a nonprofit corporation, is hereby designated as a charitable and benevolent organization within the context of Section 6(a)(6) of Article X of the Constitution of Virginia. 178

179 B. Property located in Fairfax County, owned by the Naval Submarine League and used by it
180 exclusively for charitable and benevolent purposes on a nonprofit basis as set forth in subsection A of
181 this section, is hereby determined to be exempt from local taxation.
