Patrons-Reasor; Delegate: Tate 8 9 Referred to the Committee on Local Government 10 11 Be it enacted by the General Assembly of Virginia: 1. That §§ 6 and 9 as amended and § 10 of Chapter 150 of the Acts of Assembly of 1930 are 12 amended and reenacted as follows: 13 § 6. Composition of council and vacancies. 14 15 The Council shall consist of five members four councilmen and the mayor, who shall be voted for at 16 large, whose term of office shall be for the term of four years. The term of office for the councilmen shall be four years. The term of office of the mayor shall be two years. At the May election, nineteen 17 hundred eighty two 1998, and every four years thereafter, three two councilmen shall be elected, being 18 the three two candidates who receive the largest number of votes, individually, at such election, who 19 20 will serve for a term of four years from the first day of July 1, nineteen hundred and eighty-two1998, 21 and thereafter until their successors have been elected and qualified. At the May election, nineteen 22 hundred eighty four 2000, and every four years thereafter, two councilmen shall be elected, being the 23 two candidates who received the largest number of votes, individually, at such election, who shall serve 24 for a term of four years from the first day of July 1, nineteen hundred eighty-four 2000, and thereafter 25 until their successors have been elected and qualified. At the May election, 1998, and every two years 26 thereafter, the candidate for mayor who receives the largest number of votes, individually, at such election, shall be elected and shall serve for a term or two years from July 1, 1998, and thereafter until 27 28 his/her successor has been elected and qualified. 29 All elections for members of council and the mayor shall be held at the time and in the manner 30 provided for by general law. 31 Vacancies in the council or mayor shall be filled within thirty days, for the unexpired term, by a 32 majority vote of the remaining councilmen members of council. 33 § 9. Organization rules of the council. 34 (a) At nine o'clock ante meridian a.m. on the first day of July following a regular municipal election, 35 or if such a day be a Sunday, then on the day following, the council shall meet at the usual place for 36 holding the meetings of the legislative board of the town, at which time the newly-elected newly elected 37 councilmen and the mayor, after first having taken the oaths prescribed by law, shall assume the duties 38 of their office offices. Thereafter the council shall meet at such times as may be prescribed by ordinance 39 or resolution except that they shall regularly meet not less than once each month. The mayor, any 40 member of the council, or the town manager may call special meetings of the council, at any time (at 41 least twelve hours), after written notice, with the purpose of said meeting stated therein, to each member 42 served personally or left at his usual place of business or residence, or such meeting may be held at any time without notice, provided all members of the council attend. No business other than that mentioned 43 44 in the call shall be considered at such meeting. Notice of any meeting of council shall be in accordance with the provisions of the Freedom of Information Act as contained in the Code of Virginia. 45 46 (b) All meetings of the council shall be public and any citizens may have access to the minutes and 47 records thereof at all reasonable times; except by unanimous majority vote of the council, it may **48** convene an executive session to consider and vote upon election of officers such matters as may be the 49 appropriate subject of an executive session as provided by the Code of Virginia. 50 (c) The council shall elect one of its members as chairman, who shall be ex-officio mayor; also The 51 council shall appoint a town manager, and a town clerk, and a town commissioner of the revenue. 52 The council may appoint all such other boards and commissions as may be deemed proper, and 53 prescribe the powers and duties thereof. The council may determine its own rules or procedure 54 procedures, may punish its own members for misconduct and may compel attendance of members. It shall keep a journal of its proceedings. A majority of all members of the council shall constitute a 55 quorum to do business, but a smaller number may adjourn from time to time, and compel the attendance 56 of absentees. All elections by the council shall be viva voce and the vote recorded in the journal of the 57 58 council.

59 (d) Council shall fix the compensation of the members of the council, *the mayor*, and all other

officers the compensation of which is not otherwise provided for herein, and the compensation of the
commissioner of the revenue may be fixed upon a salary basis, in lieu of commissions allowed to
commissioners of the revenue under general law.

§ 10. Same-mayor generally.

The mayor shall be elected by the council at its first meeting after each election and qualification of 64 65 councilmen, for a term of two years as provided in § 6 hereof and shall preside at meetings of the 66 council and perform such other duties consistent with his the office as may be imposed by the council and he shall have a vote and voice in the proceedings, but no veto. He The mayor shall be the official 67 68 head of the town, but shall have no jurisdiction or authority to hear, determine or try any civil or criminal matters. In times of public danger, or emergency, he the mayor, or during his the mayor's 69 absence or disability, the town manager, may take command of the police and maintain order and 70 enforce the laws, and for this purpose, may deputize such assistant policemen as may be necessary. 71 During his the mayor's absence or disability, except as above provided, his the mayor's duties shall be 72 performed by another member appointed by the council. He The mayor shall authenticate by his 73 74 signature such instruments as the council, this charter, or the laws of the State shall require.
