## **SENATE JOINT RESOLUTION NO. 26**

AMENDMENT IN THE NATURE OF A SUBSTITUTE (Proposed by the Senate Committee on Privileges and Elections

on October 23, 1996)

(Patron Prior to Substitute—Senator Hawkins)

Proposing an amendment to Section 2 of Article VII of the Constitution of Virginia, relating to the organization and government of localities.

8 RESOLVED by the Senate, the House of Delegates concurring, a majority of the members elected to 9 each house agreeing, That the following amendment to the Constitution of Virginia be, and the same 10 hereby is, proposed and referred to the General Assembly at its first regular session held after the next general election of members of the House of Delegates for its concurrence in conformity with the 11 provisions of Section 1 of Article XII of the Constitution of Virginia, namely: 12 13

Amend Section 2 of Article VII of the Constitution of Virginia as follows:

ARTICLE VII

LOCAL GOVERNMENT Section 2. Organization and government.

The General Assembly shall provide by general law for the organization, government, powers, 16 change of boundaries, consolidation, and dissolution of counties, cities, towns, and regional governments. 17 The General Assembly may also provide by general law optional plans of government for counties, 18 cities, or towns to be effective if approved by a majority vote of the qualified voters voting on any such 19 20 plan in any such county, city, or town.

21 The General Assembly may also provide by special act for the organization, government, and powers 22 of any county, city, town, or regional government, including such powers of legislation, taxation, and 23 assessment as the General Assembly may determine, but no such special act shall be adopted which 24 provides for the extension or contraction of boundaries of any county, city, or town.

25 Every law providing for the organization of a regional government shall, in addition to any other 26 requirements imposed by the General Assembly, require the approval of the organization of the regional 27 government by a majority vote of the qualified voters voting thereon in each county and city which is to 28 participate in the regional government and of the voters voting thereon in a part of a county or city 29 where only the part is to participate.

30 The General Assembly may provide by general law or special act for agreements between or among 31 two or more counties, cities, or towns, or any combination thereof, to share the revenues and costs 32 associated with a particular land area to be designated in the agreement. The law shall provide for the 33 establishment of a special governing body for the area to be comprised of members selected by the governing bodies of the participating localities. The law shall provide for the number of members of the 34 35 special governing body and their terms and compensation and for the powers of the special governing 36 body which may include one or more of the powers of county or city governing bodies and which shall pertain to the land area designated in the agreement. The law may provide for the adoption of the 37 38 agreement upon the approval of the governing bodies of the participating localities without a vote of the 39 qualified voters of the participating localities.
