989688324 HOUSE BILL NO. 198 1 2 AMENDMENT IN THE NATURE OF A SUBSTITUTE 34 56 7 (Proposed by the House Committee on Finance on February 11, 1998 (Patron Prior to Substitute—Delegate Marshall) A BILL to amend and reenact §§ 58.1-3812 and 58.1-3814 of the Code of Virginia, relating to consumer utility taxes. Be it enacted by the General Assembly of Virginia: 8 9 1. That §§ 58.1-3812 and 58.1-3814 of the Code of Virginia are amended and reenacted as follows: 10 § 58.1-3812. Telegraph and telephone companies. 11 A. Any county, city or town may impose a tax on a taxable purchase by a consumer of local telecommunication service if the consumer's service address is located in such county, city or town. 12 Except as otherwise provided, the tax shall not be imposed at a rate in excess of twenty percent of the 13 monthly gross charge to a consumer and shall not be applicable to any amount so charged in excess of 14 15 fifteen dollars per month for a residential consumer; however, any county, city or town that on July 1, 16 1972, imposed a tax in excess of limits specified herein may continue to impose such a tax in excess of such limits, but no more. Notwithstanding the foregoing, the tax may be imposed only at a rate equal to 17 ten percent of the monthly gross charge to a consumer of mobile local telecommunication and shall not 18 be applicable to any amount so charged in excess of thirty dollars per month for each mobile service 19 20 consumer. No county, city or town that currently is not collecting the tax on mobile local telecommunication service shall begin to collect the tax on mobile local telecommunication service 21 before September 1, 1994, for bills sent to consumers on and after that date. However, any county with 22 23 a population of at least 68,000 but not more than 69,000, any city with a population of at least 40,000 but not more than 41,000, and any city with a population of at least 66,000 but not more than 67,000 24 25 shall conform with the provisions of this section in accordance with the following schedule: 26 Fiscal Year Rate Cap

B. Any tax enacted pursuant to the provisions of this section or any change in a tax or structure already in existence shall not be effective until 120 days subsequent to written notice by certified mail from the county, city or town imposing such tax or change thereto, being received by the registered agent of the service provider that is required to collect the tax.

42 C. Any county tax imposed hereunder shall not apply within the limits of any incorporated town 43 located within such county which town imposes a town tax authorized by this section, provided that 44 such town (i) provides police or fire protection, and water or sewer services, provided that any such 45 town served by a sanitary district or any such town with a population between 250 and 350 people which formerly provided its own water and sewer and is now served by a water and sewer service 46 47 authority providing water or sewer services or any such town which formerly provided water and sewer services and is now served by the county in which it is located pursuant to an agreement between the **48** 49 town and the county shall be deemed to be providing such water or sewer services itself, or (ii) 50 constitutes a special school district and is operated as a special school district under a town school board of three members appointed by the town council. 51

52 D. Any county, city or town may provide for an exemption from the tax for any public safety 53 agency as defined in § 58.1-3813.

E. Any city with a population of not less than 27,000 and not more than 28,500 may provide an
exemption from the tax for any church or religious body entitled to an exemption pursuant to Article 4
(§ 58.1-3650 et seq.) of Chapter 36.

57 EF. A service provider of local telecommunication services shall collect the tax from the consumer 58 by adding the tax to the monthly gross charge for such services. The tax shall, when collected, be stated

as a distinct item separate and apart from the monthly gross charge. Until the consumer pays the tax to 59 the service provider, the tax shall constitute a debt of the consumer to the county, city or town. If any 60 consumer refuses to pay the tax, the service provider shall notify the county, city or town. After the 61 62 consumer pays the tax to the service provider, the taxes collected shall be deemed to be held in trust by 63 the service provider until remitted to the county, city or town.

64 FG. A service provider shall remit monthly to each county, city or town the amount of tax billed 65 during the preceding month to consumers with a service address in that county, city or town, less any discount allowed under § 58.1-3816.1. 66

GH. No county, city or town may impose the tax on consumers of mobile local telecommunication 67 service unless it also imposes the tax on the consumers of the other forms of local telecommunication 68 69 services.

70 HI. Any consumer shall be entitled to a refund from the county, city or town imposing the tax equal 71 to the amount of any tax the consumer paid to a jurisdiction outside of the Commonwealth if such tax was legally imposed in such other jurisdiction; however, the amount of credit or refund shall not exceed 72 73 the tax paid to the county, city or town on such purchase. 74

IJ. As used in this article, unless the context clearly requires otherwise:

"Affiliated group" shall have the same meaning ascribed to it in subdivision C 10 of § 58.1-3703, 75 76 except, for purposes of this article, the word "entity" shall be substituted for the word "corporation" 77 whenever it is used in that section.

78 "Bad debts" means any portion of a debt related to a sale of local telecommunication services, the 79 gross charges for which are not otherwise deductible or excludable, that has become worthless or 80 uncollectible, as determined under applicable federal income tax standards. If the portion of the debt deemed to be bad is subsequently paid, the service provider shall report and pay the tax on that portion during the reporting period in which the payment is made. 81 82

"Consumer" means a person who, individually or through agents, employees, officers, representatives, 83 or permittees, makes a taxable purchase of local telecommunication services. 84

'Enhanced services" means services that employ computer processing applications to act on the 85 format, code, or protocol or similar aspects of the information transmitted; provide additional, different, 86 87 or restructured information; or involve interaction with stored information.

88 "Gross charges" means, subject to the exclusions of this section, the amount charged or paid for the 89 taxable purchase of local telecommunication services. However, "gross charges" shall not include the 90 following:

91 1. Charges or amounts paid that vary based on the distance and/or elapsed transmission time of the 92 communication that are separately stated on the consumer's bill or invoice.

93 2. Charges or amounts paid for customer equipment, including such equipment that is leased or rented by the customer from any source, if such charges or amounts paid are separately identifiable from 94 95 other amounts charged or paid for the provision of local telecommunication services on the service 96 provider's books and records.

97 3. Charges or amounts paid for administrative services, including, without limitation, service 98 connection and reconnection, late payments, and roamer daily surcharges.

99 4. Charges or amounts paid for special features that are not subject to taxation under § 4251 of the 100 Internal Revenue Code of 1986, as amended.

5. Charges or amounts paid that are (i) the tax imposed by § 4251 of the Internal Revenue Code of 101 102 1986, as amended, or (ii) any other tax or surcharge imposed by statute, ordinance or regulatory 103 authority. 104

6. Bad debts.

"Local telecommunication service," subject to the exclusions stated in this section, includes, without 105 limitation, the two-way local transmission of messages through use of switched local telephone services; 106 telegraph services; teletypewriter; local cellular mobile radio telecommunication services; specialized 107 108 mobile radio; stationary two-way radio; or any other form of two-way mobile and portable 109 communications.

110 "Local telephone service," subject to the exclusions stated in this section, includes any service subject 111 to federal taxation as local telephone service as that term is defined in § 4252 of the Internal Revenue Code of 1986, as amended, or any successor statute. 112

113 "Mobile local telecommunication service" means any two-way mobile or portable local telecommunication service, including cellular mobile radio telecommunication service and specialized 114 115 mobile radio.

116 "Mobile service consumer" means a person having a telephone number for mobile local telecommunication service who has made a taxable purchase of such service or on whose behalf another 117 person has made a taxable purchase of such service. 118

119 "Mobile service provider" means every person engaged in the business of selling mobile local telecommunication services to consumers. 120

121 "Residential consumer" shall not include any consumer of mobile local telecommunication service. 122 "Service address" means the location of the telecommunication equipment from which the 123 telecommunication is originated or at which the telecommunication is received by a consumer. However, if the service address is not a defined location, as in the case of mobile telephones, maritime systems, 124 125 air-to-ground systems and the like, service address shall mean the location of the subscriber's primary 126 use of the telecommunication equipment within the licensed service area. A mobile service provider may 127 obtain a signed statement from a consumer indicating which county, city or town within the licensed 128 service area is the location of the consumer's primary use of the telecommunication equipment. A 129 mobile service provider shall be entitled to rely absolutely on a consumer's signed statement and shall 130 remit the taxes collected to the county, city or town identified by the consumer. In the absence of a 131 signed statement by a consumer, a mobile service provider shall identify the county, city or town of the 132 consumer's primary use and shall remit the tax to such county, city or town based on any other reasonable method, including, without limitation, the consumer's billing address, service address, or 133

134 telephone number within the licensed service area.

"Service provider" means every person engaged in the business of selling local telecommunicationservices to consumers.

137 "Taxable purchase" means the acquisition of telecommunication services for consumption or use; 138 however, taxable purchase does not include (i) the provision of telecommunications among members of 139 an affiliated group of entities by a member of the group for their own exclusive use and consumption 140 and (ii) the purchase of telecommunications for resale in the subsequent provision of 141 telecommunications, including, without limitation, carrier access charges, right of access charges, and 142 charges for use of intercompany facilities; however, the acquisition of telecommunications by a provider 143 of enhanced services is not the purchase of telecommunications for resale, even when the cost of the 144 telecommunications is separately stated to the purchaser of the enhanced services, as long as the primary 145 object of the purchase of the telecommunications by the provider is for the provision of enhanced services and not telecommunications. A person may make tax-free purchases of telecommunications for 146 147 resale if the person provides to the service provider a sworn affidavit indicating that the person's 148 purchases are nontaxable sales for resale.

149 § 58.1-3814. Water or heat, light and power companies.

A. Any county, city or town may impose a tax on the consumers of the utility service or services provided by any water or heat, light and power company or other corporations coming within the provisions of Chapter 26 (§ 58.1-2600 et seq.), which tax shall not be imposed at a rate in excess of twenty percent of the monthly amount charged to consumers of the utility service and shall not be applicable to any amount so charged in excess of fifteen dollars per month for residential customers. Any city, town or county that on July 1, 1972, imposed a utility consumer tax in excess of limits specified herein may continue to impose such a tax in excess of such limits, but no more.

B. Any tax enacted pursuant to the provisions of this section, or any change in a tax or structure already in existence, shall not be effective until sixty days subsequent to written notice by certified mail from the county, city or town imposing such tax or change thereto, to the registered agent of the utility corporation that is required to collect the tax.

161 C. Any county, city or town may impose a tax on the consumers of services provided within its 162 jurisdiction by any electric light and power, water or gas company owned by another municipality; provided, that no county shall be authorized under this section to impose a tax within a municipality on 163 164 consumers of services provided by an electric light and power, water or gas company owned by that 165 municipality. Any county tax imposed hereunder shall not apply within the limits of any incorporated town located within such county which town imposes a town tax on consumers of utility service or 166 167 services provided by any corporation coming within the provisions of Chapter 26, provided that such 168 town (i) provides police or fire protection, and water or sewer services, provided that any such town 169 served by a sanitary district or service authority providing water or sewer services or served by the 170 county in which the town is located when such service or services are provided pursuant to an 171 agreement between the town and county shall be deemed to be providing such water and sewer services 172 itself, or (ii) constitutes a special school district and is operated as a special school district under a town 173 school board of three members appointed by the town council.

174 Any county, city or town may provide for an exemption from the tax for any public safety agency as 175 defined in § 58.1-3813.

E. Any city with a population of not less than 27,000 and not more than 28,500 may provide an
exemption from the tax for any church or religious body entitled to an exemption pursuant to Article 4
(§ 58.1-3650 et seq.) of Chapter 36.

- 179 Any municipality required to collect a tax imposed under authority of this section for another city or 180 county or town shall be entitled to a reasonable fee for such collection.
- 181 D. In a consolidated county wherein a tier-city exists, any county tax imposed hereunder shall apply

182 within the limits of any tier-city located in such county, as may be provided in the agreement or plan of

consolidation, and such tier-city may impose a tier-city tax on the same consumers of utility service or
services, provided that the combined county and tier-city rates do not exceed the maximum permitted by
state law.

186 E. The tax authorized by this section shall not apply to utility sales of products used as motor187 vehicle fuels.
