2 *An Act to amend and reenact § 54.1-3935 of the Code of Virginia, relating to procedure for revocation*
3 *of attorney's license to practice law.*

6 **Be it enacted by the General Assembly of Virginia:**

7 **1. That § 54.1-3935 of the Code of Virginia is amended and reenacted as follows:**

8 § 54.1-3935. Procedure for revocation of license.

9 A. If the Supreme Court, the Court of Appeals, or any circuit court of this Commonwealth observes,
10 or if a complaint, verified by affidavit is made by any person to such court, that any attorney has been
11 convicted of a misdemeanor involving moral turpitude or a felony or has violated the Virginia Code of
12 Professional Responsibility, the court may assign the matter to the Virginia State Bar for investigation.
13 Upon receipt of the report of the Virginia State Bar, the court may issue a rule against such attorney to
14 show cause why his license to practice law shall not be revoked. If the complaint, verified by affidavit,
15 is made by a district committee of the Virginia State Bar, the court shall issue a rule against the
16 attorney to show cause why his license to practice law shall not be revoked.

17 B. At the time the rule is issued the court issuing it shall certify the fact of such issuance and the
18 time and place of the hearing thereon, to the Chief Justice of the Supreme Court, who shall designate
19 three circuit court judges of circuits other than the circuit in which the case is pending to hear and
20 decide the case. *In proceedings under this section, the court shall adopt the Rules and Procedures*
21 *described in Part Six, Section IV, Paragraph 13 of the Rules of Court.*

22 C. Bar Counsel of the Virginia State Bar shall prosecute the case. Special counsel may be appointed
23 to prosecute the case pursuant to § 2.1-122.

24 D. Upon the hearing, if the attorney is found guilty by the court, his license to practice law in this
25 Commonwealth shall be revoked or suspended for such time as the court may prescribe. ~~However,~~ In
26 lieu of revocation or suspension, the court may ~~reprimand such attorney~~ impose any other sanction
27 authorized by Part Six, Section IV, Paragraph 13 of the Rules of Court.

28 E. The attorney, may, as of right, appeal from the judgment of the court to the Supreme Court, ~~by~~
29 ~~petition based upon a true transcript of the record, which shall be made up and certified as in actions at~~
30 ~~law. In all such cases where an attorney's license to practice law has been revoked by the court, his~~
31 ~~privilege to practice law shall be suspended pending appeal pursuant to the procedure for filing an~~
32 ~~appeal from a trial court, as set forth in Part 5 of the Rules of Court. In any such appeal, the Supreme~~
33 ~~Court may, upon petition of the attorney, stay the effect of an order of suspension during the pendency~~
34 ~~of the appeal. Any order of reprimand shall be automatically stayed prior to or during the pendency of~~
35 ~~an appeal therefrom. No stay shall be granted in cases where the attorney's license to practice law has~~
36 ~~been revoked.~~

37 F. In any proceeding to revoke the license of an attorney, the attorney shall be entitled to
38 representation by counsel.

39 G. Nothing in this section shall affect the right of a court to require from an attorney security for his
40 good behavior, or to fine him for contempt of court.
