9	Virginia by adding a section numbered 19.2-368.3:1, relating to the Compensation for Victims of
10	Crime Act.
11	Be it enacted by the General Assembly of Virginia:
12	1. That §§ 19.2-368.2, 19.2-368.3 as it is currently effective and as it may become effective,
13	19.2-368.4, 19.2-368.5, 19.2-368.5:1, 19.2-368.6 as it is currently effective and as it may become
14	effective, and 19.2-368.11:1 of the Code of Virginia are amended and reenacted and that the Code
15	of Virginia is amended by adding a section numbered 19.2-368.3:1 as follows:
16 17	§ 19.2-368.2. Definitions. For the purpose of this chapter:
18	"Claimant" means the person filing a claim pursuant to this chapter.
19	"Commission" means the Virginia Workers' Compensation Commission.
20	"Crime" means an act committed by any person in the Commonwealth of Virginia which would
21	constitute a crime as defined by the Code of Virginia or at common law. However, no act involving the
22	operation of a motor vehicle which results in injury shall constitute a crime for the purpose of this
23 24	chapter unless the injuries (i) were intentionally inflicted through the use of such vehicle or (ii) resulted from a violation of § 18.2-51.4 or § 18.2-266.
25	"Family," when used with reference to a person, means (i) any person related to such person within
26	the third degree of consanguinity or affinity, (ii) any person residing in the same household with such
27	person, or (iii) a spouse.
28	"Victim" means a person who suffers personal physical injury or death as a direct result of a crime
29 30	or who suffers personal emotional injury as a direct result of being the subject of robbery, abduction a violent felony offense as defined in subsection C of § 17-237, or attempted robbery or abduction.
30 31	§ 19.2-368.3. Powers and duties of Commission.
32	The Commission shall have the following powers and duties in the administration of the provisions
33	of this chapter:
34	1. To adopt, promulgate, amend and rescind suitable rules and regulations to carry out the provisions
35 36	and purposes of this chapter. 2. Notwithstanding the provisions of subdivision B 1 of § 2.1-342, to acquire from the attorneys for
30 37	the Commonwealth, State Police, local police departments, sheriffs' departments, <i>child protective services</i>
38	units of local departments of social services and the State Department of Social Services, and the Chief

60 § 19.2-368.3. (Delayed effective date) Powers and duties of Commission.

61 The Commission shall have the following powers and duties in the administration of the provisions 62 of this chapter:

63 1. To adopt, promulgate, amend and rescind suitable rules and regulations to carry out the provisions 64 and purposes of this chapter.

65 2. § 19.2-368.3:1. Crime victims' ombudsman.

90 A. The Commission shall employ a crime victims' ombudsman and adequate staff to facilitate the 91 prompt review and resolution of crime victim compensation claims and to assure that crime victims' 92 rights are safeguarded and protected during the claims process. The ombudsman shall report directly to 93 the Commission.

94 B. The ombudsman shall ensure that all parties, including service providers and Criminal Injuries Compensation Fund personnel are acting in the best interests of the crime victim. The ombudsman shall 95 96 also provide assistance to crime victims in filling out the necessary forms for compensation and 97 obtaining necessary documentation. 98

§ 19.2-368.4. Persons eligible for awards.

99 A. The following persons shall be eligible for awards pursuant to this chapter unless the award 100 would directly and unjustly benefit the person who is criminally responsible:

1. A victim of a crime, including a person who is injured or killed as a result of foreign terrorism.

102 2. A surviving spouse, parent, grandparent, sibling or child, including posthumous children, of a 103 victim of a crime who died as a direct result of such crime.

104 3. Any person, except a law-enforcement officer engaged in the performance of his duties, who is injured or killed while trying to prevent a crime or an attempted crime from occurring in his presence, 105 106 or trying to apprehend a person who had committed a crime in his presence or had, in fact, committed a felony. 107

108 4. A surviving spouse, parent, grandparent, sibling or child, including posthumous children, of any 109 person who dies as a direct result of trying to prevent a crime or attempted crime from occurring in his 110 presence, or trying to apprehend a person who had committed a crime in his presence or had, in fact, committed a felony. 111

112 5. Any other person legally dependent for his principal support upon a victim of crime who dies as a result of such crime, or legally dependent for his principal support upon any person who dies as a direct 113 114 result of trying to prevent a crime or an attempted crime from occurring in his presence or trying to apprehend a person who had committed a crime in his presence or had, in fact, committed a felony. 115

B. A person who is criminally responsible for the crime upon which a claim is based, or an 116 accomplice or accessory of such person, shall not be eligible to receive an award with respect to such 117 118 claim.

C. A resident of Virginia who is the victim of a crime occurring outside Virginia and any other 119 120 person as defined in subsection A who is injured as a result of a crime occurring outside Virginia shall be eligible for an award pursuant to this chapter if (i) the person would be eligible for benefits had the 121

crime occurred in Virginia and (ii) the state in which the crime occurred does not have a crime victims'
compensation program deemed eligible pursuant to the provisions of the federal Victims of Crime Act
and does not compensate nonresidents.

125 § 19.2-368.5. Filing of claims; deferral of proceedings.

A. A claim may be filed by a person eligible to receive an award, as provided in § 19.2-368.4, or if
such person is a minor, by his parent or guardian. In any case in which the person entitled to make a
claim is incapacitated, the claim may be filed on his behalf by his guardian, conservator or such other
individual authorized to administer his estate.

130 B. A claim must shall be filed by the claimant not later than 180 days one year after the occurrence 131 of the crime upon which such claim is based, or not later than 180 days one year after the death of the 132 victim. However, (i) in cases involving claims made on behalf of a minor or a person who is 133 incapacitated, the provisions of subsection A of § 8.01-229 shall apply to toll the 180-day one-year 134 period and (ii) in cases involving claims made by a victim against profits of crime forfeited and held in 135 escrow pursuant to Chapter 21.2 (§ 19.2-368.19 et seq.) of this title, the claim shall be filed within five 136 years of the date of the order of forfeiture. In all other cases, upon good cause shown, the Commission 137 may extend the time for filing for a period not exceeding, under any circumstances, two years after such 138 occurrence.

C. Claims shall be filed in the office of the Commission in person or by mail. The Commission shall
accept for filing all claims submitted by persons eligible under subsection A of this section and alleging
the jurisdictional requirements set forth in this chapter and meeting the requirements as to form in the
rules and regulations of the Commission.

143 D. Upon filing of a claim pursuant to this chapter, the Commission shall promptly notify the attorney 144 for the Commonwealth of the jurisdiction wherein the crime is alleged to have occurred. If, within ten 145 days after such notification, the attorney for the Commonwealth so notified advises the Commission that 146 a criminal prosecution is pending upon the same alleged crime, the Commission shall defer all 147 proceedings under this chapter until such time as such criminal prosecution has been concluded in the 148 circuit court unless notification is received from the attorney for the Commonwealth that no objection is 149 made to a continuation of the investigation and determination of the claim. When such criminal 150 prosecution has been concluded in the circuit court the attorney for the Commonwealth shall promptly 151 so notify the Commission. Nothing in this section shall be construed to mean that the Commission is to 152 defer proceedings upon the filing of an appeal, nor shall this section be construed to limit the authority 153 of the Commission to grant emergency awards as hereinafter provided.

154 § 19.2-368.5:1. Failure to perfect claim; denial.

Notwithstanding the provisions of § 19.2-368.5, if, following the initial filing of a claim, a claimant fails to take such further steps to support or perfect the claim as may be required by the Commission within ninety 180 days after written notice of such requirement is sent by the Commission to the claimant, the claimant shall be deemed in default. If the claimant is in default, the Commission shall notify the claimant that the claim is denied and the claimant shall be forever barred from reasserting it; however, the Commission may reopen the proceeding upon a showing by claimant that the failure to do the acts required by the Commission was beyond the control of the claimant.

162 § 19.2-368.6. Assignment of claims; investigation; hearing; confidentiality of records; decisions.

A. A claim, when accepted for filing, shall be properly investigated, and, if necessary, assigned by
the chairman to a commissioner, deputy commissioner or other proper party for disposition. All claims
arising from the death of an individual shall be considered together by the same person.

B. The person to whom such claim is assigned shall examine the papers filed in support of the claim and shall thereupon cause an investigation to be conducted into the validity of the claim. The investigation shall include, but not be limited to, an examination of police, court and official records and reports concerning the crime, and an examination of medical and hospital reports relating to the injury upon which the claim is based. Health care providers, as defined in § 8.01-581.1, shall provide medical and hospital reports relating to the diagnosis and treatment of the injury upon which the claim is based to the Commission, upon request.

173 C. Claims shall be investigated and determined, regardless of whether the alleged criminal has been
174 apprehended or prosecuted for, or convicted of, any crime based upon the same incident, or has been
175 acquitted, or found not guilty of the crime in question owing to a lack of criminal responsibility or other
176 legal exemption.

177 D. There shall be a rebuttable presumption that the claimant did not contribute to and was not 178 responsible for the infliction of his injury.

E. The person to whom a claim is assigned may decide the claim in favor of a claimant on the basis
of the papers filed in support thereof and the report of the investigation of the claim. If he is unable to
decide the claim, upon the basis of the said papers and report, he shall order a hearing. At the hearing
any relevant evidence, not legally privileged, shall be admissible. The hearing of any claim involving a

192 G H. The person making a decision shall issue a written report setting forth such decision and his 193 reasons therefor, and shall notify the claimant and furnish him a copy of such report.

194 § 19.2-368.6. (Delayed effective date) Assignment of claims; investigation; hearing; confidentiality of 195 records; decisions.

196 A. A claim, when accepted for filing, shall be properly investigated, and, if necessary, assigned by 197 the chairman to a commissioner, deputy commissioner or other proper party for disposition. All claims 198 arising from the death of an individual shall be considered together by the same person.

199 B. The person to whom such claim is assigned shall examine the papers filed in support of the claim 200 and shall thereupon cause an investigation to be conducted into the validity of the claim. The 201 investigation shall include, but not be limited to, an examination of police, court and official records and 202 reports concerning the crime, and an examination of medical and hospital reports relating to the injury 203 upon which the claim is based. Health care providers, as defined in § 8.01-581.1, shall provide medical 204 and hospital reports relating to the diagnosis and treatment of the injury upon which the claim is based 205 to the Commission, upon request.

C. Claims shall be investigated and determined, regardless of whether the alleged criminal has been 206 207 apprehended or prosecuted for, or convicted of, any crime based upon the same incident, or has been 208 acquitted, or found not guilty of the crime in question owing to a lack of criminal responsibility or other 209 legal exemption.

210 D. There shall be a rebuttable presumption that the claimant did not contribute to and was not 211 responsible for the infliction of his injury.

E. The person to whom a claim is assigned may decide the claim in favor of a claimant on the basis 212 213 of the papers filed in support thereof and the report of the investigation of the claim. If he is unable to decide the claim, upon the basis of the said papers and report, he shall order a hearing. At the hearing 214 215 any relevant evidence, not legally privileged, shall be admissible. The hearing of any claim involving a 216 claimant or victim who is a juvenile shall be closed. All records, papers, and reports involving such 217 claim shall be confidential except as to the amount of the award and nonidentifying information 218 concerning the claimant or victim.

222 **F** G. After examining the papers filed in support of the claim, and the report of investigation, and 223 after a hearing, if any, a decision shall be made either granting an award pursuant to § 19.2-368.11:1 of 224 this chapter or denying the claim.

225 G H. The person making a decision shall issue a written report setting forth such decision and his 226 reasons therefor, and shall notify the claimant and furnish him a copy of such report. 227

§ 19.2-368.11:1. Amount of award.

228 A. Compensation for Total Loss of Earnings: An award made pursuant to this chapter for total loss 229 of earnings which results directly from incapacity incurred by a crime victim shall be payable during 230 total incapacity to the victim or to such other eligible person, at a weekly compensation rate equal to 231 sixty-six and two-thirds percent of the victim's average weekly wages. The total amount of weekly 232 compensation shall not exceed \$200. The victim's average weekly wages shall be determined as 233 provided in § 65.2-101.

234 B. Compensation for Partial Loss of Earnings: An award made pursuant to this chapter for partial 235 loss of earnings which results directly from incapacity incurred by a crime victim shall be payable 236 during incapacity at a weekly rate equal to sixty-six and two-thirds percent of the difference between the 237 victim's average weekly wages before the injury and the weekly wages which the victim is able to earn 238 thereafter. The combined total of actual weekly earnings and compensation for partial loss of earnings 239 shall not exceed \$200 per week.

240 C. Compensation for Dependents of a Victim Who Is Killed: If death results to a victim of crime 241 entitled to benefits, dependents of the victim shall be entitled to compensation in accordance with the 242 provisions of §§ 65.2-512 and 65.2-515 in an amount not to exceed the maximum aggregate payment or 243 the maximum weekly compensation which would have been payable to the deceased victim under this

244 section. 245 D. Compensation for Unreimbursed Medical Costs, Funeral Expenses, Services, etc.: Awards may 246 also be made on claims or portions of claims based upon the claimant's actual expenses incurred as are 247 determined by the Commission to be appropriate, for (i) unreimbursed medical expenses or indebtedness 248 reasonably incurred for medical expenses; (ii) expenses reasonably incurred in obtaining ordinary and 249 necessary services in lieu of those the victim would have performed, for the benefit of himself and his 250 family, if he had not been a victim of crime; (iii) expenses in any way related to funeral or burial, not to exceed $\frac{32,000}{33,500}$; (iv) expenses attributable to pregnancy resulting from forcible rape; (v) mental 251 252 health counseling for survivors as defined under subdivisions A 2 and A 4 of § 19.2-368.4, not to 253 exceed \$1,000 per claim; and (vi) reasonable and necessary moving expenses, not to exceed \$500, 254 incurred by a victim or survivors; and (vii) any other reasonable and necessary expenses and 255 indebtedness incurred as a direct result of the injury or death upon which such claim is based, not 256 otherwise specifically provided for.

E. Any claim made pursuant to this chapter shall be reduced by the amount of any payments
received or to be received as a result of the injury from or on behalf of the person who committed the
crime or from any other public or private source, including an emergency award by the Commission
pursuant to § 19.2-368.9.

F. To qualify for an award under this chapter, a claim must have a minimum value of \$100, and payments for injury or death to a victim of crime, to the victim's dependents or to others entitled to payment for covered expenses, after being reduced as provided in subsection E, shall not exceed \$15,000 in the aggregate.
