11	Be it enacted by the General Assembly of Virginia:
12	1. That § 29.1-700 of the Code of Virginia is amended and reenacted and that the Code of Virginia
13	is amended by adding a section numbered 29.1-749.1 as follows:
13 14	§ 29.1-700. Definitions.
15	As used in this chapter, unless the context clearly requires a different meaning:
16	"Motorboat" means any vessel propelled by machinery whether or not the machinery is the principal
17	source of propulsion.
18	"Operate" means to navigate or otherwise control the movement of a motorboat or a vessel.
19	"Owner" means a person, other than a lien holder, having the property in or title to a motorboat. The
20 21	term includes a person entitled to the use or possession of a motorboat subject to an interest in another
21 22	person, reserved or created by agreement and securing payment of performance of an obligation, but the term excludes a lessee under a lease not intended as security.
23	"Personal watercraft" means a motorboat less than sixteen feet in length which uses an outboard
24	motor, or an inboard motor powering a jet pump, as its primary motive power and which is designed to
25	be operated by a person sitting, standing, or kneeling on, rather than in the conventional manner of
26	sitting or standing inside, the vessel.
27	"Vessel" means every description of watercraft, other than a seaplane on the water, used or capable
28	of being used as a means of transportation on water.
29	"Waters of the Commonwealth" means any public waters within the territorial limits of the
30	Commonwealth, the adjacent marginal sea and the high seas when navigated as a part of a journey or
31	ride to or from the Virginia shore.
32	§ 29.1-749.1. Identification of personal watercraft rentals.
33 34	Every business that provides personal watercraft for rent shall place the letter "R," at least fourteen inches in height and ten inches in width on both sides of each personal watercraft rental in either red
54 35	inches in height and ten inches in width, on both sides of each personal watercraft rental, in either red or black, whichever color represents the clearest contrast from the basic color of the rental unit.
