13	Be it enacted by the General Assembly of Virginia:
14	1. That §§ 19.2-11.01 and 19.2-264.4 of the Code of Virginia are amended and reenacted, and that
15	the Code of Virginia is amended by adding a section numbered 19.2-295.3 as follows:
16	§ 19.2-11.01. Crime victim and witness rights.
17	A. In recognition of the Commonwealth's concern for the victims and witnesses of crime, it is the
18	purpose of this chapter to ensure that the full impact of crime is brought to the attention of the courts of
19	the Commonwealth; that crime victims and witnesses are treated with dignity, respect and sensitivity;
20	and that their privacy is protected to the extent permissible under law. It is the further purpose of this
21	chapter to ensure that victims and witnesses are informed of the rights provided to them under the laws
22	of the Commonwealth; that they receive authorized services as appropriate; and that they have the
$\frac{22}{23}$	opportunity to be heard by law-enforcement agencies, attorneys for the Commonwealth, corrections
23	
24	agencies and the judiciary at all critical stages of the criminal justice process to the extent permissible
25	under law. Unless otherwise stated and subject to the provisions of § 19.2-11.1, it shall be the
26	responsibility of a locality's crime victim and witness assistance program to provide the information and
27	assistance required by this chapter.
28	1. Victim and witness protection.
29	a. In order that victims and witnesses receive protection from harm and threats of harm arising out of
30	their cooperation with law-enforcement, or prosecution efforts, they shall be provided with information
31	as to the level of protection which may be available pursuant to § 52-35 or to any other federal, state or
32	local program providing protection, and shall be assisted in obtaining this protection from the
33	appropriate authorities.
34	b. Victims and witnesses shall be provided, where available, a separate waiting area during court
35	proceedings that affords them privacy and protection from intimidation.
36	2. Financial assistance.
37	a. Victims shall be informed of financial assistance and social services available to them as victims
38	of a crime, including information on their possible right to file a claim for compensation from the Crime
39	Victims' Compensation Fund pursuant to Chapter 21.1 (§ 19.2-368.1 et seq.) of Title 19.2 and on other
4 0	available assistance and services.
41	b. Victims shall be assisted in having any property held by law-enforcement agencies for evidentiary
42	purposes returned promptly in accordance with §§ 19.2-270.1 and 19.2-270.2.
43	c. Victims shall be advised that restitution is available for damages or loss resulting from an offense
4 4	and shall be assisted in seeking restitution in accordance with §§ 19.2-305, 19.2-305.1, Chapter 21.1

	(§ 19.2-368.1 et seq.) of Title 19.2, Article 21 (§ 58.1-520 et seq.) of Chapter 3 of Title 58.1, and other
46	applicable laws of the Commonwealth.
47	3. Notices.
48	a. Victims and witnesses shall be (i) provided with appropriate employer intercession services to
49	ensure that employers of victims and witnesses will cooperate with the criminal justice process in order
50	to minimize an employee's loss of pay and other benefits resulting from court appearances and (ii)
51	advised that pursuant to § 18.2-465.1 it is unlawful for an employer to penalize an employee for
52	appearing in court pursuant to a summons or subpoena.
53	b. Victims shall receive advance notification when practicable from the attorney for the
54	Commonwealth of judicial proceedings relating to their case and shall be notified when practicable of
55	any change in court dates in accordance with § 19.2-265.01 if they have provided their names, current
56	addresses and telephone numbers.
57	c. Victims shall be notified by the Department of Corrections or a sheriff or jail superintendent in
58	whose custody an escape, change of name, transfer, release or discharge of a prisoner occurs pursuant to
59	the provisions of §§ 53.1-133.02 and 53.1-160 if they have provided their names, current addresses and

60 telephone numbers in writing.

61 d. Victims shall be advised that, in order to protect their right to receive notices and offer input, all 62 agencies and persons having such duties must have current victim addresses and telephone numbers 63

given by the victims. 64

4. Victim input.

65 a. Victims shall be given the opportunity, pursuant to § 19.2-299.1, to prepare a written victim 66 impact statement prior to sentencing of a defendant and may provide information to any individual or agency charged with investigating the social history of a person or preparing a victim impact statement 67 68 under the provisions of §§ 16.1-273 and 53.1-155 or any other applicable law.

b. Victims shall have the right to remain in the courtroom during a criminal trial or proceeding 69 pursuant to the provisions of § 19.2-265.01 unless excluded by the court as a material witness. 70

71 c. [On motion of the attorney for the Commonwealth,] victims shall be given the opportunity, pursuant to §§ 19.2-264.4 and 19.2-295.3, to testify prior to sentencing of a defendant regarding the 72 73 impact of the offense. 74

5. Courtroom assistance.

75 a. Victims and witnesses shall be informed that their addresses and telephone numbers may not be 76 disclosed, pursuant to the provisions of §§ 19.2-11.2 and 19.2-269.2, except when necessary for the 77 conduct of the criminal proceeding.

78 b. Victims and witnesses shall be advised that they have the right to the services of an interpreter in 79 accordance with §§ 19.2-164 and 19.2-164.1.

80 c. Victims of certain sexual offenses shall be advised that there may be a closed preliminary hearing 81 in accordance with § 18.2-67.8 and, if a victim is twelve years of age or younger, two-way closed-circuit 82 television may be used in the taking of testimony in accordance with § 18.2-67.9.

B. For purposes of this chapter, "victim" means (i) a person who has suffered physical, psychological 83 84 or economic harm as a direct result of the commission of a felony or of assault and battery in violation 85 of §§ 18.2-57, 18.2-57.1 or § 18.2-57.2, stalking in violation of § 18.2-60.3, sexual battery in violation of § 18.2-67.4, attempted sexual battery in violation of § 18.2-67.5, maiming or driving while intoxicated 86 87 in violation of § 18.2-51.4 or § 18.2-266, (ii) a spouse or child of such a person, (iii) a parent or legal guardian of such a person who is a minor, or (iv) a spouse, parent or legal guardian of such a person 88 89 who is physically or mentally incapacitated or was the victim of a homicide; however, "victim" does not 90 mean a parent, child, spouse or legal guardian who commits a felony or other enumerated criminal 91 offense against a victim as defined in subdivision (i) of this subsection.

92 C. Officials and employees of the judiciary, including court services units, law-enforcement agencies, 93 the Department of Corrections, attorneys for the Commonwealth and public defenders, shall be provided 94 with copies of this chapter by the Department of Criminal Justice Services or a crime victim and witness 95 assistance program. Each agency, officer or employee who has a responsibility or responsibilities to 96 victims under this chapter or other applicable law shall make reasonable efforts to become informed 97 about these responsibilities and to ensure that victims and witnesses receive such information and 98 services to which they may be entitled under applicable law, provided that no liability or cause of action 99 shall arise from the failure to make such efforts or from the failure of such victims or witnesses to 100 receive any such information or services.

101 § 19.2-264.4. Sentence proceeding.

102 A. Upon a finding that the defendant is guilty of an offense which may be punishable by death, a 103 proceeding shall be held which shall be limited to a determination as to whether the defendant shall be 104 sentenced to death or life imprisonment. In case of trial by jury, where a sentence of death is not recommended, the defendant shall be sentenced to imprisonment for life. 105

A1. In any proceeding conducted pursuant to this section, the court shall permit the victim, as defined in § 19.2-11.01, upon [request the motion of the attorney for the Commonwealth, and with the 106 107 108 consent of the victim], to testify in the presence of the accused regarding the impact of the offense 109 upon the victim. The court shall limit the victim's testimony to the factors set forth in clauses (i) through 110 (vi) of subsection A of § 19.2-299.1.

B. In cases of trial by jury, evidence may be presented as to any matter which the court deems 111 112 relevant to sentence, except that reports under the provisions of § 19.2-299, or under any rule of court, 113 shall not be admitted into evidence.

114 Evidence which may be admissible, subject to the rules of evidence governing admissibility, may include the circumstances surrounding the offense, the history and background of the defendant, and any 115 116 other facts in mitigation of the offense. Facts in mitigation may include, but shall not be limited to, the following: (i) The defendant has no significant history of prior criminal activity, (ii) the capital felony 117 118 was committed while the defendant was under the influence of extreme mental or emotional disturbance, 119 (iii) the victim was a participant in the defendant's conduct or consented to the act, (iv) at the time of 120 the commission of the capital felony, the capacity of the defendant to appreciate the criminality of his conduct or to conform his conduct to the requirements of law was significantly impaired, (v) the age of 121

122 the defendant at the time of the commission of the capital offense or (vi) mental retardation of the 123 defendant.

124 C. The penalty of death shall not be imposed unless the Commonwealth shall prove beyond a 125 reasonable doubt that there is a probability based upon evidence of the prior history of the defendant or 126 of the circumstances surrounding the commission of the offense of which he is accused that he would 127 commit criminal acts of violence that would constitute a continuing serious threat to society, or that his 128 conduct in committing the offense was outrageously or wantonly vile, horrible or inhuman, in that it 129 involved torture, depravity of mind or aggravated battery to the victim.

130 D. The verdict of the jury shall be in writing, and in one of the following forms:

(1) "We, the jury, on the issue joined, having found the defendant guilty of (here set out statutory language of the offense charged) and that (after consideration of his prior history that there is a probability that he would commit criminal acts of violence that would constitute a continuing serious threat to society) or his conduct in committing the offense is outrageously or wantonly vile, horrible or inhuman in that it involved (torture) (depravity of mind) (aggravated battery to the victim), and having considered the evidence in mitigation of the offense, unanimously fix his punishment at death.

(2) "We, the jury, on the issue joined, having found the defendant guilty of (here set out statutory language of the offense charged) and having considered all of the evidence in aggravation and mitigation of such offense, fix his punishment at imprisonment for life.

E. In the event the jury cannot agree as to the penalty, the court shall dismiss the jury, and impose a sentence of imprisonment for life.

145 § 19.2-295.3. Admission of victim impact testimony.

In cases of trial by jury or by the court, upon a finding that the defendant is guilty of a felony, the court shall permit the victim, as defined in § 19.2-11.01, upon [request motion of the attorney for the Commonwealth], to testify in the presence of the accused regarding the impact of the offense upon the victim. The court shall limit the victim's testimony to the factors set forth in clauses (i) through (vi) of subsection A of § 19.2-299.1. In the case of trial by jury, the court shall permit the victim to testify at the sentencing hearing conducted pursuant to § 19.2-295.1 or in the case of trial by the court, the court shall permit the victim impact
