7 **Be it enacted by the General Assembly of Virginia:**

8 **1. That the second enactment of Chapter 833 of the Acts of Assembly of 1993, as amended by the**  
9 **second enactment of Chapter 642 of the Acts of Assembly of 1997, is amended and reenacted as**  
10 **follows:**

11 2. That the provisions of this act shall apply only to (i) the Middle Peninsula Juvenile Detention  
12 Commission which serves the Ninth and the Fifteenth Judicial Districts, (ii) the W. W. Moore, Jr.,  
13 Regional Juvenile Detention Commission which serves portions of the Tenth, Twenty-first, and  
14 Twenty-second Judicial Districts, (iii) the Rappahannock Juvenile Detention Commission which serves  
15 portions of the Fifteenth and Sixteenth Judicial Districts, ~~and~~ (iv) the James River Juvenile Detention  
16 Commission which serves parts of the Eleventh, Fourteenth, and Sixteenth Judicial Districts, (v) *the Blue*  
17 *Ridge Juvenile Detention Commission which serves parts of the Sixteenth Judicial District, (vi) the*  
18 *Highlands Juvenile Detention Commission which serves the Twenty-eighth Judicial District, and (vii) the*  
19 *Roanoke Valley Detention Commission which serves parts of the Twenty-second, Twenty-third and*  
20 *Twenty-fifth Judicial Districts.*

21 **2. That the second enactment of Chapter 833 of the Acts of Assembly of 1993, as amended by the**  
22 **second enactment of Chapter 752 of the Acts of Assembly of 1997, is amended and reenacted as**  
23 **follows:**

24 2. That the provisions of this act shall apply only to (i) the Middle Peninsula Juvenile Detention  
25 Commission which serves the Ninth and the Fifteenth Judicial Districts, (ii) the W. W. Moore, Jr.,  
26 Regional Juvenile Detention Commission which serves portions of the Tenth, Twenty-first, and  
27 Twenty-second Judicial Districts, ~~and~~ (iii) the James River Juvenile Detention Commission which serves  
28 parts of the Eleventh, Fourteenth, and Sixteenth Judicial Districts, (iv) *the Blue Ridge Juvenile Detention*  
29 *Commission which serves parts of the Sixteenth Judicial District, (v) the Highlands Juvenile Detention*  
30 *Commission which serves the Twenty-eighth Judicial District, and (vi) the Roanoke Valley Detention*  
31 *Commission which serves parts of the Twenty-second, Twenty-third and Twenty-fifth Judicial Districts.*
