10	Be it enacted by the General Assembly of Virginia:
11	1. That § 18.2-57 of the Code of Virginia is amended and reenacted as follows:
12	§ 18.2-57. Assault and battery.
13	A. Any person who shall commit commits a simple assault or assault and battery shall be guilty of a
14	Class 1 misdemeanor, and if the person intentionally selects the person against whom a simple assault is
15	committed because of his race, religious conviction, color or national origin, the penalty upon conviction
16 17	shall include a mandatory, minimum term of confinement of at least six months, thirty days of which
17	shall not be suspended, in whole or in part. B. However, if a person intentionally selects the person against whom an assault and battery resulting
19	in bodily injury is committed because of his race, religious conviction, color or national origin, the
20	person shall be guilty of a Class 6 felony, and the penalty upon conviction shall include a mandatory,
21	minimum term of confinement of at least six months, thirty days of which shall not be suspended, in
22	whole or in part.
23	C. In addition, if any person commits an assault or an assault and battery against another knowing or
24	having reason to know that such other person is a law-enforcement officer, as defined hereinafter, or firefighter, as defined in § 65.2-102, engaged in the performance of his public duties as a
25 26	law-enforcement officer or firefighter, such person shall be guilty of a Class 6 felony, and, upon
27 27	conviction, the sentence of such person shall include a mandatory, minimum term of confinement in jail
28	for six months.
29	Nothing in this subsection shall be construed to affect the right of any person charged with a
30	violation of this section from asserting and presenting evidence in support of any defenses to the charge
31	that may be available under common law.
32	D. In addition, if any person commits a battery against another knowing or having reason to know
33 34	that such other person a full-time or part-time employee of or volunteer for any public or private
34 35	elementary, secondary or high school and is engaged in the performance of his duties as such, he shall be guilty of a Class 1 misdemeanor and the sentence of such person upon conviction shall include a
36	mandatory, minimum sentence of fifteen days in jail, two days of which shall not be suspended in whole
37	or in part. However, if the offense is committed by use of a firearm, the person shall serve a mandatory,
38	minimum sentence of confinement of six months which shall not be suspended in whole or part.
39	E. As used in this section, A "law-enforcement officer" means any full-time or part-time employee of
	a police department or sheriff's office which is part of or administered by the Commonwealth or any
41 42	political subdivision thereof, who is responsible for the prevention or detection of crime and the
42 43	enforcement of the penal, traffic or highway laws of this Commonwealth, and any conservation officer of the Department of Conservation and Recreation commissioned pursuant to § 10.1-115, and such
4 4	officer also includes auxiliary police officers appointed or provided for pursuant to §§ 15.1-159.2 and
45	15.1-159.4 and auxiliary deputy sheriffs appointed pursuant to § 15.1-48.
46	D. As used in this section, the term "mandatory, minimum" means that the sentence it describes shall
47	be served with no suspension of sentence in whole or in part, and that no probation shall be given by
