

VIRGINIA ACTS OF ASSEMBLY — CHAPTER

An Act to amend and reenact §§ 36-97 and 36-99 of the Code of Virginia, relating to the Uniform Statewide Building Code; farm buildings and structures.

Be it enacted by the General Assembly of Virginia:**1. That §§ 36-97 and 36-99 of the Code of Virginia are amended and reenacted as follows:****§ 36-97. Definitions.**

As used in this chapter, unless the context or subject matter requires otherwise, the following words or terms shall have the meaning herein ascribed to them, respectively:

"Board" means the Board of Housing and Community Development.

"Review Board" means the State Building Code Technical Review Board.

"Building Code" means the Uniform Statewide Building Code and building regulations adopted and promulgated pursuant thereto.

"Code provisions" means the provisions of the Uniform Statewide Building Code as adopted and promulgated by the Board, and the amendments thereof as adopted and promulgated by such Board from time to time.

"Building regulations" means any law, rule, resolution, regulation, ordinance or code, general or special, or compilation thereof, heretofore or hereafter enacted or adopted by the Commonwealth or any county or municipality, including departments, boards, bureaus, commissions, or other agencies thereof, relating to construction, reconstruction, alteration, conversion, repair, maintenance, or use of structures and buildings and installation of equipment therein. The term does not include zoning ordinances or other land use controls that do not affect the manner of construction or materials to be used in the erection, alteration or repair of a building or structure.

"Municipality" means any city or town in this Commonwealth.

"Local governing body" means the governing body of any city, county or town in this Commonwealth.

"Local building department" means the agency or agencies of any local governing body charged with the administration, supervision, or enforcement of the Building Code and regulations, approval of plans, inspection of buildings, or issuance of permits, licenses, certificates or similar documents.

"State agency" means any state department, board, bureau, commission, or agency of this Commonwealth.

"Building" means a combination of any materials, whether portable or fixed, having a roof to form a structure for the use or occupancy by persons, or property; ~~however, farm buildings not used for residential purposes and frequented generally by the owner, members of his family, and farm employees shall be exempt from the provisions of the Uniform Statewide Building Code, but such buildings lying within a flood plain or in a mudslide-prone area shall be subject to flood proofing regulations or mudslide regulations, as applicable.~~ The word "building" shall be construed as though followed by the words "or part or parts thereof" unless the context clearly requires a different meaning.

"Equipment" means plumbing, heating, electrical, ventilating, air-conditioning and refrigeration equipment, elevators, dumbwaiters, escalators, and other mechanical additions or installations.

"Farm building or structure" means a building or structure not used for residential purposes, located on property where farming operations take place, and used primarily for any of the following uses or combination thereof:

1. Storage, handling, production, display, sampling or sale of agricultural, horticultural, floricultural or silvicultural products produced in the farm;

2. Sheltering, raising, handling, processing or sale of agricultural animals or agricultural animal products;

3. Business or office uses relating to the farm operations;

4. Use of farm machinery or equipment or maintenance or storage of vehicles, machinery or equipment on the farm;

5. Storage or use of supplies and materials used on the farm; or

6. Implementation of best management practices associated with farm operations.

"Construction" means the construction, reconstruction, alteration, repair or conversion of buildings and structures.

"Owner" means the owner or owners of the freehold of the premises or lesser estate therein, a

57 mortgagee or vendee in possession, assignee of rents, receiver, executor, trustee, or lessee in control of a
 58 building or structure.

59 "Director" means the Director of the Department of Housing and Community Development.

60 "Structure" means an assembly of materials forming a construction for occupancy or use including
 61 stadiums, gospel and circus tents, reviewing stands, platforms, stagings, observation towers, radio towers,
 62 water tanks, storage tanks (underground and aboveground), trestles, piers, wharves, swimming pools,
 63 amusement devices, storage bins, and other structures of this general nature but excluding water wells.
 64 Farm structures not used for residential purposes shall be exempt from the provisions of the Uniform
 65 Statewide Building Code, but such structures lying within a flood plain or in a mudslide-prone area shall
 66 be subject to flood proofing regulations or mudslide regulations, as applicable. The word "structure"
 67 shall be construed as though followed by the words "or part or parts thereof" unless the context clearly
 68 requires a different meaning.

69 "Department" means the Department of Housing and Community Development.

70 § 36-99. Provisions of Code.

71 A. The Building Code shall prescribe building regulations to be complied with in the construction of
 72 buildings and structures, and the equipment therein as defined in § 36-97, and shall prescribe regulations
 73 to insure that such regulations are properly maintained, and shall also prescribe procedures for the
 74 administration and enforcement of such regulations. The provisions thereof shall be such as to protect
 75 the health, safety and welfare of the residents of this Commonwealth, provided that buildings and
 76 structures should be permitted to be constructed at the least possible cost consistent with recognized
 77 standards of health, safety, energy conservation and water conservation and barrier-free provisions for
 78 the physically handicapped and aged. Such regulations shall be reasonable and appropriate to the
 79 objectives of this chapter.

80 B. In formulating the Code provisions, the Board shall have due regard for generally accepted
 81 standards as recommended by nationally recognized organizations, including, but not limited to, the
 82 standards of the Southern Building Code Congress, the Building Officials Conference of America and
 83 the National Fire Protection Association. *Notwithstanding the provisions of this section, farm buildings*
 84 *and structures shall be exempt from the provisions of the Building Code. However, farm buildings and*
 85 *structures lying within a flood plain or in a mudslide-prone area shall be subject to flood-proofing*
 86 *regulations or mudslide regulations, as applicable.*

87 C. Where practical, the Code provisions shall be stated in terms of required level of performance, so
 88 as to facilitate the prompt acceptance of new building materials and methods. When generally
 89 recognized standards of performance are not available, such provisions shall provide for acceptance of
 90 materials and methods whose performance has been found by the Board, on the basis of reliable test and
 91 evaluation data, presented by the proponent, to be substantially equal in safety to those specified.

92 **2. That the provisions of the first enactment of this act shall expire on July 1, 2000.**

93 **3. That the Board of Housing and Community Development (the Board) shall study the use of**
 94 **Virginia farm buildings and structures in the marketing and sale of agricultural goods and**
 95 **services. In conducting its study, the Board shall seek the input and expertise of agricultural**
 96 **enterprises and organizations, local building code officials, and other interested parties. The Board**
 97 **shall determine the feasibility and appropriateness of establishing certain requirements under the**
 98 **Uniform Statewide Building Code for farm buildings and structures used in such marketing and**
 99 **sales activities to protect the public health and safety. The Board shall report its findings and**
 100 **recommendations to the Governor and the 1999 Session of the General Assembly.**
