That § 46.2-395 of the Code of Virginia is amended and reenacted as follows: 11 § 46.2-395. Suspension of license for failure or refusal to pay fines or costs. 12 safety action program. B. In addition to any penalty provided by law, when any person is convicted of any violation of the amounts due. C. Before transmitting to the Commissioner a record of the person's failure or refusal to pay any fine, costs, forfeiture, restitution, or penalty or a failure to comply with an order issued pursuant to 32 § 19.2-354, the clerk of the court that convicted the person shall send or provide the person written notice of the suspension of his license or privilege to drive a motor vehicle in Virginia, effective ten 33 34 sixty days from the date of conviction, if the fine and costs are not paid prior to the effective date of the 35 suspension as stated on the notice. Notice shall be provided to the person at the time of trial or shall be 36 mailed by first-class mail to the address certified on the summons or bail recognizance document as the 37 person's current mailing address, or to such mailing address as the person has subsequently provided to 38 the court as a change of address. If so mailed on the date of conviction or within two days thereof, or if 39 delivered to the person at the time of trial, such notice shall be adequate notice of the license suspension 40 and of the person's ability to avoid suspension by paying the fines and costs prior to the effective date. 41 No other notice shall be required to make the suspension effective. A record of the person's failure or 42 refusal and of the license suspension shall be sent to the Commissioner if the fine, costs, forfeiture, restitution, or penalty remains unpaid on the effective date of the suspension specified in the notice or 43 on the failure to make a scheduled payment. 44 45 D. If the person pays the amounts assessed against him subsequent to the time the license has been

transmitted to the Department, and his license is not under suspension or revocation for any other lawful 46 47 reason, except pursuant to this section, then the Commissioner shall return the license to the person on **48** presentation of the official report of the court evidencing the payment of the fine, costs, forfeiture, 49 restitution, or penalty.

50 E. If the court has suspended or revoked the driver's license for any lawful reason other than this 51 section, or the conviction is one for which revocation or suspension is required under any provision of this title, except for this section, then the suspension permitted under this section shall be in addition to, 52 53 and run consecutively with, the revocation or suspension. The period of suspension shall be calculated 54 from the date of the assessment of the fine, costs, forfeiture, restitution, or penalty until the date it has 55 been paid.

INTRODUCED

A. Any person, whether licensed by Virginia or not, who drives a motor vehicle on the highways in 13 14 the Commonwealth shall thereby, as a condition of such driving, consent to pay all lawful fines, court costs, forfeitures, restitution, and penalties assessed against him for violations of the laws of the 15 Commonwealth; of any county, city, or town; or of the United States. For the purpose of this section, 16 17 such fines and costs shall be deemed to include any fee assessed by the court under the provisions of § 18.2-271.1 for entry by a person convicted of a violation of § 18.2-51.4 or § 18.2-266 into an alcohol 18 19

20 law of the Commonwealth or of the United States or of any valid local ordinance and fails or refuses to 21 provide for immediate payment in full of any fine, costs, forfeitures, restitution, or penalty lawfully 22 23 assessed against him, or fails to make deferred payments or installment payments as ordered by the 24 court, the court shall forthwith suspend the person's privilege to drive a motor vehicle on the highways 25 in the Commonwealth. The driver's license of the person shall continue suspended until the fine, costs, forfeiture, restitution, or penalty has been paid in full. If the person has not obtained a license as 26 required by this chapter, or is a nonresident, the court may direct in the judgment of conviction that the 27 person shall not drive any motor vehicle in Virginia for a period to coincide with the nonpayment of the
