That § 17.1-507 of the Code of Virginia is amended and reenacted as follows: 8 § 17.1-507. Number of judges; residence requirement; compensation; powers; etc. 9 A. No additional circuit court judge shall be authorized or provided for any judicial circuit until the 45

Judicial Council has made a study of the need for such additional circuit court judge and has reported its findings and recommendations to the Courts of Justice Committees of the House of Delegates and **46** Senate. In its study, the Judicial Council shall consider, and report its findings regarding, the reduced 47 case load that will occur if family court judgeships are authorized in accordance with the provisions of 48 Article 2 (§ 16.1-69.6:1 et seq.) of Chapter 4.1 of Title 16.1. Additionally, The boundary of any judicial 49 50 circuit shall not be changed until a study has been made by the Judicial Council and a report of its 51 findings and recommendations made to said Committees.

C. If the Judicial Council finds the need for an additional circuit court judge after a study is made 52 53 pursuant to subsection B, the study shall be made available to the Compensation Board and the Courts 54 of Justice Committees of the House of Delegates and Senate. The Compensation Board shall make a 55 study of the need to provide additional courtroom security and deputy court clerk staffing. This study 56 shall be reported to the Courts of Justice Committees of the House of Delegates and the Senate, and to
