| 10 | Be it enacted by the General Assembly of Virginia: |
| 11 | 1. That § 24.2-112 of the Code of Virginia is amended and reenacted as follows: |
| 12 | § 24.2-112. Assistants to general registrars; employees. |
| 13 | The electoral board shall determine the number and set the term for assistant registrars; however, |
| 14 | their terms shall not extend beyond the term set by law of the incumbent general registrar. The general |
| 15 | registrar shall establish the duties of assistant registrars, appoint assistant registrars, and have authority to |
| 16 | remove any assistant registrar who fails to discharge the duties of his office. |
| 17 | In any county or city whose population is 20,500 or greater, there shall be at least one full-time |
| 18 | assistant registrar who shall serve in the office of the general registrar. |
| 19 | In any county or city whose population is over 15,500 but less than 20,500, there shall be at least |
| 20 | one assistant registrar who shall serve at least one day each week in the office of the general registrar. |
| 21 | Any county or city whose population is 15,500 or less shall have at least one substitute registrar who |
| 22 | is able to take over the duties of the general registrar in an emergency and who shall assist the general |
| 23 | registrar when he requests. |
| 24 | All assistant registrars shall have the same limitations and qualifications and fulfill the same |
| 25 | requirements as the general registrar except that an assistant registrar may be an officer of election. |
| 26 | Assistant registrars who agree to serve without pay shall be supervised and trained by the general |
| 27 | registrar. |
| 28 | All other employees shall be employed by the general registrar. The general registrar may hire |
| 29 | additional temporary employees on a part-time basis as needed. |
| 30 | The compensation of any assistant registrar, other than those who agree to serve without pay, or any |
| 31 | other employee of the general registrar shall be fixed and paid by the local governing body and shall be |
| 32 | the equivalent of or exceed the minimum hourly wage established by federal law in 29 U.S.C. § 206 (a) |
| 33 | (1), as amended. |
| 34 | The general registrar shall not appoint to the office of paid assistant registrar his spouse or any |

The general registrar shall not appoint to the office of paid assistant registrar his spouse or any person, or the spouse of any person, who is his parent, grandparent, sibling, child, or grandchild.
