6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 15.2-5601 of the Code of Virginia is amended and reenacted as follows:**

## 8 § 15.2-5601. Definitions.

9 As used in this chapter, the following words and terms shall mean, unless the context indicates  
10 otherwise:

11 "Authority" means an authority created under the provisions of § 15.2-5602 or, if any such authority  
12 shall be abolished the entity succeeding to the principal functions thereof.

13 "Bonds" or "revenue bonds" means bonds, notes, certificates or other evidences of borrowing.

14 "Cost" means, as applied to any project, all or any part of the cost of acquisition, construction,  
15 alteration, enlargement, reconstruction and remodeling of a project or portion thereof, including the cost  
16 of the acquisition of all land, rights-of-way, property, rights, easements and interests acquired by the  
17 authority for such construction, additions or expansion, the cost of demolishing or removing any  
18 building or structure on land so acquired, including the cost of acquiring any lands to which such  
19 building or structures may be removed, the cost of all labor, materials, machinery and equipment,  
20 financing charges, insurance, interest on all bonds prior to and during such construction, and during the  
21 construction of any addition or expansion, and if deemed advisable by the authority, for a period not  
22 exceeding one year after completion of such construction, addition or expansion, reserves for principal  
23 and interest and for extensions, enlargements, additions, replacements, renovations and improvements,  
24 provisions for working capital, the cost of surveys, engineering and architectural expenses, borings, plans  
25 and specifications and other engineering and architectural services, legal expenses, studies, estimates of  
26 cost and revenues, administrative expenses and such other expenses as may be necessary or incident to  
27 the construction of the project, and of such subsequent additions thereto or expansion thereof, the cost of  
28 financing such construction, additions or expansion and placing the project and such additions or  
29 expansion in operation.

30 "Federal agency" means the United States of America and any department, bureau, agency or  
31 instrumentality thereof.

32 "Project" or "projects" means any one or more of the following: auditorium, theater, concert or  
33 entertainment hall, coliseum, convention center, arena, field house, stadium, fairground, campground,  
34 *land conservation project, including but not limited to the holding of conservation easements*, sports  
35 facilities, including racetracks, amusement park or center, garden, park, zoo and museum, as such terms  
36 are generally used, and parking, transportation, utility and restaurant facilities and concessions in  
37 connection with any of the foregoing, including any and all buildings, structures, approaches, roadways,  
38 and other facilities and appurtenances thereto which the authority may deem necessary or desirable,  
39 together with all property, rights, easements and interests which may be acquired by the authority for the  
40 construction, improvement and operation of any of the foregoing. The transportation facilities  
41 hereinabove mentioned may be principally for the use and benefit of the inhabitants of the locality  
42 creating the authority so long as they are incidentally related to the acquisition and construction of any  
43 of the foregoing and may be financed contemporaneously with, prior to or subsequent to the acquisition  
44 and construction of any of the foregoing.
