6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 54.1-106 of the Code of Virginia is amended and reenacted as follows:**8 § 54.1-106. Health care professionals rendering services to patients of certain clinics exempt from
9 liability.

10 A. No person who is licensed or certified by the Boards of/for Audiology and Speech-Language
11 Pathology; Dentistry; Medicine; Nursing; Optometry; Opticians; Pharmacy; Hearing Aid Specialists;
12 Psychology; Social Work; or Licensed Professional Counselors, Marriage and Family Therapists and
13 Substance Abuse Treatment Professionals who renders at any site any health care services within the
14 limits of his license or certification, voluntarily and without compensation, to any patient of any clinic
15 which is organized in whole or in part for the delivery of health care services without charge, shall be
16 liable for any civil damages for any act or omission resulting from the rendering of such services unless
17 the act or omission was the result of his gross negligence or willful misconduct.

18 For purposes of this section, any commissioned or contract medical officers or dentists serving on
19 active duty in the United States armed services and assigned to duty as practicing commissioned or
20 contract medical officers or dentists at any military hospital or medical facility owned and operated by
21 the United States government ~~and located in the Commonwealth~~ shall be deemed to be licensed pursuant
22 to this title.

23 B. For the purposes of Article 5.1 (§ 2.1-526.1 et seq.) of Chapter 32 of Title 2.1, any person
24 rendering such health care services who (i) is registered with the Division of Risk Management and (ii)
25 has no legal or financial interest in the clinic from which the patient is referred shall be deemed an
26 agent of the Commonwealth and to be acting in an authorized governmental capacity with respect to
27 delivery of such health care services. The premium for coverage of such person under the Risk
28 Management Plan shall be paid by the Department of Health.

29 C. For the purposes of this section and Article 5.1 (§ 2.1-526.1 et seq.) of Chapter 32 of Title 2.1,
30 "delivery of health care services without charge" shall be deemed to include the delivery of dental,
31 medical or other health services when a reasonable minimum fee is charged to cover administrative
32 costs.
