6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 16.1-228 of the Code of Virginia is amended and reenacted as follows:**

8 § 16.1-228. Definitions.

9 When used in this chapter, unless the context otherwise requires:

10 "Abused or neglected child" means any child:

11 1. Whose parents or other person responsible for his care creates or inflicts, threatens to create or
12 inflict, or allows to be created or inflicted upon such child a physical or mental injury by other than
13 accidental means, or creates a substantial risk of death, disfigurement or impairment of bodily or mental
14 functions;15 2. Whose parents or other person responsible for his care neglects or refuses to provide care
16 necessary for his health; however, no child who in good faith is under treatment solely by spiritual
17 means through prayer in accordance with the tenets and practices of a recognized church or religious
18 denomination shall for that reason alone be considered to be an abused or neglected child;

19 3. Whose parents or other person responsible for his care abandons such child;

20 4. Whose parents or other person responsible for his care commits or allows to be committed any
21 sexual act upon a child in violation of the law; or22 5. Who is without parental care or guardianship caused by the unreasonable absence or the mental or
23 physical incapacity of the child's parent, guardian, legal custodian or other person standing in loco
24 parentis.25 "Adoptive home" means the place of residence of any natural person in which a child resides as a
26 member of the household and in which he has been placed for the purposes of adoption or in which he
27 has been legally adopted by another member of the household.

28 "Adult" means a person eighteen years of age or older.

29 "Ancillary crime" or "ancillary charge" means any delinquent act committed by a juvenile as a part
30 of the same act or transaction as, or which constitutes a part of a common scheme or plan with, a
31 delinquent act which would be a felony if committed by an adult.32 "Boot camp" means a short term secure or nonsecure juvenile residential facility with highly
33 structured components including, but not limited to, military style drill and ceremony, physical labor,
34 education and rigid discipline, and no less than six months of intensive aftercare.

35 "Child," "juvenile" or "minor" means a person less than eighteen years of age.

36 "Child welfare agency" means a child-placing agency, child-caring institution or independent foster
37 home as defined in § 63.1-195.38 "Child in need of services" means a child whose behavior, conduct or condition presents or results in
39 a serious threat to the well-being and physical safety of the child; however, no child who in good faith
40 is under treatment solely by spiritual means through prayer in accordance with the tenets and practices
41 of a recognized church or religious denomination shall for that reason alone be considered to be a child
42 in need of services, nor shall any child who habitually remains away from or habitually deserts or
43 abandons his family as a result of what the court or the local child protective services unit determines to
44 be incidents of physical, emotional or sexual abuse in the home be considered a child in need of
45 services for that reason alone.46 However, to find that a child falls within these provisions, (i) the conduct complained of must
47 present a clear and substantial danger to the child's life or health or (ii) the child or his family is in need
48 of treatment, rehabilitation or services not presently being received, and (iii) the intervention of the court
49 is essential to provide the treatment, rehabilitation or services needed by the child or his family.

50 "Child in need of supervision" means:

51 1. A child who, while subject to compulsory school attendance, is habitually and without justification
52 absent from school, and (i) the child has been offered an adequate opportunity to receive the benefit of
53 any and all educational services and programs that are required to be provided by law and which meet
54 the child's particular educational needs, ~~and~~ (ii) the school system from which the child is absent or
55 other appropriate agency has made a reasonable effort to effect the child's regular attendance without
56 success, *and (iii) the school system has provided documentation that it has complied with the provisions*

57 of § 22.1-258; or

58 2. A child who, without reasonable cause and without the consent of his parent, lawful custodian or
59 placement authority, remains away from or ~~habitually~~ deserts or abandons his family or lawful custodian
60 *on more than one occasion* or escapes or remains away without proper authority from a residential care
61 facility in which he has been placed by the court, and (i) such conduct presents a clear and substantial
62 danger to the child's life or health, (ii) the child or his family is in need of treatment, rehabilitation or
63 services not presently being received, and (iii) the intervention of the court is essential to provide the
64 treatment, rehabilitation or services needed by the child or his family.

65 "The court" or the "juvenile court" or the "juvenile and domestic relations court" means the juvenile
66 and domestic relations district court of each county or city.

67 "Delinquent act" means (i) an act designated a crime under the law of this Commonwealth, or an
68 ordinance of any city, county, town or service district, or under federal law, (ii) a violation of
69 § 18.2-308.7, or (iii) a violation of a court order as provided for in § 16.1-292, but shall not include an
70 act other than a violation of § 18.2-308.7, which is otherwise lawful, but is designated a crime only if
71 committed by a child. For purposes of §§ 16.1-241 and 16.1-278.9, the term shall include a refusal to
72 take a blood or breath test in violation of § 18.2-268.2 or a similar ordinance of any county, city or
73 town.

74 "Delinquent child" means a child who has committed a delinquent act or an adult who has committed
75 a delinquent act prior to his eighteenth birthday, except where the jurisdiction of the juvenile court has
76 been terminated under the provisions of § 16.1-269.6.

77 "Department" means the Department of Juvenile Justice and "Director" means the administrative head
78 in charge thereof or such of his assistants and subordinates as are designated by him to discharge the
79 duties imposed upon him under this law.

80 "Family abuse" means any act of violence, including any forceful detention, which results in physical
81 injury or places one in reasonable apprehension of serious bodily injury and which is committed by a
82 person against such person's family or household member.

83 "Family or household member" means (i) the person's spouse, whether or not he or she resides in the
84 same home with the person, (ii) the person's former spouse, whether or not he or she resides in the same
85 home with the person, (iii) the person's parents, stepparents, children, stepchildren, brothers, sisters,
86 grandparents and grandchildren who reside in the same home with the person, (iv) the person's
87 mother-in-law, father-in-law, sons-in-law, daughters-in-law, brothers-in-law and sisters-in-law who reside
88 in the same home with the person, (v) any individual who has a child in common with the person,
89 whether or not the person and that individual have been married or have resided together at any time, or
90 (vi) any individual who cohabits or who, within the previous twelve months, cohabited with the person,
91 and any children of either of them then residing in the same home with the person.

92 "Foster care services" means the provision of a full range of casework, treatment and community
93 services for a planned period of time to a child who is abused or neglected as defined in § 63.1-248.2 or
94 in need of services as defined in this section and his family when the child (i) has been identified as
95 needing services to prevent or eliminate the need for foster care placement, (ii) has been placed through
96 an agreement between the local board of social services or a public agency designated by the
97 community policy and management team and the parents or guardians where legal custody remains with
98 the parents or guardians, (iii) has been committed or entrusted to a local board of social services or
99 child welfare agency, or (iv) has been placed under the supervisory responsibility of the local board
100 pursuant to § 16.1-293.

101 "Intake officer" means a juvenile probation officer appointed as such pursuant to the authority of this
102 chapter.

103 "Jail" or "other facility designed for the detention of adults" means a local or regional correctional
104 facility as defined in § 53.1-1, except those facilities utilized on a temporary basis as a court holding
105 cell for a child incident to a court hearing or as a temporary lock-up room or ward incident to the
106 transfer of a child to a juvenile facility.

107 "The judge" means the judge or the substitute judge of the juvenile and domestic relations district
108 court of each county or city.

109 "This law" or "the law" means the Juvenile and Domestic Relations District Court Law embraced in
110 this chapter.

111 "Legal custody" means (i) a legal status created by court order which vests in a custodian the right to
112 have physical custody of the child, to determine and redetermine where and with whom he shall live,
113 the right and duty to protect, train and discipline him and to provide him with food, shelter, education
114 and ordinary medical care, all subject to any residual parental rights and responsibilities or (ii) the legal
115 status created by court order of joint custody as defined in § 20-107.2.

116 "Permanent foster care placement" means the place of residence in which a child resides and in
117 which he has been placed pursuant to the provisions of §§ 63.1-56 and 63.1-206.1 with the expectation

118 and agreement between the placing agency and the place of permanent foster care that the child shall
119 remain in the placement until he reaches the age of majority unless modified by court order or unless
120 removed pursuant to § 16.1-251 or § 63.1-248.9. A permanent foster care placement may be a place of
121 residence of any natural person or persons deemed appropriate to meet a child's needs on a long-term
122 basis.

123 "Secure facility" or "detention home" means a local, regional or state public or private locked
124 residential facility which has construction fixtures designed to prevent escape and to restrict the
125 movement and activities of children held in lawful custody.

126 "Shelter care" means the temporary care of children in physically unrestricting facilities.

127 "State Board" means the State Board of Juvenile Justice.

128 "Status offender" means a child who commits an act prohibited by law which would not be criminal
129 if committed by an adult.

130 "Status offense" means an act prohibited by law which would not be an offense if committed by an
131 adult.

132 "Residual parental rights and responsibilities" means all rights and responsibilities remaining with the
133 parent after the transfer of legal custody or guardianship of the person, including but not limited to the
134 right of visitation, consent to adoption, the right to determine religious affiliation and the responsibility
135 for support.

136 "Violent juvenile felony" means any of the delinquent acts enumerated in subsection B or C of
137 § 16.1-269.1 when committed by a juvenile fourteen years of age or older.
