## HOUSE BILL NO. 2426

FLOOR AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by Delegate McDonnell)

A BILL to amend and reenact § 18.2-255.2 of the Code of Virginia, relating to drug-free school zones; penalty.

Be it enacted by the General Assembly of Virginia:

1. That § 18.2-255.2 of the Code of Virginia is amended and reenacted as follows:

§ 18.2-255.2. Prohibiting the sale of drugs on or near certain properties.

A. It shall be unlawful for any person to manufacture, sell or distribute or possess with intent to sell, 11 give or distribute any controlled substance, imitation controlled substance or marijuana at any time while 12 (i) upon the property, including buildings and grounds, of any public or private elementary, secondary, 13 14 or post secondary school, or any public or private two-year or four-year institution of higher education; 15 (ii) upon public property or any property open to public use within 1,000 feet of such school property; (iii) on any school bus as defined in § 46.2-100; (iv) upon a school bus stop, or upon either public 16 property or any property open to public use which is within 1,000 feet of such school bus stop, during 17 the time when school children are waiting to be picked up and transported to or are being dropped off 18 19 from school [ or a school-sponsored activity ]; (iv) (v) upon the property, including buildings and 20 grounds, of any publicly owned or publicly operated recreation or community center facility or any 21 public library; or (v) (vi) upon the property of any state hospital as defined in § 37.1-1 or upon public 22 property or property open to public use within 1,000 feet of such an institution. Nothing in this section 23 shall prohibit the authorized distribution of controlled substances.

B. Violation of this section shall constitute a separate and distinct felony. Any person violating the provisions of this section shall, upon conviction, be imprisoned for a term of not less than one year nor more than five years and fined not more than \$100,000. However, if such person proves that he sold such controlled substance or marijuana only as an accommodation to another individual and not with intent to profit thereby from any consideration received or expected nor to induce the recipient or intended recipient of the controlled substance or marijuana to use or become addicted to or dependent upon such controlled substance or marijuana, he shall be guilty of a Class 1 misdemeanor.

C. If a person commits an act violating the provisions of this section, and the same act also violates
another provision of law that provides for penalties greater than those provided for by this section, then
nothing in this section shall prohibit or bar any prosecution or proceeding under that other provision of
aw or the imposition of any penalties provided for thereby.

2. That the provisions of this act may result in a net increase in periods of imprisonment in state
correctional facilities. Pursuant to § 30-19.1:4, the estimated amount of the necessary appropriation
is \$0.
