## HOUSE BILL NO. 2685

Offered January 21, 1999

A BILL to amend and reenact § 18.2-371.2 of the Code of Virginia, relating to possession of tobacco products by minors; civil penalties.

**11** Be it enacted by the General Assembly of Virginia:

## 1. That § 18.2-371.2 of the Code of Virginia is amended and reenacted as follows:

13 § 18.2-371.2. Prohibiting purchase or possession of tobacco products by minors or sale of tobacco14 products to minors.

15 A. No person shall sell to, distribute to, purchase for or knowingly permit the purchase by any person less than eighteen years of age, knowing or having reason to believe that such person is less than 16 17 eighteen years of age, any tobacco product, including but not limited to cigarettes and cigars. Tobacco products may be sold from a vending machine only if the machine is (i) posted with a notice, in a 18 conspicuous manner and place, indicating that the purchase or possession of tobacco products by minors 19 20 is unlawful and (ii) located in a place which is not open to the general public and is not generally 21 accessible to minors. An establishment which prohibits the presence of minors unless accompanied by an 22 adult is not open to the general public.

B. No person less than eighteen years of age shall purchase or possess any tobacco product including
but not limited to cigarettes and cigars. The provisions of this subsection shall not be applicable to the
possession of tobacco products by a person less than eighteen years of age making a delivery of tobacco
products in pursuance of his employment.

C. No person shall sell a tobacco product to any individual who does not demonstrate, by producing 27 28 a driver's license or similar photo identification issued by a government agency, that the individual is at 29 least eighteen years of age. Such identification is not required from an individual whom the person has 30 reason to believe is at least eighteen years of age or who the person knows is at least eighteen years of age. Proof that the person demanded, was shown, and reasonably relied upon a photo identification 31 32 stating that the individual was at least eighteen years of age shall be a defense to any action brought under this subsection. In determining whether a person had reason to believe an individual is at least eighteen years of age, the trier of fact may consider, but is not limited to, proof of the general 33 34 35 appearance, facial characteristics, behavior and manner of the individual.

This subsection shall not apply to mail order sales.

37 D. A violation of subsection A or C by an individual or by a separate retail establishment shall be 38 punishable by a civil penalty not to exceed \$100 \$500 for a first violation and a civil penalty not to 39 exceed \$200 \$,1000 for a second violation. However, a third or subsequent violation of subsection A 40 shall be punishable by a civil penalty not to exceed \$500 \$2,500. A violation of subsection B shall be 41 punishable by (i) eighty hours of community service and a civil penalty not to exceed \$50 fifty dollars 42 for a first violation and (ii) 160 hours of community service and a civil penalty not to exceed \$100 for a second or subsequent violation. Upon a third or subsequent violation of subsection B, the judge in his 43 discretion may enter an order pursuant to subdivision 9 of § 16.1-278.8. In any case where a person in 44 violation of subsection B is under the age of sixteen, the court may enter an order delaying the person's 45 eligibility to apply for a driver's license until his seventeenth birthday. Any attorney for the 46 47 Commonwealth of the county or city in which an alleged violation occurred may bring an action to **48** recover the civil penalty, which shall be paid into the state treasury. Any law-enforcement officer may 49 issue a summons for a violation of subsection A, B, or C.

50 E. 1. Cigarettes shall be sold only in sealed packages provided by the manufacturer, with the 51 required health warning. The proprietor of every retail establishment which offers for sale any tobacco product, including but not limited to cigarettes and cigars, shall post in a conspicuous manner and place 52 53 a sign or signs indicating that the sale of tobacco products to any person under eighteen years of age is 54 prohibited by law. Any attorney for the county, city or town in which an alleged violation of this subsection occurred may enforce this subsection by civil action to recover a civil penalty not to exceed 55 fifty dollars. The civil penalty shall be paid into the local treasury. No filing fee or other fee or cost 56 57 shall be charged to the county, city or town which instituted the action.

58 2. For the purpose of compliance with regulations of the Substance Abuse and Mental Health59 Services Administration published at 61 Federal Register 1492, the Department of Agriculture and

60 Consumer Services may promulgate regulations which allow the Department to undertake the activities 61 necessary to comply with such regulations.

3. Any attorney for the county, city or town in which an alleged violation of this subsection occurred
may enforce this subsection by civil action to recover a civil penalty not to exceed \$100. The civil
penalty shall be paid into the local treasury. No filing fee or other fee or cost shall be charged to the
county, city or town which instituted the action.

66 F. Nothing in this section shall be construed to create a private cause of action.

67 G. Agents of the Virginia Alcoholic Beverage Control Board designated pursuant to § 4.1-105 may 68 issue a summons for any violation of this section.
