SENATE BILL NO. 750

A BILL to amend and reenact § 24.2-643 of the Code of Virginia, relating to voting procedures at the polls; voter identification.

Patron-Miller, K.G.

Referred to Committee on Privileges and Elections

Be it enacted by the General Assembly of Virginia:

1. That § 24.2-643 of the Code of Virginia is amended and reenacted as follows:

§ 24.2-643. Qualified voter permitted to vote; entry of voter's name on pollbook; other information.

14 A. After the polls are open, each qualified voter at a precinct shall be permitted to vote. The officers 15 of election shall ascertain that a person offering to vote is a qualified voter before admitting him to the voting booth and furnishing an official ballot to him. 16

B. An officer of election shall ask the voter for his full name and current residence address and 17 repeat, in a voice audible to party and candidate representatives present, the full name and address stated 18 by the voter. The officer shall ask any the voter, who is subject to the requirement to vote in person 19 20 pursuant to subsection B of § 24.2-416.1, to present any one of the following forms of identification: his 21 Commonwealth of Virginia voter registration card, his social security card, any preprinted form of identification which shows his name and address, any preprinted form of identification which shows his 22 name and signature, or any preprinted form of identification which shows his name and photograph. 23

24 If the voter's name is found on the registered voter list, if he presents one of the forms of 25 identification listed above, if he is qualified to vote in the election, and if no objection is made, an officer shall mark the voter's name on the registered voter list, an officer shall enter, opposite the 26 voter's preprinted name on the pollbook, the first or next consecutive number from the voter count form 27 28 provided by the State Board_z; an officer shall provide the voter with the official ballot_z; and another 29 officer shall admit him to the voting booth.

30 If a voter, who is subject to the requirement to vote in person pursuant to subsection B of 31 <u>§ 24.2-416.1</u>, is entitled to vote except that he is unable to present one of the forms of identification 32 listed above, he shall be allowed to vote after signing a statement, subject to felony penalties for false 33 statements pursuant to § 24.2-1016, that he is the named registered voter who he claims to be. 34

A voter may be accompanied into the voting booth by his child age fifteen or younger.

35 C. If the current residence address stated by the voter is different from the address shown on the 36 registered voter list, the officer of election shall furnish the voter with a change of address form 37 prescribed by the State Board. Upon its completion, the voter shall sign the prescribed form, subject to 38 felony penalties for making false statements pursuant to § 24.2-1016, which the officer of election shall 39 then place in an envelope provided for such forms for transmission to the general registrar who shall 40 then transfer or cancel the registration of such voter pursuant to Chapter 4 (§ 24.2-400 et seq.) of this 41 title.

42 D. At the time the voter is asked his full name and current residence address, the officer of election 43 shall ask any voter for whom an identification number other than a social security number is recorded on the registered voter list if he presently has a social security number and note that number on the list 44 if the voter is able to provide it. Any social security numbers so provided shall be entered by the 45 general registrar in the voter's record on the voter registration system. 46
