2 *An Act to amend the Code of Virginia by adding sections numbered 58.1-3650.804, 58.1-3650.805, and*
3 *58.1-3650.806, designating certain property to be exempt from taxation.*

6 **Be it enacted by the General Assembly of Virginia:**

7 **1. That the Code of Virginia is amended by adding sections numbered 58.1-3650.804,**
8 **58.1-3650.805, and 58.1-3650.806 as follows:**

9 *§ 58.1-3650.804. Property of American Type Culture Collection.*

10 *A. American Type Culture Collection, a nonprofit organization, is hereby designated as a religious,*
11 *charitable and benevolent organization within the context of Section 6 (a) (6) of Article X of the*
12 *Constitution of Virginia.*

13 *B. Property located in Prince William County, which is owned by American Type Culture Collection*
14 *and used by it exclusively for religious, charitable and benevolent purposes on a nonprofit basis as set*
15 *forth in subsection A of this section, is hereby determined to be exempt from local taxation.*

16 *§ 58.1-3650.805. Property of Lakeview Swim Club, Inc.*

17 *A. Lakeview Swim Club, Inc., a nonprofit corporation, is hereby designated as an organization*
18 *providing a public park and playground within the context of Section 6 (a) (6) of Article X of the*
19 *Constitution of Virginia.*

20 *B. Property located in Fairfax County at 5352 Gainsborough Drive and identified by Fairfax County*
21 *Tax Map Number 69-3, ((5)), Parcel M, which is owned by Lakeview Swim Club, Inc., and used by it*
22 *exclusively for public park and playground purposes on a nonprofit basis as set forth in subsection A of*
23 *this section, is hereby determined to be exempt from local taxation.*

24 *§ 58.1-3650.806. Property of Rainbow Center 4-H Therapeutic Equestrian Program, Inc.*

25 *A. Rainbow Center 4-H Therapeutic Equestrian Program, Inc., a nonprofit organization, is hereby*
26 *designated as a religious, charitable and benevolent organization within the context of Section 6 (a) (6)*
27 *of Article X of the Constitution of Virginia.*

28 *B. Property located in Prince William County, which is owned by Rainbow Center 4-H Therapeutic*
29 *Equestrian Program, Inc., and used by it exclusively for religious, charitable and benevolent purposes*
30 *on a nonprofit basis as set forth in subsection A of this section, is hereby determined to be exempt from*
31 *local taxation.*
