991147667 **SENATE JOINT RESOLUTION NO. 459** 1 2 AMENDMENT IN THE NATURE OF A SUBSTITUTE 3 (Proposed by the Joint Conference Committee 4 5 6 on February 26, 1999) (Patron Prior to Substitute—Senator Hawkins) Establishing a joint subcommittee to study the need for increased availability of higher education 7 services in South-central Virginia. 8 WHEREAS, since Colonial days, Virginians have demonstrated a "thirst for knowledge and a 9 reverence for learning," which resulted in the establishment of schools and universities in the 10 Commonwealth; and 11 WHEREAS, Thomas Jefferson is credited with developing Virginia's plan for a system of public education, which provided for elementary schools, general or secondary schools, and a university; and 12 WHEREAS, with the establishment of the College of William and Mary in 1624 by the crown of 13 England, and with the enactment of legislation appropriating funds for the University of Virginia in 14 February 1818, Virginia was well on its way to creating a high quality and effective system of higher 15 education composed of state-supported colleges and universities; and 16 17 WHEREAS, today, Virginia's system of higher education includes public and private two- and four-year, comprehensive and doctoral institutions which offer a range of fields and disciplines from the 18 19 associate degree to the post-doctoral level, and educational opportunities in the professional schools; and 20 WHEREAS, it has been the long-standing goal of the Commonwealth to ensure that opportunities for 21 higher education are accessible and available to all citizens in the most practicable, feasible, and 22 cost-efficient manner; and 23 WHEREAS, although the South-central region of the Commonwealth is served by the community 24 college system, there is no comprehensive or doctoral institution or branch campus that can be easily 25 accessed by citizens in the area; and WHEREAS, increased availability of higher education opportunities in South-central Virginia may 26 27 facilitate economic development, foster community growth, promote the appreciation of the cultural and historical significance of the region and enhance educational opportunities for all citizens through 28 29 partnerships with public schools, business, government, and other local, state, and federal entities; and 30 WHEREAS, the costs of providing improved access to higher education opportunities in South-central Virginia need not be prohibitive, as such educational services could be provided on a 31 32 regional basis; and 33 WHEREAS, the State of Florida has explored the regional university concept to provide greater 34 access to college degree programs in its unserved areas, and the design and approach of Florida and 35 other states in this regard should be considered; now, therefore, be it 36 RESOLVED by the Senate, the House of Delegates concurring, That a joint subcommittee be 37 established to study the need for increased availability of higher education services in South-central 38 Virginia. The joint subcommittee shall be composed of 11 members, which shall include seven 39 legislative members and four nonlegislative citizen members as follows: three members of the Senate, to 40 be appointed by the Senate Committee on Privileges and Elections; four members of the House of 41 Delegates, to be appointed by the Speaker of the House in accordance with the provisions of Rule 16 of the House Rules; and four citizens at large from South-central Virginia, two of whom shall be appointed 42 by the Senate Committee on Privileges and Elections and two of whom shall be appointed by the 43 44 Speaker of the House. In conducting its study, the joint subcommittee shall review the policies and procedures, if any, for 45 the establishment of colleges, branch campuses and regional higher education centers in the 46 47 Commonwealth, including accreditation. An analysis of the South-central region shall also be performed to determine the necessity of establishing either a comprehensive or doctoral institution of higher **48** 49 education in the area, opening a branch campus of an existing institution of higher education, or establishing a regional higher education center. Such analysis shall include, but not be limited to, (i) 50 regional demographic characteristics; (ii) the level of education in the region, and high school and 51 college graduation rates; (iii) the status of economic development of the South-central region; (iv) the 52 53 availability of appropriate facilities, space, and grounds for enhanced higher education services; (v) the 54 availability of qualified professors, instructors, administrators, and staff; (vi) the disciplines which will be offered for study; (vii) the types of degrees that will be conferred; (viii) characteristics of the 55 potential pool of students; (ix) the potential costs of and community and local government support for 56 providing increased availability of higher education services; (x) consultation with the State Council of 57 Higher Education, public and private colleges and universities currently serving South-central Virginia or 58 59 positioned to provide higher education services to South-central Virginia, and other relevant entities; and

60 (xi) such other issues as may be deemed necessary by the joint subcommittee.

61 The direct costs of this study shall not exceed \$10,200. An estimated \$1,500 is allocated for
 62 materials and resources. Such expenses shall be funded from the operational budget of the Clerk of the
 63 Senate.

64 The Division of Legislative Services shall provide staff support for the study. Technical assistance

65 shall be provided by the State Council of Higher Education and the staff of the Senate Finance

66 Committee. All agencies of the Commonwealth shall provide assistance to the joint subcommittee, upon 67 request.

68 The joint subcommittee shall complete its work in time to submit its findings and recommendations
69 to the Governor and the 2000 Session of the General Assembly as provided in the procedures of the
70 Division of Legislative Automated Systems for the processing of legislative documents.

71 Implementation of this resolution is subject to subsequent approval and certification by the Joint 72 Rules Committee. The Committee may withhold expenditures or delay the period for the conduct of the

73 study.
